

King Gottwald Peter reaffirming his interest in peaceful co-ordination with the European states and securing our capacity for peaceful co-operation in order to prevent conflicts and eliminate the threat of wars involving the destruction of civilizations and threats to life for nations

On the basis of the current situation, only negative intentions against the standard forms of legitimate dispute resolution and the conduct of diplomatic principles creating trust, fitness for friendship for peaceful purposes and the ability to create a nonconflict situation, I King Gottwald Peter therefore reaffirms my interests;

It is not my goal to end the conflict situation and cause your civilization to cease. Today, as a result of violent violations of international rights by European policies against my person, I was forced to create a logistics strategy that is capable of promptly responding to the world's representation of peace and security for the act of complete destruction of the civilization existence of the states of your organized group.

It is not my goal to extend provocation with the interest of strengthening the conflict and achieving acts of common intolerance preventing the creation of an act of peaceful co-operation to prevent the rise of war and criminal intentions. To this day, I am forced to resist the acts of apartheid and the forced interests of my own ideology for retaliation of intolerance and crimes, and I also respond in a direct way to the creation of steps leading to the destruction of groups of criminal associations and to ensuring the normalization of the state.

It is not my goal to block the possibility of a friendly agreement that allows us to build on our legal cooperation that will therefore be developed responsibly to ensure the function of a common agreement that is to prevent civilian bankruptcy and civil society bankruptcy. I always offer the possibility of a common peace solution without resistance to friendship; I always offer the possibility for our joint solution to the saturation according to the stabilization process which guarantees the protection of the function of security, the state function of democracy and diplomacy without discrimination of the internal parties and the judicial function in legal justice, civilization.

It is not my ability to achieve a rational solution without conflict and with the possibility of avoiding conflict if your governments are still based on expanding the activity of their own criminal network and blocking their own functions of legal practice in the country to block criminal targets and to suppress threats only to the rise of crime on national and international In order to permanently harm international rights and legitimate principles of the existence of a state with the rights to self-determination of the establishment of sovereignty.


It is not my ability to support the growth of the legitimacy of your countries in the obligation of your country's purpose to eliminate the criminal networks of the government, as well as the unwillingness of your cooperation and the determination of a legitimate step taken to prevent your government from being discriminated against, and for your interests to support this effect are blocked by media and rights Social communication and the establishment of political friendship.

Because of the threats that arise over the principles of the existence of the criminal movement as a terrorist state, I am therefore entitled to request our cooperation to prevent the growth of the crime to the level of your disappearance, which is why I call for an agreement on joint meetings intended for debates leading to a peaceful determination of the diplomacy, Legal resolution of disputes according to the principles of justice, thus allowing the establishment of cooperation to prevent the full bankruptcy of your government, state and civilization.

If you can not apply such diplomacy principles defining the rights of the existence of your state, we are jointly forced to establish joint meetings of the political parties of your states, the parliamentary assembly and the parliament, together with the Ministry and the representatives of security forces, thereby jointly determining the concentration for the separation of persons of terrorist relationship and activity Crime from persons not related to criminal activity, and that is the only purpose of creating a legitimate state without the basic principle of violating peace and security rights, determining your legitimacy and policy capability.

Thus, it will be decided to initiate cooperation to determine the peaceful solution and process of your state's defense, in the act of establishing a new government of your states as a response to discrimination against all persons exercising policies and governing your country, in exercising their rights and neutralizing the terrorist movement Which is just a threat to your country's existence.

If this process is not implemented and no changes are invoked, then the interest of the peace settlement is terminated and there is no need to create another solution because of your own act of confirming the full illegality of the government of the country and the state. We can not discuss diplomatic progress between a group that is legitimately not related to the right of representation of states and territories.

If your policy is not capable of legitimately agreeing in the interests of legal, peaceful, and fair disciplines, then your ultimate legitimacy of states is based on the latest form of existence according to the following intelligence information;

Therefore, in the interests of states that have been confirmed as active in international terrorism:

Czech Republic, Slovak, French, Portuguese, Italian, Hungarian, Romanian, Bulgarian, Turkish, Austrian, Swiss Confederation, German Federation, Kingdom of Belgium, Netherlands, Spain, Grand Duchy of Luxembourg.

So, at the same time, with states that refuse to admit it, it is so applied and confirmed.

The choice means;

A person moving within the Territorial States' Territories has the right to choose ID's government as a self-determination for such citizenship.

Can not vote in opposition. Whoever refuses to vote, he therefore remains marked as a terrorist entity in the civil registry to the terrorist state. In another case, renouncing the citizenship of a terrorist state, as an act which means proclaiming his own identity as "stateleness".

Any terrorist person or a person without legitimate identity verification can not live on the territory of the ID's government. Terrorists must be shot and mass killing, people without identity will be deported to foreign countries with legitimacy of citizenship or concentrated in refugee camps.

The election will take place on: 01.06.2017-10.06.2017

The choice will be made by issuing a document at the local residence's home, and by the notary's own verification, sharing in public media, the Medial Agency.

The outcome of the elections has been applied since the date: 1998, some states up to 2003, and 2007, according to the document "EU states and their application of illegality".
