Ray: . . .Quite a few updates went out over the weekend.

WEEKEND UPDATES:

Saturday, Oct. 13th

On the Iraqi TV news, Prime Minister-Designate Madhi was stating that his cabinet will be selected and in place within the next 10 days. Parliament held its meeting today and announced the names of all of the new committees. #wearethepeople

Sunday, Oct. 14th

The leader of the Islamic Supreme Council of Iraq, Sheikh Jalal al-Din al-Saghir, stated that Prime Minister-Designate Adel Abdul-Madhi will present his cabinet on the second day after the visit of the martyrdom of Imam Hussein. [Now, let's determine when that takes place] #wearethepeople

Banks were excited about the weekend. I think about you and wonder if I give you all the information. . . I give you the good stuff. . . I'm frustrated, why shouldn't you be frustrated too. . . I'm going to give it to you guys. Hold on. I'm trying to get an update here. (right now on the call).

Ray: While your doing that - I've been telling folks for the longest time, I'm not a Guru. They received information "Guru's have 800 number but not the authority to release.'

Tony: We have heard that before and we still haven't gotten them. They must be going to someone else.

So anyway, banks were scheduled to go this weekend. Expected about the weekend and today. One bank said they had big meetings . . . and it would be later. Said there was an issue, so don't expect it.

The other bank said they did not get that news and they still are planning and expect it this week. It's one of the big five (banks.)

One is saying one thing. Now saying it's not happening, there is an issue and you should know what it is. The other says it's happening and later in the week. What we get from our committee was, it was stopped . . . because the US stopped it for whatever reason. I'm supposed to know the reason. I'm telling you guys, "I Do Not!"

I know everybody outside the country agree the US stopped it . . . Once again! That is where we are this morning. Two out of three (banks) are still looking for it this week.

Saturday morning money was supposed to be delivered to the banks so this could happen. They were waiting for the money so this could go and they didn't get their delivery. I don't know if they will get the delivery today or not. So we knew it wasn't happening when the delivery didn't come.

No group got their paper work done; no black cards. None took place anywhere I could verify it. Paymasters got nothing. No money this weekend.

It's all good. The thousands came out. We know what was accomplished. What's happening over there now made it worse. Other than that I know Iraq is ready to go and tried to go this weekend.

CURRENT WINDOW: Tony: . . .the US stopped it . . . once again! . . .Two out of three (banks) are still looking for it this week.

Tony: Different ways of saying by the 24th. It hasn't gone from bad to worse. Just different ways of saying by the 24th. Does Mahdi need to take oath and be in office before the CBI finalizes everything? Or does CBI say let's go right now while there is no argument? It's time to delete the three zero's - nobody arguing about that. CBI is ready to go. Our information tells us they were ready to go on Friday. Money was not delivered to the banks. If I say it stops here or where it is at, it comes from more than one source and inside and out of country. Want you to understand why I say that. It's because of the sources where it came from.**

UNITED STATES: Tony: . . .the US stopped it . . . once again! . . . there is an issue. The US wants to cut off all monies going to Iran from Iraq. That is what is going on. . .

- **Banks:** Delivery to banks of money to start the currency exchange was supposed to have happened on Saturday and did not. Tony **said two of three banks are still expecting to be able to start exchanges this week.**

CHINESE INTELLIGENCE OFFICER CHARGED WITH ECONOMIC ESPIONAGE INVOLVING THEFT OF TRADE SECRETS FROM LEADING U.S. AVIATION COMPANIES

WASHINGTON – A Chinese Ministry of State Security (MSS) operative, Yanjun Xu, aka Qu Hui, aka Zhang Hui, has been arrested and charged with conspiring and attempting to commit economic espionage and steal trade secrets from multiple U.S. aviation and aerospace companies. Xu was extradited to the United States yesterday.

The charges were announced today by Assistant Attorney General for National Security John C. Demers, U.S. Attorney for the Southern District of Ohio Benjamin C. Glassman, Assistant Director Bill Priestap of the FBI’s Counterintelligence Division, and Special Agent in Charge Angela L. Byers of the FBI’s Cincinnati Division.

“This indictment alleges that a Chinese intelligence officer sought to steal trade secrets and other sensitive information from an American company that leads the way in aerospace,” said Assistant Attorney General Demers. “This case is not an isolated incident. It is part of an overall economic policy of developing China at American expense. We cannot tolerate a nation’s stealing our firepower and the fruits of our brainpower. We will not tolerate a nation that reaps what it does not sow.”

“Innovation in aviation has been a hallmark of life and industry in the United States since the Wright brothers first designed gliders in Dayton more than a century ago,” said U.S. Attorney Glassman. “U.S. aerospace companies invest decades of time and billions of dollars in research. This is the American way. In contrast, according to the indictment, a Chinese intelligence officer tried to acquire that same, hard-earned innovation through theft. This case shows that federal law enforcement authorities can not only detect and disrupt such espionage, but can also catch its perpetrators. The defendant will now face trial in federal court in Cincinnati.”

“This unprecedented extradition of a Chinese intelligence officer exposes the Chinese government’s direct oversight of economic espionage against the United States,” said Assistant Director Priestap.

Yanjun Xu is a Deputy Division Director with the MSS’s Jiangsu State Security Department, Sixth Bureau. The MSS is the intelligence and security agency for China and is responsible for counter-intelligence, foreign intelligence and political security. MSS has broad powers in China to conduct espionage both domestically and abroad.

Xu was arrested in Belgium on April 1, pursuant to a federal complaint, and then indicted by a federal grand jury in the Southern District of Ohio. The government unsealed the charges today, following his extradition to the United States. The four-count indictment charges Xu with conspiring and attempting to commit economic espionage and theft of trade secrets.

According to the indictment:

Beginning in at least December 2013 and continuing until his arrest, Xu targeted certain companies inside and outside the United States that are recognized as leaders in the aviation field. This included GE Aviation. He identified experts who worked for these companies and recruited them to travel to China, often initially under the guise of asking them to deliver a university presentation. Xu and others paid the experts' travel costs and provided stipends.

An indictment is merely a formal charge that a defendant has committed a violation of criminal law and is not evidence of guilt. Every defendant is presumed innocent until, and unless, proven guilty.

The maximum statutory penalty for conspiracy and attempt to commit economic espionage is 15 years of incarceration. The maximum for conspiracy and attempt to commit theft of trade secrets is 10 years. The charges also carry potential financial penalties. The maximum statutory sentence is prescribed by Congress and is provided here for informational purposes. If convicted of any offense, a defendant's sentence will be determined by the court based on the advisory Sentencing Guidelines and other statutory factors.

This investigation was conducted by the FBI's Cincinnati Division, and substantial support was provided by the FBI Legal Attaché's Office in Brussels. The Justice Department's Office of International Affairs provided significant assistance in obtaining and coordinating the extradition of Xu, and Belgian authorities provided significant assistance in securing the arrest and facilitating the surrender of Xu from Belgium.

Assistant Attorney General Demers and U.S. Attorney Glassman commended the investigation of this case by the FBI and the assistance of the Belgian authorities in the arrest and extradition of Xu. Mr. Demers and Mr. Glassman also commended the cooperation of GE Aviation throughout this investigation. The cooperation and GE Aviation's internal controls protected GE Aviation's proprietary information.

The case is being prosecuted by Assistant U.S. Attorneys Timothy S. Mangan and Emily N. Glatfelter of the Southern District of Ohio, and Trial Attorneys Thea D. R. Kendler and Amy E. Larson of the National Security Division's Counterintelligence and Export Control Section.

How Mueller & President Trump are Pulling the Biggest Sting in History

On the crisp fall night of October 9, 2016, there was an electric energy in the air at Washington University in St. Louis for the second presidential debate. Hillary Clinton ended the first debate with a below the belt attack on Donald Trump accusing him of bullying a former Miss Universe beauty queen. There was a sense in the air that Trump – famous for his counter punches – would swing back with a TKO, and boy, did he deliver.

That night on stage Trump made a shocking promise to Clinton in the event he got elected. "If I win, I'm going to instruct my attorney general to get a special prosecutor to look into your situation...we're going to have a special prosecutor," Trump said. Clinton responded, "It's just awfully good that someone with the temperament of Donald Trump is not in charge of the law in our country." Trump then interrupted and said: "Because you'd be in jail." Trump's statement was met with cheers and thunderous applause.

Trump's famous "because you'd be in jail" line is constantly rotated throughout the Internet via memes and videos on social media to this day; however, what many seem to have forgotten is the first part of Trump's statement: he promised to assign a special prosecutor to look into Clinton's crimes.

Fast forward to May 16, President Trump is now in the White House and meets with Robert Mueller. CNN [reported](#) that Trump interviewed him as a potential replacement for fired FBI Director James Comey. As Trump would say, "wrong!" **It's not possible that Mueller could've been interviewing for the FBI director position because he already served in that capacity** – under Presidents George W. Bush and briefly Barack Obama – and he exceeded the term limit allowed to work in that role. The term limit is ten years and Mueller served as FBI director for 12 years. Mueller got a special additional two-year extension from Obama that the Senate approved. The fake news totally got this wrong — to no one's surprise.

So what was the meeting really about? I believe Trump was finalizing his decision to appoint Mueller as his special prosecutor to investigate Clinton. Don't believe it? Keep reading.

The day after Mueller's meeting with Trump, Deputy Attorney General Rod Rosenstein appointed Mueller to serve as special counsel for the United States Department of Justice. In the appointment record signed by Rosenstein it reads:

The Special Counsel is authorized to conduct an investigation including “any links and/or coordination between Russian government and individuals associated with the campaign of President Donald Trump, and any matters that arose or may arise directly from the investigation.”
