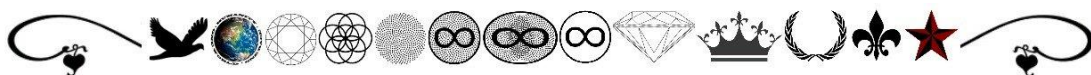

Offense is repeated at the extensive nature:

Terrorist Monitoring of legal activity of the foreign entity Imperium of Diamond's, terrorist activity and spy without legal obligation or right's, violation of rights of extraterritoriality and permanently violated international law character, harming the ability to work and carry out the activities of documentation or other activities, provocations and manipulations with computers simultaneously in supporting the activities of terrorist regime.

Judgment;

The death penalty for anyone who in any way cooperate and encourage community interest continuity International Organized Crime and Global Terrorism as a European terrorist regime and alliance communities with activity against the ID's of the federal government, the World Diamond International Alliance, and against International Law.

Schools, university Pompeu Fabra, Barcelona must be inspected every person who was in the Student registry over the last 10 years, and every teacher, employee. Anyone who in any way supported and respected activity or crime, they must go to the execution, the death penalty after 5-10 year's investigation into isolation prison's.

Each of these persons must obligation to immediately pay 10.000.000.000.000.000 Euro fine for such activity, as a preliminary amount of money. If finances are not paid, the criminal must ensure that pays off through work in prisons.

Persons can not be respected in any case, interest or inquiry. Person owns the rights to testify before a court. In case of any hint of disgust, everyone can be killed instantly and without trial.

The death penalty will be applied subsequently against anyone who in any way supported and respected activity or terrorism within the entire territory of Spain.

The death penalty for each of them, their contact persons. A person in the interest of crime activities in the form of world terrorism and therefore lose the right for a right to any kind of communication or activities and freedom of movement and life. Anyone who has enabled or used its contacts with such a person, therefore he must be punished the same way. Death penalty and for every one.

Judgment must be applied against anyone who in any way in such a relationship, without any exceptions, Court judgment must encourage and ensure that each country's government in the interests of the membership of the United Nation organization, and equally to every country in the interests of the World Diamond membership, and equally to every country's government that ensure recognition of the right title and interest to enforce claims.

Prior to the death penalty will be applied to the interrogation for a period of five or ten years, under the supervision of isolation prisons. Then it can be undertaken for the execution of global terrorism, and organized crime.

The judgment will be applied names and duties of the World Diamond International Alliance, and through the Imperium of Diamond's federal government.

In case of any resistance, provocation is not forbidden to carry out defense and response through the hard and violent methods for disposal and disorient a terrorist movement.
