## Street Reconstruction Projects To Be Outlined At June 4 Council Meeting

Charlestown Neighborhood Council Chairman Dennis McLaughlin has announced that representatives from the Boston Redevelopment Authority and TAMS Consultants Inc. will come before the council on Tuesday, June 4 to make a presentation on four street reconstruction projects to begin in Charlestown this summer. The contracts include reconstruction of sidewalks and roadways, replacement of street lights and trees, and improvements to sewer and water lines on 26 streets. McLaughlin states that Paul Reavis, BRA assistant director for Engineering and Design Services, and James

Parsons, TAMS Transportation Planning consultant, will outline the work to be done in the areas of Adams Street and the Training Field, Mt. Vernon Street, Rutherford Avenue and Mishawum Park. McLaughlin stated: "The purpose of the presentation is to outline the mitigation plans between the contractor and the neighborhood in connection with the reconstruction projects. The council seeks to mitigate issues of concern to area residents that would lessen the impacts of traffic, parking and access to their streets for the duration of the work schedule." The 26 streets included in the contracts are:

- Adams Street between Winthrop Street and Lowney Way;
  - Chestnut Street between Mt. Vernon Avenue and Lowney Way;
  - Common Street between Winthrop and Adams streets;
  - Concord Street between Monument Square and Bunker Hill Street;
  - Devens Street between Main Street and Old Rutherford Avenue;
  - Essex Street between Rutherford Avenue and Lyndeboro Street;
  - Ellwood Street from Putnam Street to end;
  - Ferrin Street from Lowney Way to end;
  - Lawrence Street between

## Neighborhood Council Gives Approval To MWRA Mitigation Proposal

With the threat of a lawsuit by the Massachusetts Water Resources Authority to prod the city into action, Boston Transportation Department Commissioner Rick Dimino asked for an emergency meeting of the Charlestown Neighborhood Council on May 28. Dimino sought to get the approval of the CNC for the city to sign the latest version of a Memorandum of Understand-

ing (MOU) between the MWRA and the city. The LTD would be signing the document on behalf of Charlestown. Mitigation measures have been on the drawing board since 1988 when the MWRA first proposed the use of the former Revere Sugar facility on Medford Street as a construction equipment transfer site for the building of the water treatment plant on Deer Island, part of the Boston Harbor clean up. This use was later eliminated from the plan and the focus of the local site became the transfer of personnel to Deer Island. Area residents had consistently opposed this use of the site and the CNC had voted its opposition last year. Dimino explained that Federal Judge David Mazzone indicated to the city that he had every intention of becoming in-

involved in settling the matter of the site in order to move the harbor clean up forward. Dimino stated that he was not going to let the court or a judge get involved with a MOU knowing the work the community had done in putting such a document together. Dimino said that agreements had to be reached and he was seeking the endorsement of the CNC to sign the document. In addition, Dorothy Steele, Massport's Charlestown liaison, told the council that the lease agreement with Massport and MWRA was presently for construction equipment transfer. She noted that Massport had stuck to its promise not to sign a revised lease for personnel transfer until the MOU was approved by the community and signed by the city. Highlights of the 16-page

 McLaughlin noted that residents who live on these 26 streets should come to the June 4 meeting at 7 p.m. and hear the presentation. He also invited residents of areas not included in these contracts to attend the meeting and request that their streets be included in an upcoming reconstruction project.  
 The total cost of the reconstruction projects is \$4.6 million. Advertisements for the contracts are being published this week in trade journals and Boston's daily newspapers. Bids received will be opened on June 14 and a contractor is expected to be selected in July to begin the first phase

of the reconstruction work by mid-summer.

McLaughlin stated that the mitigation plan sought by the council should include an alternate parking plan for residents during the length of the project and the appointment of an on-site liaison to work with the contractor and the neighborhoods during the construction period to help coordinate the work schedule and alleviate inconvenience to the residents as much as possible. The liaison would notify residents of all utility shutoffs, disruption of traffic flow, etc., through flyers delivered to their doorsteps and by notice in **The Charlestown Patriot**.

## Weld Names BHCC President As Education Advisor

Gov. William Weld and Lt. Gov. Paul Cellucci have named Bunker Hill Community College President Piedad Robertson as their education advisor.

Robertson, who continues on as president of BHCC, assumes her volunteer, advisory position immediately. She said the non-

paying job of education advisor is a short-term position that may last through the summer, and is most critical now as the adminis-

tration and the legislature deliberate education reform issues.

"I bring the educator's view of what constitutes effective public education policy to the Weld-Cellucci administration," she said. "That viewpoint is critical to ensuring that education reform in Massachusetts will provide us with a high-quality public education system."

Robertson was named as the administration's education advisor replacing James Harrington who filled the position the last five months while preparing a report on the future of public education in Massachusetts.

"To President Robertson, education policy is not just an intellectual exercise," said Weld in a State House press release. "She has been on the front lines of our public education system and will guide our efforts to restructure and revitalize that system in Massachusetts." The legislature is now considering an education reform bill filed by Weld.

The firm was established by Breen in 1988 after a 28-year association with another firm, and has been operating in Charlestown since then.

## City Square Park Design Topic Of Community Meeting

In preparation for a January 1992 site inspection of five land parcels in City Square that will be suitable for development at the end of the Central Artery/North Area (CANA) roadway reconstruction project, the City Square Park Committee brought CBT architects and consultants to a meeting on May 22 to begin to set the direction for a one-acre park on Parcel 5, located directly across from the Charlestown Courthouse. CBT consultant Tony Casendino stated: "The park will link the community to the waterfront and be the gateway to Charlestown."

Park Committee chairpersons Ken Stone and Annette Tecce set the tone of the meeting by requesting community input for the park's design. A questionnaire soliciting ideas from residents was published in the Patriot and was distributed at the meeting. CBT presented a slide show featuring park concepts and design ideas lending alternative options for the development of the land.

Committee members stated that any design for the park should take into account the future development of Parcels 1, 2, 3 and 4 in City Square and also incorporate the historic background of the community and, in particular, of City Square.

All suggestions and ideas for the park were submitted to CBT who will come back to the community with variations of park schemes, similar to the process taken in the construction of parks in Hayes and Thompson squares.

The committee will meet again on Monday, June 10 at 7:30 p.m. at the Bunker Hill Museum, 43 Monument Square (enter on Monument Avenue side). For more information, call Stephen Collins at 951-6002.

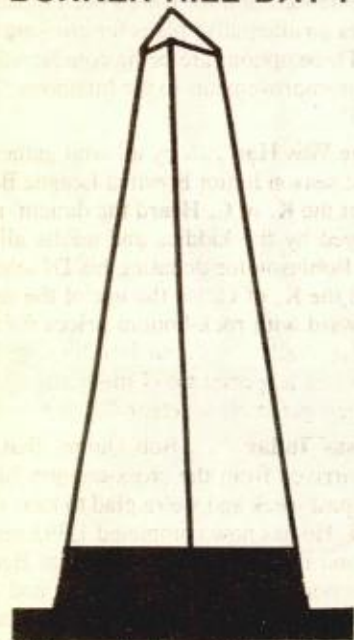

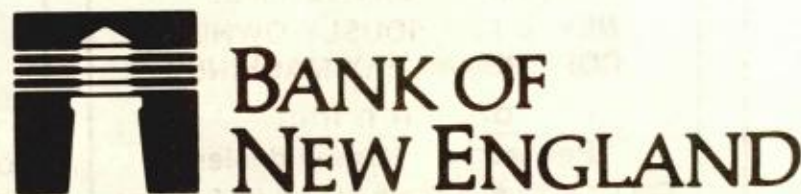

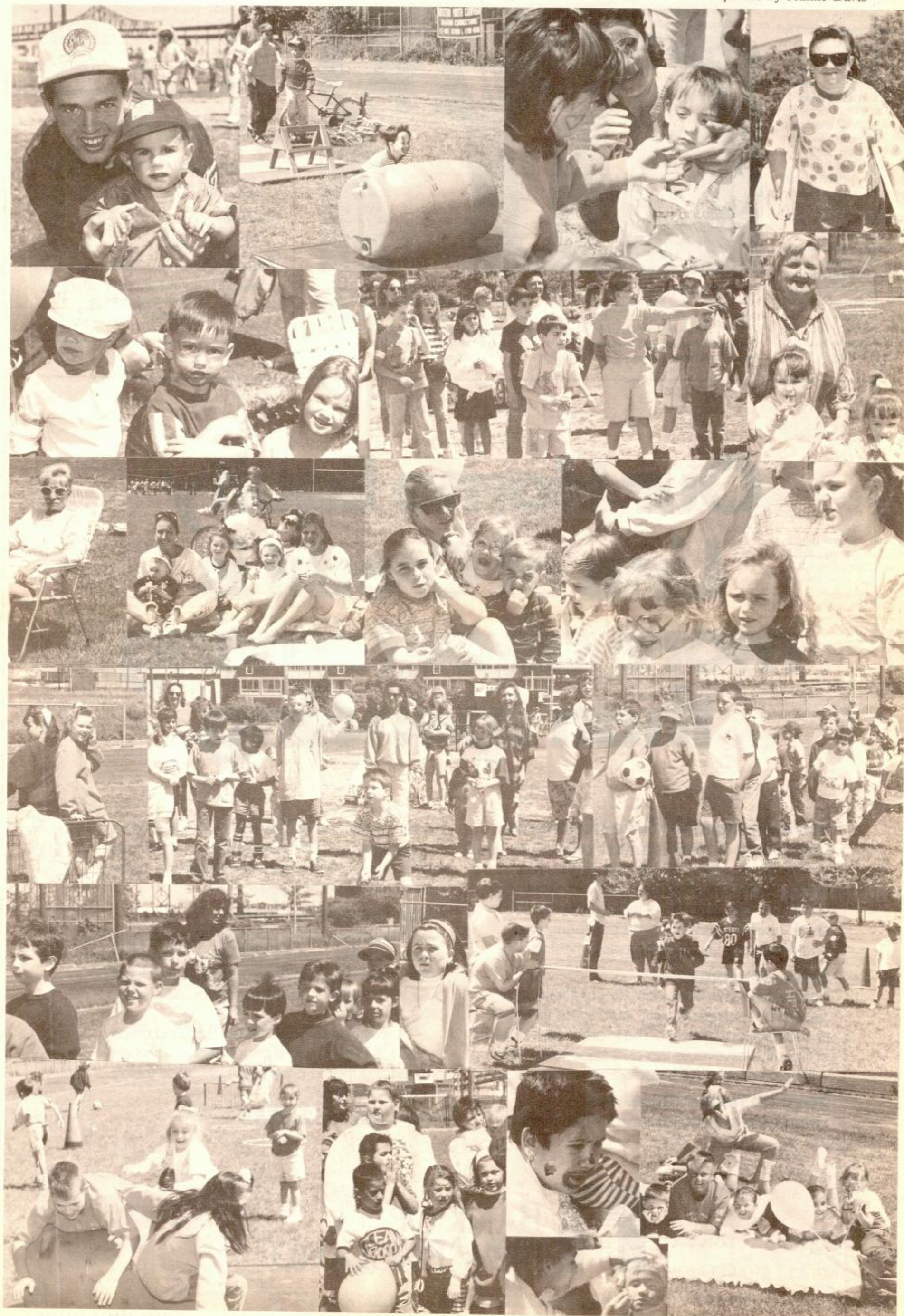

**MWRA And City Set To Sign MOU**

(continued from page one) document include the limiting of the size of the facility to that specified in the Massport-MWRA lease of Aug. 1, 1988. It also determines that at no time will more than 300 vehicles be parked on the site.

The MOU spelled out that the piers will be used exclusively to transport personnel to Deer Island by means of a water shuttle. Ferries containing up to 350 workers will depart from the pier at 6:25 a.m. to return about 4 p.m.

The document sets out that "the MWRA will not, under any circumstances, transport sludge, sludge products or residuals, aggregate, excavated materials, bulk materials or hazardous materials into or out of the Revere Sugar site by any mode."

Other categories outlined in the MOU include: preparation of the site; provisions for handling residential complaints; traffic and parking, including providing two detail police officers for four hours each afternoon the site is operative; job training and education; job fairs, including at least one in the community; notification of job opportunities; means of cooperative relations and information exchange; and dispute resolution.

Also, the MWRA will pay 25 percent (not to exceed \$75,000) of costs to complete the design and Environmental Impact Report for the proposed Charlestown haul road.

In addition, MWRA has

agreed to provide \$50,000 annually for three years to fund activities that benefit the community by providing grants to local organizations or non-profit institutions. The amount of the grant will be reviewed before the end of the three years.

Members of the CNC questioned Dimino as to potential traffic problems, including the fact that the detail police officers are only for the afternoon and leave the neighborhood streets open to a morning rush to the site. They also asked for stronger language in securing jobs for Charlestown residents and requested that the community be notified along with the city on any amendments to the project and be given written notice on any extraordinary circumstances on the site.

Several council members indicated for the record that in approving the MOU, they were not approving the use of the site for personnel transfer. A motion was made to approve the MOU as presented with the several recommendations by the CNC and the vote was unanimous by the 14 members present and voting.

On Wednesday Kathy Hearn, special assistant to the executive director of MWRA, stated that she was hopeful that the MOU would be signed late that day or early Thursday. She said that site preparation will begin late this summer but there are no plans to use the facility until 1992.

Hearn confirmed Steele's re-

port that the Massport-MWRA lease would be for 10 years with two two-year options. Hearn said she anticipates the peak use of the site to be in 1993 and 1994 with the completion of the project within the

10-year range of the lease.

As for the \$50,000 grant to the community, Hearn said that it would probably be issued in July 1991, the beginning of MWRA's 1992 fiscal year.

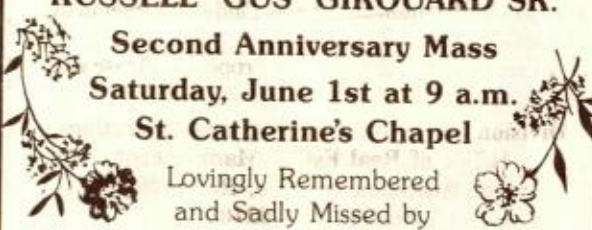

## News From The Harvard-Kent School

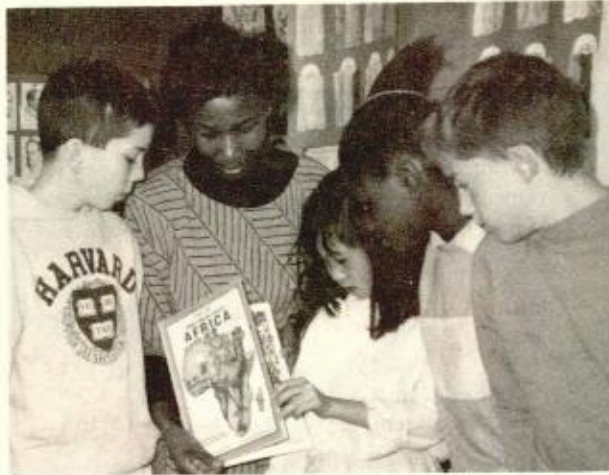

## 'The Investigation Of A Murder In El Salvador' Opens At The CWT

The Cicatrix Theatre Company will begin its three-week run of Charles Mee's "The Investigation of a Murder in El Salvador" tonight, May 30, at the Charlestown Working Theater, 442 Bunker Hill St. The play, directed by Somerville resident Oliver Todd, is the company's first full-length production to be presented in Charlestown.

"I am excited to be working at the Charlestown Working Theater . . . it's an amazing space," says Todd, who decided on the Charlestown location after looking at a number of schools, churches and other theatres. Todd was particularly impressed with the fact that the CWT, which boasts good acoustics, an adequate stage and office, a well-

stocked costume and props room, and a sizeable dance studio and dressing room, has everything necessary to make it the perfect setting for a full-scale production of the play.

Set in El Salvador in the early 1980s, the story of "The Investigation . . ." centers on six wealthy, white Americans sequestered on the estate of a local landowner. Each must confront the bizarre reality of his presence in the midst of chaos. As they wallow in opulence at the eye of the storm, the Americans cannot avoid the contradictions of their position. Ironies abound as they attempt to spend an afternoon of normalcy while refusing to acknowledge the life and death struggle surrounding

their enclave. A murder occurs during the day, but what to do about it?

The characters each try to find ways to ignore the truth of their situation

through denial, self-justification or downright confusion. Their attempts to avoid reality reveal the hilarity, horror and complexity of human nature.

According to Todd, the play is more about human nature than about politics. Against the backdrop of murderous conflict, the play questions not only the motivations of imperial tourists, but also, on a more universal level, the actions (or non-action) of any bystander. "The humor in this play blends the bizarre and grotesque in a way that makes us confront where the line gets drawn between what we can sit back and watch and laugh at, and what we feel the need to get up and do something

about," Todd remarked.

The Cicatrix Theatre Company has presented some unusual plays during the past three years of its existence. Recent productions include "The Birthday Party" by Pinter, "Vatslau" by Mroczek and "Under a Mantel of Stars" by Puig (of "Kiss of the Spider Woman" fame). Two works written by members of the company are among the organization's proposed upcoming projects.

Performances of "The Investigation of a Murder in El Salvador" are tonight through June 1, June 5-8, and June 12-15. All shows begin at 8 p.m. Tickets are \$10, Wednesdays pay what you can. For advance reservations, call 282-7998.

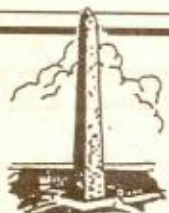
