OBJECTIVE

To improve the Green to Gold ADO and Scholarship mission by clarifying RMID's expectation pertaining to the submission of Green to Gold waivers (ADO and Scholarship), request for extensions in the ADO program and release from the ADO program.



Eligibility



Leaders for Life

- Age Scholarship < 31 by 31 Dec of the year of commissioning (No Waivers for Scholarships)
- Age ADO/Nonscholarship < 30 years old at the projected time of commission (Waivers are authorized)
- GT Score: 110 (No Waivers, retest OK)
- Cumulative GPA of 2.5 (Waivers are authorized)
- Pass APFT <6 Months of Application (No Waivers)</p>
- Meet height/ weight standards (No Waivers)



Eligibility (Cont.)



Leaders for Life

- Chain of Command recommendations (No Waivers)
- US Citizen (No Waivers)
- Not a conscientious objector (No Waivers)
- Eligible to re-enlist code (No Waivers)
- Letters of Acceptance (No Waivers)
 - College/ University
 - Professor of Military Science (PMS)
- No prior ROTC scholarship enrollment (Waivers Auth)



Eligibility (Cont.)



Leaders for Life

- Favorable Clearance Investigation approved or initiated (No Waivers)
- SAT/ ACT minimum 920/ 19 (Waivers auth, retest OK)
- Cannot have been convicted of a Domestic Violence Crime (Lautenberg Amendment) (No Waivers)
- With Dependents
 - No more than three to include spouse (Waiverable)
 - Sole parent with custody (Waiverable)
 - Spouse in Armed Forces/Dual Military (Waiverable)
 - Responsible for child support (Waiverable)
- No arrests, indictments, or convictions by a civil court or military law for other than minor traffic violations (Waiverable)



Eligibility (Cont.)



- Pass DODMERB medical exam IAW AR 40-501
- Minimum of 2 years Active Duty (Waiverable)

PMS Recommend and Brigade Approval

- Age 30 through 32 at time of commissioning
- Reenrollment (no remaining debt)
- Dependency Non-custodial child support, dual military/ROTC, or more than three (3) dependents
- Civil Conviction
 - ■Minor Traffic fine less than \$250 (6 or more within 12 months)
 - •Minor Traffic fine more than \$250
 - ■Minor traffic fine of \$100 or more per offense, plus other adverse adjudication (6 or more within 12 months) or (10 or more in previous 3 years)
 - ■Minor Non-Traffic fine less than or greater than \$250

PMS/Brigade Recommend and CG Approve

- Age 33 through 39 at time of commissioning
- Active Federal Service
- Civil Conviction
 - •Minor Traffic & Non-Traffic any adverse disposition that included a sentence of jail/confinement/detention, even if suspended
 - •Misdemeanor confinement, misdemeanor/non Lautenberg domestic violence/assault, felony reduced to misdemeanor, DUI.
 - Other Misdemeanors
- Dependency Sole/Joint Custody

PMS/Brigade/CG Recommend and HQDA Approve

- Age 40 through 42 at time of commissioning
- Civil Conviction
 - ■Misconduct convictions for felonies or offenses that involve moral turpitude

ADO Extension



Leaders for Life

The ADO program is two-years (21 months). Failure to graduate on time will result in the Soldiers removal from the ADO program. Extensions will be considered for extenuating circumstances beyond the Soldiers control on a case-by-case basis.

Send request, CC Form 131-R and any support documents to the Green to Gold Program Manager at usarmy.knox.usacc.mbx.train2lead@mail.mil, subject – ADO Extension – Cadet XXX.

The CG, USACC is the approval authority.



ADO Release



Leaders for Life

ADO Soldiers must maintain eligibility. Failure to maintain the eligibility requirements below will result in removal from the program and immediate re-assignment.

A Green to Gold ADO program Soldier may be removed from the program for:

- (1) Failure to maintain a CGPA of 2.0 or higher.
- (2) Failure to complete degree in the time allotted (21 consecutive months).
- (3) Failure to meet height/weight standards IAW AR 600-9.
- (4) Failure to pass a record APFT (will be administered every six months).
- (5) Misconduct as defined by AR 145-1 Para 3-43 (12).
- (6) Lack of aptitude as defined by AR 145-1 Para 3-43 (13).
- (7) Undesirable character as defined by AR 145-1 Para 3-43 (14).
- (8) Indifferent attitude as defined by AR 145-1 Para 3-43 (15).
- (9) Change in medical condition which makes the Soldier ineligible for commissioning.



ADO Release (Cont.)



Leaders for Life

An ADO Soldier who has been notified that they will be removed from the program may provide mitigating reasons to the appropriate Brigade Commander. These reasons must be in writing and must be initiated within **seven** (7) days of notification of possible removal.

The Brigade Commander will determine if the request is forwarded after review of the mitigating reasons submitted by the Soldier.

CG, USACC will make the final determination based upon the removal packet, Brigade Commander's recommendations and any mitigating factors provided in writing by the Soldier.
