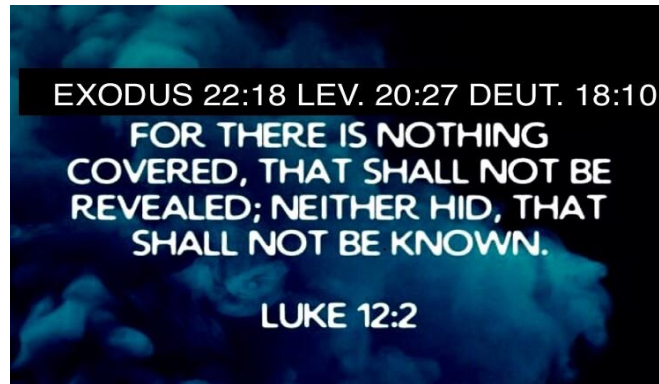

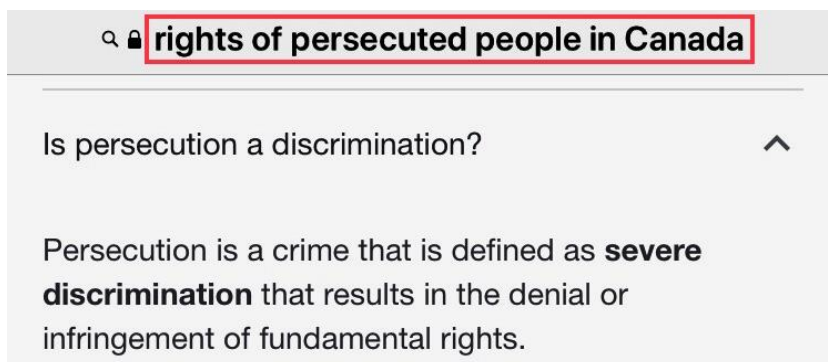

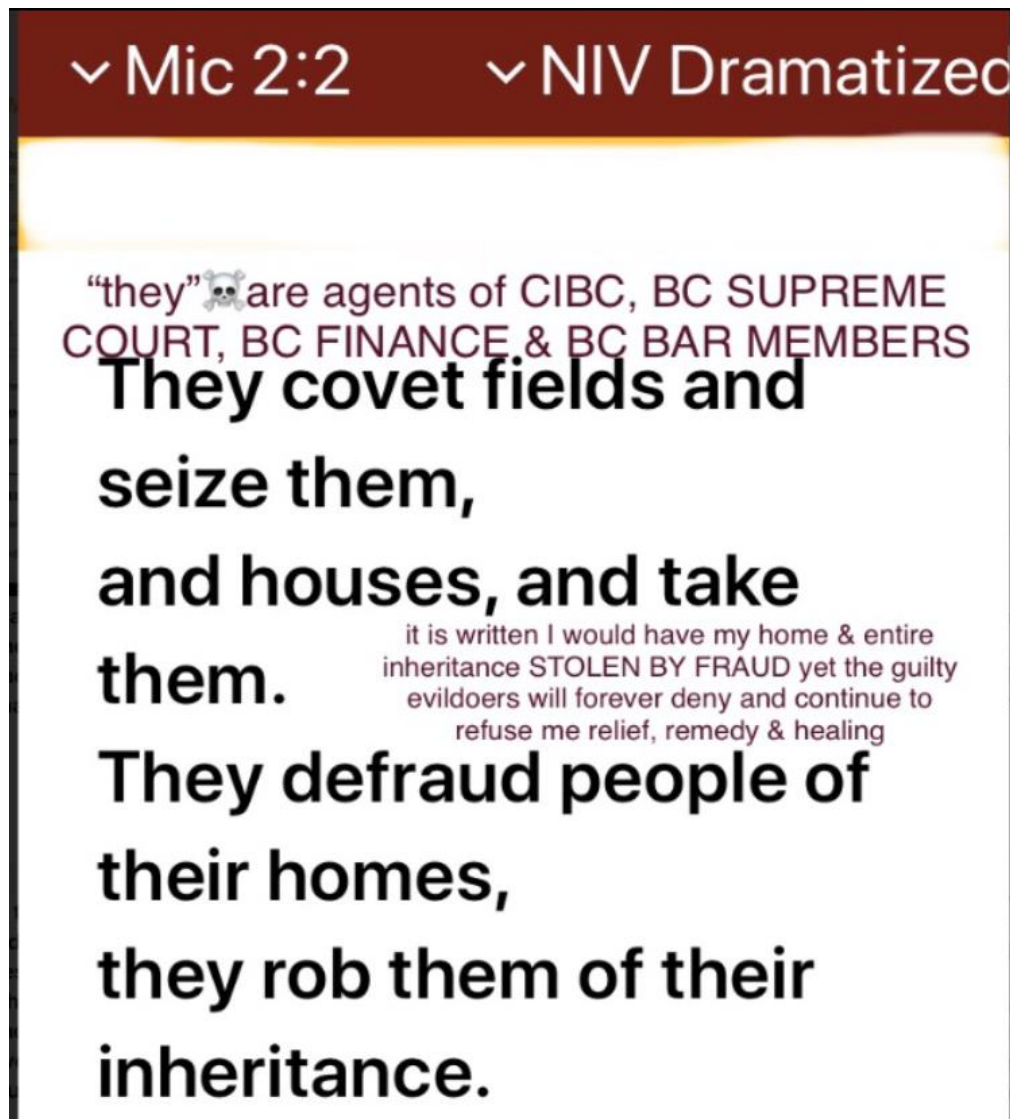

There are two types of trusts in Canada: testamentary trusts and *inter-vivos* trusts. A testamentary trust is created as part of a will and comes into effect only after the testator/ settlor passes away. An *inter-vivos* trust is established while its creator is still alive. Which one you choose depends on what you intend to do with it. If your primary concern is to ease the transfer of assets to your heirs while ameliorating your estate’s tax burden and eliminate unnecessary public probate, then a testamentary trust is probably all you need.

THIS IS THE LAST WILL AND TESTAMENT of me, **GERALD WAYNE JACK DALEY**, of the City of Victoria, in the Province of British Columbia.

1. I revoke all my prior wills and codicils.

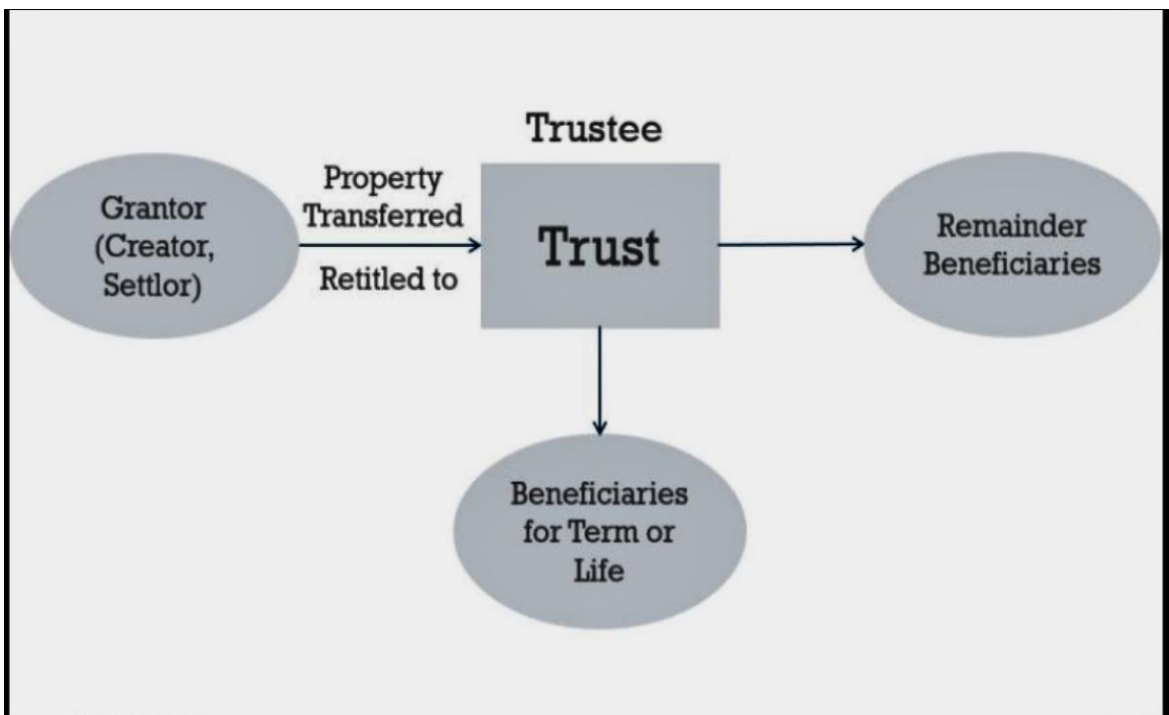
One of the easiest things for creditors to target in a lawsuit is your real estate assets. It is critical to plan for the possibility of such claims.

“The most common techniques are to hold real estate in a spouse’s or adult family member’s name, if they aren’t subject to the same liability risks, or to register the real estate in the name of a corporation or trust, possibly as bare trustee,” Kett suggests.

Doing this creates a protective fence around your family home and makes it off-limits for creditors. Make sure to pick a family member who's not a guarantor for any of your personal or business debt.

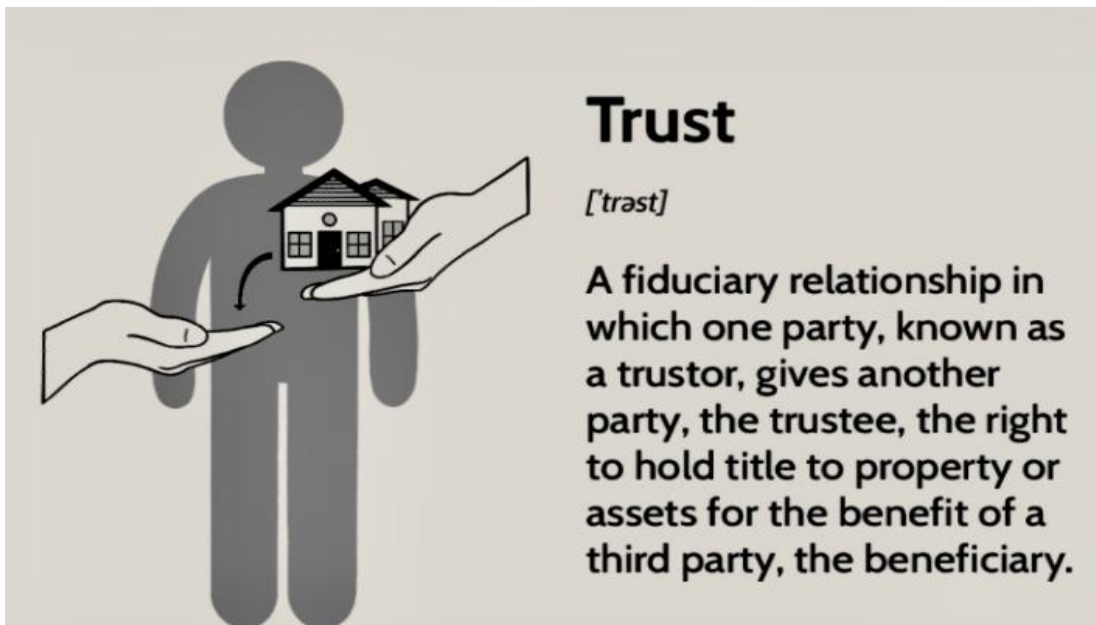

A trust is created when you transfer ownership of your assets to a trustee (either an individual or a trust company) with instructions for them to use those assets for the benefit of a beneficiary. The person(s), institution, trustee or estate you choose to give money, property or other benefits when you die.

Why do people put everything in a trust? ^

The main benefit of putting your home into a trust is **the ability to avoid probate**. Additionally, putting your home in a trust keeps some of the details of your estate private. The probate process is a matter of public record, while the passing of a trust from a grantor to a beneficiary is not. Jun 17, 2022

### Living Trusts: Do They Protect Your Assets From Creditors?

A surprising number of readers want to know "Can a living trust protect my family's assets from creditors and lawsuits?"

I think there are some promoters out there that use this as a pitch to get people to set up a living trust using their services:

"Transfer your assets to a living trust and hide them from your creditors," are the claims.

Sorry, that's not the law.

Let's have a quick review of a revocable living trust. Basically **a trust is "a legal arrangement where property is held for the benefit of someone." In other words, you "entrust" title to your assets to "someone" who is instructed to use and manage those assets per the terms of the trust document.**

A trust is revocable if it contains language that allows you to change your mind and terminate or modify it. In California, the Probate Code specifically states that all trusts are revocable, unless specifically stated otherwise.

A trust is called a "living" trust because it is set up by you while you are living. **If you set up a trust through your will, it's called a "testamentary" trust since it is created through your last will and testament.**

The right to revoke your trust means you can remove any asset from the trust title at any time you choose.

Since you have the right to revoke the trust, you are treated as the legal owner of the trust assets for purposes of income tax law or creditor collection law.

So, the general, basic answer to the question, "Will my revocable living trust protect my assets from my creditors?" is no. Since you can remove any asset at any time, your creditor can force you to remove the asset.

Now there are types of "irrevocable" trusts that can be used for protection of "spendthrifts."

(That's the fancy term for someone who can't manage their own property due to lack of sophistication, gullibility, or other problems).

I know a family where one son spends money as soon as he gets it.

He gives it to friends, spends it on new toys, whatever. He just doesn't have a healthy concept of money and can't keep it. He is a classic "spendthrift."

In his parents' case, what they have done in their living trust is said, in effect, after they're both dead, the spendthrift son's share of the estate will be held in an irrevocable trust for his benefit.

He is to be given a monthly draw on the trust until he dies or until the money runs out.

In that case, **the money** in the "spendthrift trust" **is sheltered from** the son's **creditors since he does not, nor did he ever, own the assets held inside the trust.**

Sure, the creditors can get his monthly draw once he gets it, but the main trust is sheltered for his benefit.

That is **a classic and perfectly legal way of sheltering assets from the creditors** of a "spendthrift" using a living trust (**it can also be done using a testamentary trust**).

Hello Victoria,

I wanted to send you a quick email to let you know that I received Jack's original Will from Donald Linge's office this afternoon as well as their Will's Notice Search results (which saves me a step). He did send a small account (totalling \$883.65) but I told him that it would not get paid until the house sells and there was some money in the estate. It does not look like they were able to locate Jack's son – though there is a note on the file that you had texted Jennifer at one point asking her for Shane's contact information. Did you ever receive a response from her in that regard? If not, I will contact Jennifer's lawyer tomorrow and see if they have any information. If not, we will have to hire a "skip tracer" to find Shane so that we know where to send the Notice that needs to be sent out to the beneficiaries. I will have to contact Jennifer's lawyer regardless as I need to know if I am to send her Notice to them or to Jennifer directly.

In the meantime, I will need to contact CIBC and request that they send me the date of death particulars for Jack's account(s) with them. As such, I am attaching an Authorization for you to sign which will allow CIBC to talk to me. Please sign it and either email it back to me or fax it back to me as soon as possible. My fax number is 778.426.3332.

Also, today I spoke with Dan Carroll, who is the lawyer at Fulton & Company LLP, and representing CIBC in the foreclosure action. I explained the situation to him and asked him about the court hearing later this week. The hearing is still going to go ahead but, as I mentioned to you already, it is primarily procedural – just to get someone named for the estate for the purpose of the litigation – and to get you added as a "interested party" because you live in the house (I did tell Mr. Carroll that you and Jack were common law and that you are not simply a "tenant"). The foreclosure hasn't officially started yet and he asked that I keep him up to date on the status of the probate as he may be able to go back to CIBC and ask them to wait a bit longer. If not, they would still go ahead and start the formal foreclosure process and then once they get an order nisi they would sit back and let you try to sell the house. I felt good after my conversation with him – he seemed reasonable and appeared to understand the situation. I did tell him that the only major delay that I potentially could see was finding Jack's son – but hopefully that won't end up taking too long. Skip tracers are pretty good these days if we have no other way of finding Shane.

Lastly, have you been able to update the house insurance yet?

Do you want me to copy Bob on my emails to you about the estate?

Instances of title fraud are still rare in B.C., but they are on the rise—possibly due to soaring real estate prices in the Lower Mainland. As real estate prices increase, so does the size of the mortgages potentially exploited by fraudsters.

While the Parcel Activity Notifier cannot prevent someone from either impersonating a property owner or from submitting fraudulent documents to the land title office, it can provide a warning to owners when a transfer or mortgage relating to their property is submitted for registration. In the case of title fraud, an owner could then take steps to protect title to the property.

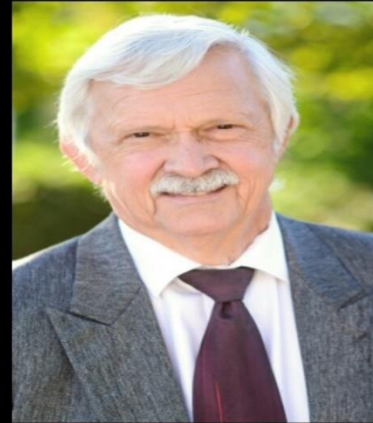



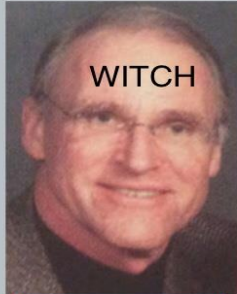

### Pintea v. Johns, 2017 SCC 23 – A SHORT SUMMARY

Your Honour, I would like to respectfully draw your attention to *Pintea v Johns*, 2017 SCC 23 (S.C.C.). This case was decided unanimously by the Supreme Court of Canada.

In this case, the case management judge found that the plaintiff, a self-represented litigant, was in contempt of court because he failed to attend two case management conferences as ordered. The case management judge found that the plaintiff was in contempt of court, struck the statement of claim filed by the plaintiff and ordered significant costs (\$83,000) against him. The plaintiff appealed to the Alberta Court of Appeal, where he was unsuccessful, and then further appealed to the Supreme Court of Canada.

The Supreme Court found that the case management judge, in her decision to find the plaintiff in contempt of court, failed to consider that the plaintiff had not actually received the orders to attend the case managements conferences which were sent to him. The plaintiff moved during the proceedings, and it is disputed as to whether or not he filed a change in address form with the Court in accordance with the *Rules*. The Court continued to send notices and orders to his old address and the orders were not forwarded to him and were not otherwise brought to his attention.

The Supreme Court found that under the common law of civil contempt it must be proved beyond a reasonable doubt that a person had actual knowledge of the orders and that the respondents did not satisfy this requirement. The justices were concerned to ensure that the plaintiff was not unfairly penalized as a self-represented litigant and that sufficient had been done to ensure he understood and could participate in the court process.

In its decision, the Supreme Court unanimously allowed the appeal, restored the action, and vacated the costs award.

As well, the Supreme Court of Canada endorsed the *Principles of Self-Represented Litigants and Accused Persons* published by the Canadian Judicial Council in 2006<sup>1</sup>.

The Canadian Judicial Council *Principles* promote access to justice for self-represented litigants and are used to ensure self-represented persons are provided with fair and equal treatment in the courts.

Highlights of the *Principles* include:

- Access to justice for self-represented persons requires all aspects of the court process to be, as much as possible, open, transparent, clearly defined, simple, convenient and accommodating.

- Judges and court administrators should do whatever is possible to provide a fair and impartial process and prevent an unfair disadvantage to self-represented persons.
- Self-represented persons should not be denied relief on the basis of a minor or easily rectified deficiency in their case.
- Judges have a responsibility to inquire whether self-represented persons are aware of their procedural options, and to direct them to available information if they are not. Depending on the circumstances and nature of the case, judges may explain the relevant law in the case and its implications, before the self-represented person makes critical choices.
- Judges should ensure that procedural and evidentiary rules are not used to unjustly hinder the legal interests of self-represented persons.


I would respectfully ask this Court to ensure that the Principles, where relevant, are used to guide your management of my case.

Several courts have since considered the decision of *Pintea* and the endorsement of the Principles when crafting opinions that deal with self-represented litigants. I can refer you to for instance, *Gray v. Gray*, 2017 ONSC 5028, *R v Tossounian*, 2017 ONCA 618 and *Moore v. Apollo Health & Beauty Care* (2017 ONCA 383) in Ontario; *1985 Sawridge Trust v Alberta (Public Trustee)* 2017 ABQB 530 in Alberta; and *Young v Noble*, 2017 NLCA 48 in Newfoundland and Labrador.

The Supreme Court of Canada's endorsement of the Canadian Judicial Council *Principles* is relevant and important for me in my present case as a self-represented litigant, and I would ask that this Honourable Court to give due consideration to both the application of the *Principles* and spirit of the *Pintea* decision in my case.

3. Where appropriate, a judge should consider engaging in such case management activities as are required to protect the rights and interests of self-represented persons. Such case management should begin as early in the court process as possible.

4. When one or both parties are proceeding without representation, non-prejudicial and engaged case and courtroom management may be needed to protect the litigants' equal right to be heard. Depending on the circumstances and nature of the case, the presiding judge may:

- (a) explain the process;
- (b) inquire whether both parties understand the process and the procedure;
- (c) make referrals to agencies able to assist the litigant in the preparation of the case;
- (d) provide information about the law and evidentiary requirements;
- (e) modify the traditional order of taking evidence; and
- (f) question witnesses.

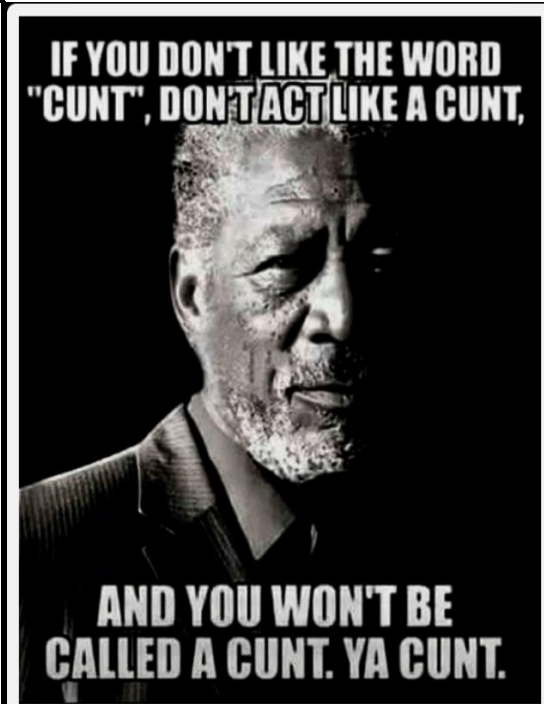

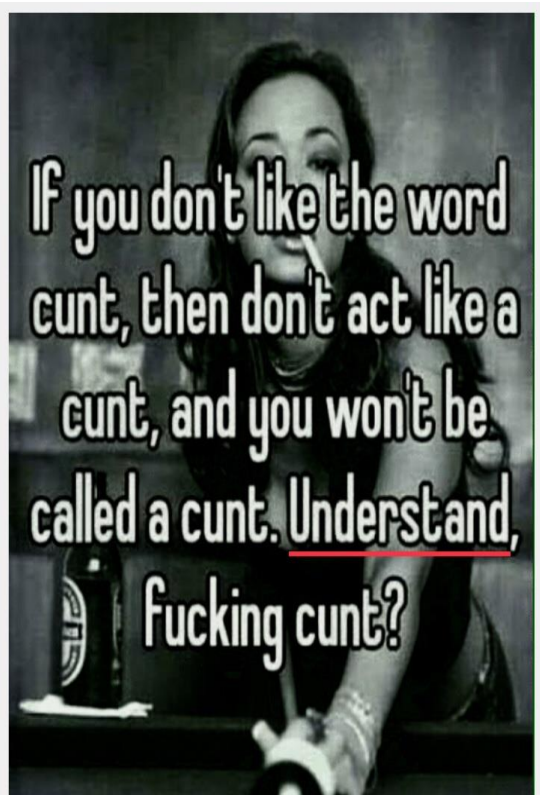

**clean hands doctrine** n. a rule of law that a person coming to court with a lawsuit or petition for a court order must be free from unfair conduct (have "clean hands" or not have done anything wrong) in regard to the subject matter of its claim. As an affirmative defense (positive response) a respondent might claim the petitioner (party suing him/her) has a "lack of clean hands" or "violates the clean hands doctrine" because the petitioner has misled the respondents or has done something wrong regarding the matter under consideration.

I the Woman before *the court* am seeking a court of equity authorized to apply principles of equity to handle my request of injunctions and specific performance remedies. **Equity will not suffer a wrong to be without a remedy:** When seeking equitable relief, the one that has been wronged has the stronger hand. The stronger hand is the one that has the capacity to ask for a legal remedy (judicial relief). In equity, this form of remedy is usually one of specific performance or an injunction (injunctive relief). These are superior remedies to those administered at common law such as damages. "**Where there is a right there must be a remedy**" is paramount as I as Trustee, owner and beneficiary have right to the property under the *Land (Spouse Protection) Act* as directed by my spouse's Will.

United Nations reaffirms faith in fundamental human rights, in the dignity and worth of the human person and in the equal rights of men and women. Article 13 States Parties shall take all appropriate measures to eliminate discrimination against women in other areas of economic and social life in order to ensure, on a basis of equality of men and women, the same rights, in particular:

**2. The applicant must establish that they will suffer irreparable harm which cannot be adequately compensated in damages.**



31. I am a woman with disabilities holding a professional diagnosis of Post Traumatic Stress Injury (PTSD). If I am forced into homelessness and lose my personal and family property, there is no doubt I will suffer irreparable harm. I will not be able to replace these assets which hold great sentimental value. I could never be adequately compensated in damages because these are priceless assets holding memories of my family. These possessions are my lifeline.
32. I the applicant have right to be provided a safe, controlled, familiar environment due to permanent injuries to have an ability to financially provide for myself. If I am forced from my residence, I will not have an opportunity to utilize the premises to own and operate two public service trades greatly contributing to my well being and the betterment & relief of those who need these services.
33. I Victoria am terrified, in fear for my life and have been for months by reason I will be injured by the imminent commission of this wrongful eviction this week on February 28. If forced out of my residence the irreparable harm which cannot be adequately compensated in damages is the reason I, Victoria plead for an urgent *quia timet* injunction to take pre-emptive steps to avoid the loss of my own life and ability to make a living eliminating my burden on society. As a competent, reliable, right minded Woman in need of protection I would like an opportunity to contribute to the community not be a hardship. If I am forced to be a burden on society, I lose my dignity and have no reason to live.

**3. The balance of convenience favours the granting of the injunction.**


34. The balance of convenience in this matter favours the applicant, a grieving widow and woman with permanent disabilities in need of protection. This court has a responsibility to maintain the status quo of the applicant who has lived in this location for seventeen (17) years; a sufficient period of time establishing a connection to the spousal home and adequate connection with the community. There is no inconvenience to the other parties as the sale provides no guarantee of closing written in the contract to extinguish liability for the bank and others.
35. The balance of convenience to favour the granting of the interlocutory injunction I, Victoria plead with this court for an urgent mandatory ruling to take pre-emptive steps to avoid the loss of my own life in hopes to force CIBC to undertake the positive step of negotiating with me privately to settle the allegation of liability owed by the estate of which I am protector and defender.
36. The balance of convenience to favour the granting of the interlocutory injunction are the instructions in my spouse's Last Will and Testament page 2 para 4(a) which is found in the *Land (Spouse Protection) Act 4 (2)* which states I the personal representative hold our homestead in trust

**2. The applicant must establish that they will suffer irreparable harm which cannot be adequately compensated in damages.**

CIBC, its solicitors and this court force evicting me, a widow with disabilities into homelessness violates s. 7 of the Canadian Charter of Rights and Freedoms. Citing *Victoria (City) v. Adams*, 2008 BCSC 1363, 2009 BCCA 563 my position is my forced eviction infringes on my right to life, liberty and security in a manner not in accordance with the principles of fundamental justice contrary to s. 7 of the Charter.

In her judgement *Justice Ross* reminded everyone that **Canada was as party to several international human rights instruments which recognizes adequate housing as a fundamental right.** For example, in *Baker v. Canada (Minister of Citizenship & Immigration)*, [1999] 2 S.C.R. 817 S.C.C.) asserted at para. 70 international human rights law is a critical influence on the interpretation of the scope of the rights included in the Charter.

Quia timet (pronounced ['kʰi.a 'tɪmɛt]; **Latin for "because he fears"**) an injunction to restrain wrongful acts which are threatened or imminent but have not yet commenced, the necessary conditions are: proof of imminent danger; proof that the threatened injury will be practically irreparable (**Definition of An irreparable injury is, in equity, "the type of harm which no monetary compensation can cure or put conditions back the way they were"**); and proof that whenever the injurious circumstances ensue, it will be impossible to protect applicant's interests, if relief is denied.



Actions speak louder than words. Next time someone tries to convince you that they care, look at what they do, not what they say.



Consistently my experience with persons acting as “*the court*” they ADMIT to not reading or reviewing applications, affidavits or documents. We have a copy of the Notice of Application that you filed February 27, 2020. However, you need to provide us with a copy of the affidavit that was filed February 25, 2020.

Pursuant to the Order of Master Keighley, which remains in full force and effect, and CIBC's prior agreement to extend the vacant possession date for 30 days to February 29, 2020, you are legally obligated to vacate the property on Saturday, February 29, 2020. If you do not, the lawyers for CIBC must make an application on Monday, March 2, 2020 for a writ of possession. This application will be made by desk order and when the writ of possession is issued, it will be enforced by the bailiff to have you removed from the property.

Both PUKES/MALE MONSTERS "Johnston & Keighley" ARE COMPULSIVE LYING INCOMPETENT IGNORANT MURDERERS, THIEVES & DESTROYERS WHO HATE ME

As requested a copy of the filed affidavit. I will also provide my notes in the second PDF. I was not surprised to be abused and disrespected today by 'the court'. After digesting the way I was treated by not scheduling a continuance for tomorrow or Monday my application for an injunction has no merit once I'm violently attacked, forced from my residence, my privacy violated and property stolen to be left homeless.

None of this persecution, racism and attempted murder is necessary if Don Linge or Dominique Alford had done their jobs properly when I requested their legal services after Jack passed. Mr. Linge and Ms. Alford are guilty of negligence as both knew the bank was foreclosing. Both read Jack's will and should have known the law to inform me of my right to survivorship of the property which is clearly written in Jack's will. ## Stoney Creek CIBC bank manager stole \$1.7M from seniors, deceased customers: police

A woman who was a bank manager at a CIBC branch in Stoney Creek is facing fraud charges, police say, after investigators say she stole nearly \$2 million from seniors and customers who had recently died.

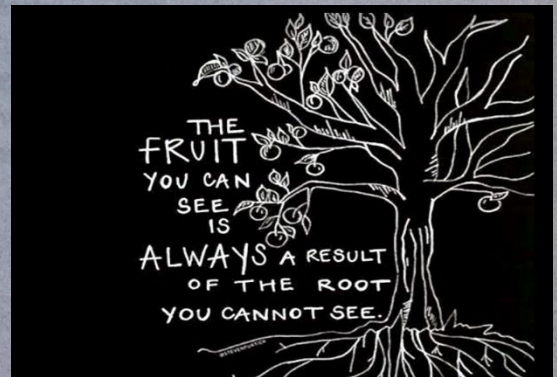
The 60-year-old Burlington woman was arrested Tuesday morning and charged with fraud over \$5,000, possession over \$5,000 and breach of trust, according to police.

Police say she has resigned from her position at the bank.

Hamilton police got involved on April 25 after the service says its major fraud unit received a tip from CIBC's corporate security about an internal probe alleging one of their employees had taken a large sum of money from customers.

A lengthy investigation followed and police say it found the woman stole \$1.7 million between 2008 and 2015.

She was taken into custody Tuesday and released on a promise to appear in court on October 24 at 9 a.m.
