# MGH-Charlestown Nurse To Receive National Recognition

Karen Murphy-Lind, R.N. has been a caregiver at Mass. General Hospital's Charlestown HealthCare Center for 25 years - almost as long as the health center has been in existence.

On Feb. 27, Murphy-Lind will receive national recognition for her extraordinary efforts to improve the health of people in the Charlestown community. She has been selected by the national Dermatology Nurses Association for the group's Outstanding Community Service Award. The annual award is given to an association member who has provided outstanding community service through public education in connection with skin cancer awareness, skin care and skin disorders.

Every year, Murphy-Lind organizes free skin cancer screenings at the health center for the American Cancer Society's Skin Savers Program, and she frequently volunteers her time to speak about skin care to community organizations and senior centers. Charlestown residents have seen her distributing information, sunscreen and caps at the community's Family Fun Day, the Bunker Hill Road Race and the health center's Health Awareness Day.

At the health center, Murphy-Lind is known for her vigilance in combining skin self-exams with other important health measures and has found creative ways to help people become aware of the harmful effects of unprotected exposure to the sun.

Murphy-Lind is equally known as an ad-

vocate for youth programs. For these efforts, she received a Partners in Excellence Award in December from Partners Health Care, which includes Mass. General Hospital, Brigham and Women's Hospital and North Shore Medical Center.

She received the Partners in Excellence Award for her work with the MGH Community Benefit Program in connection with the Healthy Charlestown Coalition's efforts to raise awareness about substance abuse among youth, helping kids improve their performance in school through a mentor-

## Information On Property Tax Exemptions Available On Tuesday At The Library

The city of Boston Assessing Department is holding an information session regarding the residential exemption and personal exemptions for Boston homeowners on Tuesday, Feb. 24, from 10 a.m. to 4 p.m., at the Charlestown Branch Library, 179 Main St. Staff members will be on hand to answer questions and brochures and application forms will be available. Residential exemptions, in particular, can provide substantial savings to taxpayers who owned and occupied their homes as of Jan. 1, 1997. A residential exemption is an amount of assessed value that is exempted from taxation by recommendation of the

mayor and vote of the city council.

For qualifying homeowners, the fiscal year 1998 residential exemption will result in a tax saving of over \$450. Taxpayers who receive the residential exemption for FY 1998 will see the exemption value indicated in the Residential Exemption box on the third quarter tax bill, which was issued in late December. Homeowner-occupants who do not see a value in the Residential Exemption box have until March 31, 1998 to apply for the exemption.

service-connected disability may be qualified for one or more personal exemption. Last year, 6,000 homeowner-occupants received personal exemptions, saving them from \$175 to \$1,750, depending upon the type of exemption granted.



Recipients of FY 1997 personal exemptions who completed a renewal application this summer, and first-time applicants who filed before Oct. 31 should look at the Clause Exemption box on the third quarter bill. If a dollar amount appears in the box, the taxpayer received the exemption. Taxpayers who do not see a personal exemption indicated on the third quarter bill but believe they may qualify have until March 31, 1998 to apply.


When you buy an investment property, finding and keeping good tenants is very important. We've found that a little caution during the screening process can save a lot of headaches later on.






She has received numerous awards including first place, Juried Exhibition,




# Doherty Park Named National Landmark



# Birmingham Calls For \$443 Million In Income Tax Relief

Senate President Thomas Birmingham proposed enacting the largest tax cut in the history of the Commonwealth with the benefit accruing to average taxpayers. "By doubling the exemption and making the tax cut effective in 1998," he explained, "this tax cut returns \$443 million to working men and women in an equitable and straightforward way."

Birmingham, referring to the latest revenue data, asserts that unlike the \$1.5 billion tax cut proposals, "this \$443 million tax cut will not jeopardize the Commonwealth's ability to invest in its future through education, child care, health care and public safety. We can balance a tax cut today with spending to improve the Commonwealth of the future."

The recommendation is to increase the tax exemption for single filers from \$2,200 to \$4,400, for a \$131 tax cut, and to increase the exemption for those filing jointly from \$4,400 to \$8,800, creating a \$262 benefit.

"This is a progressive, responsible way to help all taxpayers enjoy our economic good times," said Birmingham. "This is collectively produced wealth, and it ought to be recognized as such."

Two examples illustrate the different philosophies governing Birmingham's proposal and the one recommended by the governor for the 1999 tax year: A couple filing jointly, one with \$50,000 of taxable income, would get a tax cut of \$175 through the governor's proposal. With the Birmingham recommendation, they would get a \$262 tax cut.

In contrast, a two-parent family with \$500,000 in taxable income, would receive a \$1,750 windfall from the governor. That same filer, with half a million dollars in taxable income would get a \$262 tax cut if the exemption is doubled.

Birmingham said, "Doubling the exemption now offers an opportunity to share the good times in a timely, responsible way with ordinary people benefitting as much as the wealthiest."



# Scapicchio Calls For Improvements In Sullivan Square Area

District One Boston City Councillor Paul Scapicchio announces that from a Feb. 3 meeting for concerned Cambridge Street area residents, the development of plans for improvements to the Sullivan Square area are underway. Scapicchio scheduled the meeting shortly after an area resident was struck by a car and severely injured as she attempted to cross Cambridge Street.

Present at the meeting were Scapicchio, Councillor Stephen Murphy, Boston Police Area A Capt. Ronald Conway and Officer Bill Smith, along with representatives from Central Artery and the Boston Transportation Department (BTD). Ten residents of the impacted area attended and were able to voice their concerns. Scapicchio stated, "This area has been a traffic nightmare for a long time. I am glad we were able to focus attention on the problems." The councillor then suggested more speed limit postings and an electronic speed monitor. Conway stated that he could get the speed monitor as well as add more selective enforcement in the area. In addition, Murphy stated that as chairman of the Public Safety Committee, he would help the residents.

Other issues raised by residents were: the traffic light on the corner of ' Brighton and Cambridge streets; the safety of pedestrians utilizing the day care center, bus stop and Sullivan Square T Station; creating a safe and easy access route from residents of the "Lost Village" into town; and the safety of the Caldwell Street Playground.

As a result of the meeting, the BTD plans to install a new street light as part of their "Spring Clean Up" program. In addition, Para Jayasinghe from BTD offered to do a study of the area and make a proposal for a pedestrian walk across Rutherford Avenue into town. Lastly, Officer Smith addressed the Caldwell Street Playground issue and asked that all residents contact the police department whenever they observe illegal activity so police can respond appropriately.


