This paper' is concerned with an examination of the powers and obligations of the private prosecutor in Canada and with assessing the viability of retaining such a role in the light of modern judicial developments.² For the purposes of this study, a **private prosecutor is taken to be an individual, group, or corporation (other than a public authority) not acting in any public capacity.**³ Although theoretically most prosecutions are "private" in the sense that they are pursued by various **public officers who have no powers beyond those of the private citizen,** they are not private prosecutions in the sense of the term as used here ⁴
