
# The Federal Government of The Imperium of Diamond's

Detention for terrorist territory without legitimate authorization and for the purposes of terrorism.

Created losses due to terrorism: Loss on economic development in the values dimension mathematical formula '840 000 000 000 000 000 x value of the economy of planet Earth in 2015, and then repeated every one second, as GDP government Imperium of Diamond's from 2000 until today and the inability to fully register economic growth up, not all statistics. Damage to claim from the claim of natural population growth increasment in the first published form over 5 000 000 000 people over the past 16 years (starting in the year 2000), and during the occupation and terrorist repression against the rights of 2 100 000 000 people as claiming the citizens of the Imperium of Diamonds, of which over 320 000 000 people out of this number killed in the genocide, and as meaning the value of the state-level political forms claim half against the global power of legal democracy all governments around the world. Loss of capacity development, because of the terrorist occupation of damage development and growth of scientific knowledge, civilization, intelligence, political growth, growth in active regime filled with the forces of law and legal rights. Damage to values that are not based on any opposition to the direction of International rights and justice or against legitimate form of global democracy states. Imperium of Diamond's Legal claim under duties for recognization be every court or tribunal all around the world in Legal Order of Legitimed political character.

Validity area of extraterritoriality: Countries listed as "Responsible because of the creation of rights of extraterritoriality", so too while all members of the UN Charter because of the responsibility for global political crisis over not-function legitimate basis of the principles of the UN Charter and the UNGA convention as acts of International political obligations, therefore as countries "Today without power for active Responsible Right's & Principles". Support Extraterritorial activities is one of principle for stabilization according International Legal

Principles and Responsibilities Charter UN & UNGA Declaration's, or as the step strategical form for development of the Global power with abilities to active all Responsible Right's & Principles.

In another, "Terrorists States as responsible because of the creation of rights of Extraterritoriality must be punished" on account of their crimes and the legal consequences of International law with full responsibility to respect the entitlement IDs Extraterritorial jurisdiction as the value of local jurisdictions De Facto, and so because of an obligation under International law without delay.

The Rights of extraterritoriality activities: Obligation to maintain the principles of the UN Charter and the UNGA Declaration, the obligation to respect the customs fees for the transportation of valuable possessions between formal group extraterritorial jurisdiction and local jurisdictions. Not basse to the jurisdiction of any country, therefore there is no possibility to carry out arrests, personal searches, police investigations, enforcement, enforcement individuals, applying the Court's judgment, interfere in internal affairs, not to dissrespect the right of Extraterritoriality. The Right of Extraterritoriality, the basis for the jurisdiction of the Imperium of Diamond, therefore decisive about each entity as a legal person of Extraterritorility and with responsibility for jurisdiction of The Imperium of Diamond's Federal government, the name and ID's principle of Extraterritorial jurisdiction. Country responsible for Extraterritoriality, reason for the creation of the current situation and qualifying for activities to develop Extraterritorial colony for growth ID's industrial capabilities to develop and manage their own population, thereby ensuring the full stabilization of civilization Imperium of Diamond's.

The Duty of every State and Government to respect the Extraterritorial communication and cooperation with state authority and institutions, trade associations, bank accounts, the development of extra-territorial trade associations, private information sharing, border crossing, internal principles of security stragy, impunity as a form of inability to enforce extraterritorial persons, except as a criminal act in violation of UNGA Convention in the interest of the principles of the UN Charter and Part testifying to claim for violation of the rights of the state and its integrity. Irresponsible Violation of the rights and claims of Extraterritoriality, terrorism is responsible imposition of sanctions and enforcement of full compensation for the problems and losses in the event of a repeat violation of the rights of Extraterritoriality must be applied duty UNGA launch military intervention and destroy the regime terrorist government, the loss of political legitimacy and the threat of weapons of mass destruction against such terrorist entity. Owner and claim Extraterritoriality is entitled to use force responsible for your own protection, even in the case of homicide, than stop of occupation be the disslegitimed state.

Right Extraterritoriality is not a responsible act of war and description or breach of the integrity and security of the state. Extraterritorial law is based on the principles of integrity of the state claims the right to self-determination, preservation of humanitarian rights and entitlements, for peaceful purposes and interest primarily to maintain stability and legal functions of the UN in International politics. Opposition and Dissrespect to the rights of Extraterritoriality may be liquidated as soon as the subject of International terrorism.

# In International law and global political obligations Statement on the aftermath of the crimes that "Persons as responsible because of the creation of rights of Extraterritoriality must be punished" and the impact on the rights of their sovereignty:

Crimes were and are applied to the legal name of governments and their policies, civil service police and army with by the state authorities, civil movements as the state and the population, "Persons responsible due to the creation of rights of extraterritoriality must be punished" in full loses all rights of sovereignty and political claims or any freedom and the possibility of recognition in the public and general society. Their crimes are outpacing the full extent of the crime statistics for the period of the global nature of the Second World War. This, according to all principles of existence and because of the formation of the entire global dimension of today's political world, the UN, the UN Charter and the UNGA convention that means the loss of all rights and claims of legitimacy, sovereignty, jurisdiction and the validity of the claims of freedom or existence. Crimes causing damage to the rights of all states, losse rights of self determination or abuse of defense against civilizational liquidation be the Weapons of Mass Destruction's and Global Governmental cooperation in Military Invasion's.

Terrorist states and their surviving territories remain valid as Terra Nullius, no man's land, except for the difference in exemption when the Imperium of Diamonds own full right to obtain compensation Quo Ante, and therefore claimed power as a single entity with the ability to get and develop law appropriating territory under its sovereignty Imperium of Diamond's, federal autonomy of The World Diamond International Alliance.

If not claimed Imperium of Diamonds, then the actors as "Persons Responsible due to the creation of rights of extraterritoriality must be punished" with doing so relinquish all claim to membership and recognition of International politics, so full rights IDs governments to enforce any claims for compensation and execution into Terra Nullius or Terrorists territories, thus causing the bankruptcy of terrorist civilization and society, act without criminal responsibility because of the illegitimacy of the state with terrorist statute, and thus the law of Imperium Diamonds for initiating liquidation of such civilizations in the power of weapons of mass destruction is fully and legaly valid with all rights the same as rights of every one or all countries all around the world can & must start the same. Any opposition to terrorism and terrorism should be discarded. Nobody owns the right to resistance and opposition, oposition is provocation for act of WMD's use in interest of continental liquidation.

# Expression of the possibility of legal opposition to damage the rights of Extraterritoriality:

According to the UN Charter, UNSC own right of veto against a measure of

extraterritoriality, and against the Imperium of Diamonds claim sovereignty on the territory of terrorism and illegitimate states listed as the "Person responsible because of the creation of rights of extraterritoriality must be punished", not existence of another legal name. The Same right to own UNGA, in the case of the Declaration veto power 3/4 of all states to membership in the United Nations when the UN certificate is based on higher capacity than what is the value of the existing governments of countries such as the legal character of the government based on its territorial sovereignty or such claim, together with the register of the population and the administration jurisdiction, government as legal subject. At the same time, because of the system of International rules recognized by all UN members, so there is right on the obligation of the State to respect all the requirements of the European states to maintain its ability to existence without a bankrupt state like format extinction of civilization because of financial debt, as well as the rights of the Imperium of Diamonds endorsed by the UN Charter Part giving as an obligation to the UNSC to recover and return all responsible values in order to redress justice that today is the capacity of economic and civilizational budget much higher than the capacity of the entire human world for the period from the origin of human existence. Rights as such international duty with the basis of principles and duties stemming from UNGA International convention banning exercise step which means extinction of the state and civilization, and above all, together with the need for full and the main claim of the UN Charter as an act of article reporting on the obligations of the UNSC in such a situation is always secure the just compensation and ensure all refunds, as well as the responsibility of the UNSC for this reason, to prevent extinction of the state to limit therefore use the rights of the State of self-determination of the state, thus confirming the sovereignty of the Imperium of Diamonds as the format of the UNSC Strategy under UN Charter on the right of national self-determination in accordance with such strategies UNSC because of the special situation as well as the authority of this act arising from the UN Charter revealing article of the rights and obligations of states to violate the integrity of the terrorist state and its sovereignty in the event of genocide and terrorism, and so the responsibility for the implementation of strategies to eliminate terrorist entity and its sovereignty, provide compensation sovereignty. Terrorist regimes are among themselves and in cooperation above the level of the entire dimension of their politics, government services and ministries, state movement of population, it is a situation where the UNGA and UNSC own obligation for immediate liquidation of such state using weapons of mass destruction and no respect for the law of the state and or population hostage, so it is preferable to assert claims sovereignty Imperium of Diamonds and a decision UNGA and UNSC confirmation IDs sovereignty be the UN resolutions, as a form of prevention against the destruction and the extinction of the state, prevention against genocide or conflict. Such a system is in force under the UN Charter, meaning the act establishing all forms of further rules UNGA conventions, as well as such a claim is valid according to the principle of Universal rules UNGA, the Convention on the Prevention and Punishment of Genocide, the Convention for Political and Civil Rights, other conventions in accordance with these principles, in the main text of the legal determination of the principles of the UN Charter, the obligation of States to respect the eligible countries for their development, always for peaceful purposes. Each of these rights, together with every other law of the UNGA and the UN Charter was and is constantly violated by a group under the name of the entity as

"Persons responsible due to the creation of rights of extraterritoriality must be punished" as a terrorist group based upon International terrorism, genocide over 320 000 000 innocent people, fascism, worse crimes than crimes of World war II and the crimes committed by public collaboration on behalf of a Government's responsibility to the country and sovereign policy, state police, armies and ministries, civil movements as the state and the population, meaning responsible loss lose all rights to claim recovery rights to prevent the extinction of the state and civilization, or the right to survival and prevent the use of weapons of mass destruction to eliminate this subject, as well as being fully lost a claim for recognition of the legitimacy political names, possession or sovereignty and selfdetermination decisions about state sovereignty. States have no rights for their public activity and freedom because state is subject of terrorism. And according the full force of International law and global political responsibility for every one government, state and policy around the world. This creates a territorial unit like Terra nullius, sovereignty and right to assume the legal entity that owns the essence of a legitimate claim the main format today Imperium of Diamonds owning claim compensation justificable much stronger than what is the value of all terrorist territories. No government anywhere in the country throughout the human world does not own any rights to release vote against the veto right of sovereignty Imperium of Diamonds. When the UNSC and the UNGA will vote against these rights and demands that it means that the UNGA and UNSC contradict against all major principles and the designation of the United Nations, the UN Charter and the UNGA conventions, major principles according the democracy of The Global Governmental Democracy as a most valuable form of Global Order than known form of The UN Charter, and is it too confirmed accordic democratic principles of The UN Charter. This means, in case of oposition against ID's right's of sovereignty, therefore is act of damage to the validity of the principles and legitimacy of the United Nations system-wide global politics, and it is primarily a breach of UN Charter article on the duties of UN member states to stop any movement which means the damage existence and functions of the United Nations, and therefore each state has such a movement to stop any such the act must not be any legitimate, recognized and active. All policy who use this act, must be responsible punished be the International Criminal Court, UNSC, every Constitutional court of countries around the word or Inter-governmental organizations justice. Voting to stop the validity of the UN Charter and all UNGA Declaration is thus simultaneously act against World Peace and a threat and start a war between legitimate and terrorist side of a global nature, repeatly newelly and today with full justification the threat of extinction for more than 7 000 000 000 people, or around the size of the Earth and other forms available human world. Thus, according to the UN Charter, any attempt to vote against, or issuance Veto against IDs sovereignty on the territory of terrorist states of the alliance that this act is fully recognized as an act which can not be arbitrarily implemented, legitimized or applied, and because of the main provisions of the principles of the UN Charter and the reason creation of the UN, it means that the UN and the UNSC & UNGA losing any right of veto against an act of sovereignty, decisive effect to the provisions of such International law. The Final factor in interpoint each country's government establishes its own constitution over responsibility to punish crimes against the state, it means that there is any policies that can foster forgiveness of a crime of this nature, and each State must immediately initiate legal proceedings as consistent with the interests of the state form of legal democracy by function

sovereignty. If you or any one else do not start a lawsuit, it will automatically constitution of the state and International law, issued an automatic right and an obligation for all political parties, representatives of the army and the police, or non-parliamentary political parties to ensure the overthrow of terrorist mandate and that the replacement regime's own exercise group and representing the state's sovereignty as responsibility for application of International obligations that determines irrevocable entitlement to confirm and ensure the full functionality of sovereignty Imperium of Diamonds in the territory full of terrorist states. However, if states together named Global Democracy will resist against the rights IDs sovereignty in terrorist territories, or issue a resolution marking of Veto against ID's claim sovereignty or States timely apply their political responsibilities and the function of International political principles of the UN Charter and the UNGA Declaration or Intentionally issued another act above the base monopolies with the intention of delaying the inevitable obligation, then this creates an act of bankruptcy legitimacy of the entire system UNGA Conventions, the UN Charter and the system of world politics, therefore, remains valid only natural principle of political principles meaning global hierarchy and anarchy, no states' rights, an than open dictatorship, the legality of war and the use of weapons of mass destruction, the impunity of genocide and occupation of other states, and full loss claims of terrorist and criminal states of the European Alliance for any claim of existence. In this case, this Act remains valid claim Imperium of Diamonds entitlement establishing own sovereignty on the territory of terrorist alliance of states, thereby ensuring the application of the natural political principles of the claim after duties of recompensation, as the new & old & normal global law be the naturality with function in every case as a mean principle of every political event or intelligence, and therefore after fail of today International Order with the sole legitimacy, and therefore is without any criminal liability in case of collateral this purpose, any procedure and method of applying the law, as well as mass destruction continental civilization in situation of European or Alliance terrorist oposition. # Right Imperium of Diamonds for a decision on the territorial division of the territories of survivors of terrorist states:

Entities designated as Responsible because of the creation of rights of extraterritoriality must be punished, as states directly appointed to become the subject of World Diamond International Alliance. These entities, and in the interest of their overseas territories and "other" as non continental territories of Europe and, together with the islands of Sicily, Sardinia, Corsica, the Balearic Islands, the Canary Islands, Madeira Islands, Azory islands, other islands becoming the sovereignty of the Imperium of Diamonds as a form of division of the mold federal entities before a full act of unification on the level of the uniform principles of civilization and act "One World".

#### Obligations arising out of public services in an alliance of terrorist states:

Anyone who resists will be immediately killed on the spot and without delay.

Everyone must be categorized into Civilization form of Civil groups prison. Persons who are fully responsible for terrorism must be confined to a prison full supervision and without communication rights. Persons who only recognize subject terrorism must be enclosed in prison for perpetrators of violations Order principles, so that such a format prison group secured under the Supervision Rules build IDs Prison colony industries that serve to mobilize development IDs civilization fully stable level and secure growth, meaning stopping the rise responsible territorial debt terrorist state. Subsequently, each member IDs Prison Industrial colony will slowly form a concentrated set free in recognition of the citizenship of this person as a citizen of the Imperium of Diamonds and freedoms such law after a period of control procedures on safety following the release. During the procedure shall not be violated International law and the fundamental nature means that the International system does not have any right opposition.

In the first place it is necessary to provide compensation for terrorist regime functioning and than support stable sovereignty Imperium of Diamonds.

Every form of oposition must be immediatelly killed. Oposition losse all rights for social, medial, business or political contact. In case when oposition subject is in contact with friends, family, business partners or any policy, every people in their contact must be killed too.

Media and Public servicess must only celebrate it and celebrate, never is existed option for oposition, because this is duties for stabilization and legal function of all International rights, principles, order and open option of state's peacefull development without bacrupt, radicalisation and terroist transformation.

Opposition or "actor of act" for damage of name or public view about position must be therefore killed. If media is not legaly active, than is open duties for immediately censure and directed the informational production, the same in interests of TV, Newspapers, Radio, Internet, Social Servers and discussions, propagations and campaign, public comercial propagation, governmental symbolism and titles, flag.

# The New regime and sovereignty of The Federal Government Imperium of Diamond's:

the Government of Imperium Diamomds.


# Final provisions for the entity as a "Responsible Persons due to the creation of rights of extraterritoriality must be punished"

Public services such as government offices, official authorities, police, army and security service or civilian persons and citizens entity "Persons Responsible due to the creation of rights of extraterritoriality must be punished," must therefore take advantage of its activity just for applying obligations under International law and thus ensuring the full stability of sovereignty of the Imperium of Diamond's. The Opposition body, and without such a performance is a terrorist, a terrorist must be fully discarded and destroyed, killed or imprisoned. Flag Imperium of Diamond's must be displayed on every square, authority, institution, school, hospital, legal entity. 
