## Charlestown Boys \& Girls Club To Begin Renovations On May 1

After years of discussion, planning and fund raising, the Charlestown Boys \& Girls Club will begin its much-awaited renovations on May 1. The club's original plan to sell its Green Street building and consolidate operations into an expanded High Street building, met opposition from its abutters. Faced with a lawsuit and escalating costs, the club decided to keep both buildings and do a full renovation

The High Street building will be renovated first and completion is expected in early 1999. The Green Street building renovation will follow and will be completed before the end of 1999. The club will have at least one building operating throughout the course of the renovations.
During the High Street phase of the project, the Teen Center space will be relocated to the third floor of the Green Street
building. The gymnasium will not be available for use, but the physical education staft will be conducting leagues and other outdoor activities utilizing neighborhood parks. The club's summer camps will be unaffected by the renovation and will continue to operate in the Green Street building.

Central Artery Meeting To Discuss 14-Lane Bridge And Ramps
Representatives from the Central Artery/Tunnel Project (CA/T) will be coming to Charlestown on Thursday, April 30 at 7 p.m. at the Knights of Columbus Hall, 75 West School St., to show drawings and to discuss a variety of issues relative to the project.
Some of the topics to be discussed include the new 14-lane bridge that will cross the Charles River between I-93 at the Bunker Hill Community College and North Station as part of the CA/T Project and what ramps from Charlestown will exist after the river crossing is built. CA/T staff has informed residents that any issues conceming the project, especially as it relates to Charlestown, will be addressed.

Charlestown Industrial Park Discharges Waste Into Harbor . . . Landlord Slapped With \$70,000 Fine

The owner of the Charlestown Commerce Center, 30-50 Terminal St., has agreed to pay a $\$ 70,000$ fine to the Department of Environmental Protection for allowing sewage to discharge from the industrial park into Boston Harbor.
As part of the consent order, Donato Pizzuti, trustee for CCC Realty Trust, owner of the industrial park, agreed to connect the park into the municipal sewer system.
Acting on a complaint, DEP inspectors in October 1997 visited the park and found what appeared to be sewage overflowing from a
manhole cover. Inspectors revisited the site on numerous occasions during the past six months to test the overflow and determine its path. The staff found high levels of fecal coliform in the sewage and, using a dye test, discovered that the overflow was discharging into Boston Harbor, violating the state's Clean Water Act and Title 5 regulations. "We have worked long and hard to bring Boston Harbor back from its inglorious days as America's dirtiest harbor. We won't sit idly by and allow iresponsible behavior to pollute the harbor again," said

William Gaughan, DEP's Northeast Region director. "We were made aware of this case by a citizen who tipped us off. We encourage anyone who witnesses environmental crimes to call us on our toll-free hotline at 1-888-VIOLATE."
The consent order also requires the Trust to provide DEP with plans and drawings of all existing pipes and tanks showing the discharge points on the property. And, the Trust is required to submit to DEP by July 15 a plan to tie into the municipal sewer system.
In the interim, the Trust has installed an 8,000 -gal-
lon tight tank for the disposal of wastes from Atlantic Coast Brewing, Ltd., a tenant in the industrial park. The Trust will then submit records to DEP showing that the tank is properly maintained and pumped out.

If the Trust violates any part of the consent order, it will be liable for an additional $\$ 19,710$ fine. The fines and consent order cannot be appealed.

## Local Groups, Residents, Urge Clean-up Of Dirty Mystic Power Plant

Now that spring has come and the earth has thawed, people are beginning to come out of their homes to take a deep breath of fresh air. Unfortunately, the air is not as clean as it should be thanks to the "Filthy Five," the five worst power plant polluters in he state.
For asthma sufferers like Amy Rosetti, the spring thaw is not a happy occasion. She lives near the Mystic Power Plant, which is located in Everett. "Air pollution aggravates my as thma. On hot summer days, I have to stay indoors so I can breathe," she says.

Amy is not alone. Communities in the vicinity of the Mystic Power Plant have nearly twice the state's rate of asthma. Poor air quality causes a laundry list of problems including reduced lung function, increased asthma attacks, and the premature death of over 1,000 people each year in Mass. Over 24,000 people each year are hospital-
ized in Mass. due to respiratory dis tress. Children and the elderly are especially susceptible to the health impacts of air pollution. Asthma is the number one reason for kids to miss school.
Given the health consequences, why does our air continue to be so polluted? Due to a loophole in the Federal Clean Air Act, power plants built before 1977 can legally pollute up to 10 times more than plants that meet modern day standards. There are five such plants in Mass., and they are responsible for 40 percent of the total air pollution in the state. "These 'grandfathered' plants are the largest industrial source of air pollution in the state. Bringing them up to modem emissions standards would give us the biggest bang for our buck, greatly reducing pollutants that affect public health, watershed quality, and acid rain," says Beka Economopoulos, clean air associate for MASSPIRG

Local residents, community groups, health care professionals, and environmentalists are calling on Gov, Paul Cellucci to begin at home by requiring the Mystic Power Plant and other polluting plants in the state to meet the same air pollution standards as new plants. The clean-up of the Mystic plant would reduce its sulphur dioxide emissions (acid rain) by 75 percent and its nitrogen oxide emissions (soot and smog) by 30 percent. This would be the equivalent of removing over 51,000 cars from the road.

A public forum to discuss air pollution and the Mystic plant will be held on Wednesday, April 29 at 7:30 p.m., at the MGH HealthCenter in Chelsea at 151 Everett Ave. Sponsored by local groups and the Chelsea Health Department, experts will provide information and a plan of action will be set.

## Legion And USS Constitution Sponsor Program On The Flag

On a recent spring moming, students from grades 4 and 5 at the Harvard-Kent Elementary School were invited on board USS Constitution by her commanding officer, CDR. Christopher Melhuish, USN, to participate in the "Our Country's Flag - Veterans - Children - Constitution" program. Lt. CDR. Claire Bloom, USN, executive officer of USS Constitution, was the host for the gathering, in the absence of Melhuish.
This program, cooperatively organized and sponsored by USS Constitution and Bunker Hill Post 26, The American Legion, was held in conjunction with the visitation to the ship of Anthony "Tony" Jordan of Maine who serves as the National Commander of The American Legion, the largest veterans organization in the world.

Bloom opened the program, speaking about the country's flag along with the Pledge of Allegiance as two important symbols of this nation. She explained that when this nation has gone to war, it has done so under this flag, noting that "Old Ironsides" had fought under this flag.
Bloom told the students that the three colors of the flag were symbolic: the red is indicative of the ruling power and also of the blood shed to protect the nation; the blue represents the water and sky that surrounds this nation; and white is a symbol of peace.
James Conway, Past National Historian of The American Legion, spoke about the great relationship that has developed between USS Constitution and the residents of Charlestown and the community's pride in her officers and crew.
Legion Past National Commander John P. "Jake" Comer of Quincy stated that he was pleased to have the opportunity to be on board for this special event.

Jordan, the Legion's present National Commander told the students that the flag and the ship both stand for freedom. He stated that he represents over 3 million veterans and "freedom is the watchword." He asked the students to ask that the flag be flown - at their school, on public buildings and outside their homes.

Bloom then told the students of the pride she felt and she led them in the Pledge of Allegiance as each student held a small American flag, courtesy of Bunker Hill Post 26. Conway then asked Bloom, Bunker Hill Post CDR. Ron Taylor to join him for a presentation to Jordan of a plaque commemorating USS Constitution, designed by Tom Gorsuch.

## Clarifying The Kennedy Center's Position On Sober House Siting

Dear Gloria,
I am writing to correct a misinterpretation of the Kennedy Center's position on the siting of the proposed Sober House as reported in the April 16 edition of the Patriot. The article reporting on the April 7 meeting of the Charlestown Neighborhood Council stated that "the Kennedy Center's Head Start Program . . . agreed that siting a Sober House at the proposed location would not conflict with" the program. This is not completely correct. What was stated at the meeting was that representatives of the Sober House project had spoken with former employees of the Head Start program. In fact, the Kennedy Center Board of Directors voted to support the concept of a Sober House but not to support any siting until the public process allowed Head Start parents and other abutters to discuss the proposed project.

The Kennedy Center Board and staff very much appreciate the need for sober living arrangements for recovering people. We, however, would not support any siting without hearing the public debate. The voices of the parents who send their children to our program will influence the Kennedy Center's position on the siting.
