Voke And Birmingham Call For MDC Investigation Of Accident

In response to the weekend accident on the Gilmore Bridge that left a Charlestown woman hospitalized, Rep. Richard Voke and Sen. Thomas Birmingham have called upon the Metropolitan District Commission to make a full-scale investigation of the incident. The Gilmore Bridge comes under MDC roadway jurisdiction.

"We need to know what happened that day so we can make sure such a tragedy never happens again," stressed Birmingham. "If, through their comprehensive review of the accident

scene, the MDC can discover some way to improve public safety, we owe it to all of Charlestown to implement such improvements immediately," added Voke.

Although the driver of the truck involved in jumping the sidewalk and striking Mary Carr was cited for operating to endanger and 31 other violations, both Voke and Birmingham said that investigators have to look past the negligence of the truck driver for other possible contributing factors.

"If roadway conditions, ongoing reconstruction

work, improperly operating lights, inadequate signs or other factors played a part in this unfortunate incident, the problems need to be identified and fixed," stressed Voke. "When we say we never want something like this to happen again, we must make sure the whole picture is thoroughly reviewed and remedial actions are taken forthwith," Birmingham stated.

Although no investigation completion date has been confirmed by the MDC, both Voke and Birmingham pledged to stay committed to this review.

Catholic School Study Recommends Parish School Consolidation

When news hit the streets on Tuesday that Cardinal Bernard Law had recommended consolidation of the two parish parochial schools in Charlestown based on a two-year Catholic school study, school faculty and parents were in a state of disbelief. Both St. Francis de Sales and St. Catherine schools were inundated with telephone calls from distraught families searching for information that the schools were not prepared to answer.

The report on the two-year study from Catholic University was delivered to the parishes on Monday with a note informing the

pastors not to discuss the report until after the Cardinal held a press conference on Tuesday. This was an easy mandate to follow due to the fact that detailed information on the report's consolidation plan was not included in the volume. Compounding the difficult situation placed upon both parishes was a pre-press conference news article in one of Boston's daily newspapers that was soon carried by every radio station within hearing distance.

Perplexed pastors and school administrators were hesitant to advise their flock on the possibilities of a school's closure because no information was sent to

them on the issue. They, as a result, were as little informed as were their parishioners.

When the air cleared on Wednesday and a telephone line into the Archdiocesan School Office could be attained, information on the consolidation proposal for St. Catherine and St. Francis de Sales schools was obtained. According to Sister Mary Jude Waters, O.P. from that office, the process of consolidating schools in Charlestown would be lengthy with "no time limit involved." She further stated that "all three parishes in Charlestown would be involved in consultations on a consolidation plan before the archdiocese would become involved."

Sister Mary Jude stated that the recommended consolidation came as a result of declining enrollments in both schools. "We are trying to strengthen our schools and continue to give parents the option of a

CNC Supports Election Committee Action To Seat Galvin As Member

The Charlestown Neighborhood Council took on the task of deciding who would be the winner of the council's Precinct Election for Precinct 3 as the first order of business at the November monthly meeting. The close race between incumbent Bob Wallace and former council member Bill Galvin, giving Galvin the lead by two disputed votes, was challenged by Wallace, bringing the issue to the council to resolve.

Galvin and Wallace were seated in the audience while Kate McDonough, chairperson of the Election Committee, read the committee's report on the Oct. 26 election. In the report, McDonough stated that both candidates had received 77 votes each with four additional ballots being disputed. Two of those ballots were discarded, she stated, one because both names were marked off and the other because no name was marked off. The two votes that ultimately decided the election, she said, also had both candidates' names checked off, but clearly showed that Wallace's name was scratched through indicating that Galvin was the vote getter. One of these ballots included the voter's signature to verify his decision.

The Election Committee, after the ballot count on election day, had met with the observer from the League of Women Voters to listen to her advice on the matter. After hearing that the two disputed votes were, in her estimation, meant to be cast for Galvin, the committee voted unanimously that Galvin had won by the two votes.

McDonough stated that prior to holding the election she had contacted the Mayor's Office of Neighborhood Services on the proper procedure to run the election. She also abided by the guidelines set down by the Council By-Laws, she stated. "We followed all these rules," she said, in explaining the committee's decision to validate Galvin's win.

Wallace expressed his belief that improprieties in election procedures that took place on Oct. 26 should be rectified before the next council election.

The council voted to accept the Election Committee report on the election and unanimously voted to abide by the committee's decision to allow the two disputed votes for Galvin to be counted. This vote cleared the way for Galvin to assume a seat on the council to represent Precinct 3 for the next two years.

Council members who were also seated to represent their precincts at the Nov. 14 meeting were Jeanne Davis, Bob Scalli, Nancy Keyes and Tom Cunha. Ken Stone was appointed to fill the seat as the

North Area Task Force representative following the resignation of Marilyn Darling.

Representatives from Precincts 1 and 4 will be chosen at the December council meeting. Residents who live in these precincts interested in applying for the seats should contact Judy Evers, community liaison for the Mayor's Office of Neighborhood Services, at 725-3485.

CNC members present at the meeting were Chairman Dennis McLaughlin, Vice Chairmen Peter Looney and Tom Cunha, Secretary Jim Mansfield, Treasurer Nancy Keyes, Jim Conway, Marty O'Brien, Bob Scalli, Mel Stillman, McDonough, Dan Kovacevic, Matt O'Neil, Ed Callahan, Kevin Roche, Moe Gillen and Galvin.

Committee reports covered a full gambit of community issues. The council first heard an update on the Central Artery/North Area (CANA) project from Ed Barr, CANA coordinator. He outlined the new traffic pattern through City Square that was instituted last week, and guaranteed the community that adequate police protection would be maintained with the assignment of detail officers to busy intersections. A total of nine officers are currently assigned to the City Square area during rush hours, Barr stated.

Public Safety Committee

The Public Safety Committee will send a letter to Boston Fire Department Commissioner Martin Pierce regarding the cut back in the number of firefighters at Engines 32 and 50 and Ladder 9.

O'Brien stated that one

man per shift has been taken away from Charlestown and sent to other sections of Boston. He stated that a

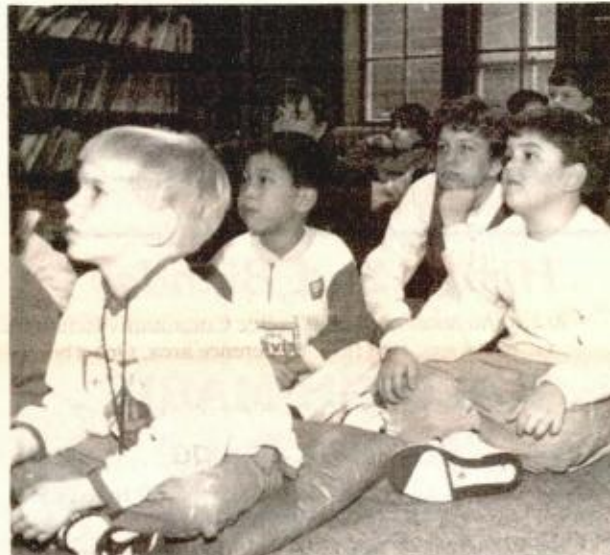
guarantee of full manpower, four men and one officer, was included in the mitigation. (continued on page 18)

Historic Chapter Closes On Gulf War

Another chapter in the annals of Charlestown's rich history closed on Nov. 16 as residents gathered to fulfill a final act in tribute to the community's service men and woman who served their country in Operation Desert Shield/Storm.

With news that the last of

the military with Charlestown ties had finally left the Persian Gulf area, the Charlestown Welcome Home Committee took on the task of taking down the yellow ribbons that had been placed on the street poles along the Bunker Hill Day Parade route as a symbol of support and greeting to those who were able to

"come home" for the annual holiday celebration.

The Welcome Home Committee, with the full support of the community, organized efforts to transmit messages of encouragement to the service people starting with the first news that a Charlestown man was sent to the Gulf. Over the past 15 months, a total of 32 military personnel were recipients of these good wishes through a prayer service, a march from the Bunker Hill Park to the Bunker Hill Monument, gift packages at Christmas and Easter, specially designed greetings cards for every holiday with thousands of signatures from Charlestown residents, along with untold numbers of letters and cards from individuals and families.

Donations came from various individuals and organizations to finance the cost of the committee's activi-

ties, but the bulk of the expenses were taken care of by Bunker Hill Post No. 26, the American Legion. The Legion paid for items to supplement those donated for the boxes and the mailing of the gift packages, greeting cards and a weekly copy of the **Patriot** to each service man and woman. They also provided the luncheon for the committee on Saturday, following the removal of the ribbons.

The culmination of the committee's efforts in support of the troops took place during Bunker Hill Day activities the weekend of June 14-16. Servicemen who were able to "come home" were treated to an array of activities, including a laser-light show in the Charlestown Navy Yard, a portion of which spelled out the name, rank and branch of service of each of the 32 local service people; a con-

cert by the Mummer's Band from Philadelphia at the Bunker Hill Monument; and joining the line of march in the annual parade. Tributes were paid and gifts bestowed on the servicemen at the American Legion's Nite Before Banquet and at the Bunker Hill Associates Annual Breakfast.

The yellow ribbons were attached to the street poles to indicate the community's unified support of the service men and woman. That support was evidenced by the enormous yellow ribbon that was wrapped around the Bunker Hill Monument and tied in a bow.

Among the committee members who were able to report to duty for the removal of the yellow ribbons last Saturday were: Gloria Conway and Kathy Giordano, co-chairladies; Peter Looney, Moe Gillen, Tom Cunha, Mel Stillman, Judy Evers, Florence Johnson,

Kay Whelan, Claire Lynch, Pat Harty, Natalie Rizzo, and Ralph Rizzo, Elaine McCarthy, Judie Dunphy, Mary MacInnes, Marty O'Brien, Dorothy Scott, Jim Conway, Paul Allen, Rev. Ronald Coyne, Alison Cunha, Shannon Smith, Matthew Ezekiel, Shawna Dole, Jennifer Ray, Arthur Cameron and Janell Jones. The Village Market on Main Street supplied a truck to help transport volunteers and equipment.

The closing of this chapter leads to jubilation in that none of Charlestown's service men or woman were injured seriously during the Persian Gulf War. All have returned to their regular duties in their military or civilian lives.

Once again, the true spirit of this community came forth with the caring and support of its sons and daughters who were called to war.

★ Residents Beware — There was an attempted abduction of a Charlestown teen on Monday, Nov. 18, shortly after 10 p.m. According to the Boston Police report, a man described as in his 30s, medium build, with dark blond long hair chased the girl and tried to grab her while she was in the vicinity of 320 Main St., but her screams scared him away and alerted area residents.

He reportedly ran to a pick-up truck which was parked in the rear of the building. The police spokesperson said that neighbors chased the vehicle down Main Street, losing it at Sullivan Square. The pick-up was described as gray in color and dirty, with a king cab and no tailgate.

★ Olive's II — The city of Boston Licensing Board heard testimony on Wednesday, Nov. 20 on a petition by McAvoy's Inc., formerly at 129-131 Chelsea St., to transfer the location and corporation of its licensed business to Olive's Associates Inc. at 10 City Square. The board is expected to make a decision on this petition today, Nov. 21.

The owners of Olive's, a trendy restaurant located at 67 Main St., plan to open another restaurant on the first floor of the Roughan building in City Square. Although the Main Street location has been the recipient of rave reviews in such publications as **Boston Magazine**, residents of homes abutting the site have voiced numerous complaints on the everyday operational practices at the restaurant. These complaints were not mentioned at yesterday's board hearing.

Giving testimony at the hearing were Annette Tecce, president of the Charlestown Business Association, and Harvard Square resident Maria Welling, speaking in favor of the petition. Neighborhood Council Chairman Dennis McLaughlin and member Jim Conway, and Judy Evers, community liaison for the Mayor's Office of Neighborhood Services, requested a postponement.

Tecce presented the board with a letter of support from the Business Association and Welling told the board that she approved of the new location in an abandoned restaurant. She added that City Square would be a safer place with the presence of a proven, well-established restaurant. Welling said that she was not saying that there had not been problems, and she credited the city for resolving them, adding that she wanted to keep the pressure on them. She then submitted a letter in support of Olive's to the board.

McLaughlin informed the board of the concern expressed by members of the Neighborhood Council that public comment had not been heard, noting that there are still issues to be worked out. He asked for a postponement of the board's findings until after the Dec. 3 CNC meeting when the council would reach a decision on the matter.

Conway advised the board that many residents were not made aware of the license transfer. He stated if the board decision is to be made prior to a community hearing, then he must be opposed as there are unaddressed traffic and parking impacts on the

neighborhood.

When Board Chairman Tom Stanton questioned Conway as to his wife's name on the letter of support from the Business Association, Conway rebutted, stating: "Her name is on the letterhead as a board member, but she did not vote on this issue because she was not aware a vote would be taken on Olive's and was not present. There are 125 members of the Business Association who also didn't cast a vote," he stated, concluding, "The membership was not polled."

Evers informed the board: "I have been trying to resolve the problems at the present location (67 Main St.), problems such as garbage, crowd control and public safety. Most of the issues that have been resolved have been through city intervention." She also stated: "Because of the past history, the neighborhood wants some safeguard on the old location before they can support the application for an additional license by the same owners at a new location."

Evers said: "It has been very difficult for the past three years in working with these people (Olivia and Todd English) to get concessions. They have not been good neighbors in the past. We don't feel they'll be good neighbors in the future."

Chairman Stanton concluded the hearing by telling the gathering that he was going to vote in favor of the application, noting that he had heard all good things about Olive's and that it would be quite a change from McAvoy's.

The Basic Services Committee of the CNC will hold a public meeting on Tuesday, Nov. 26 at 7 p.m. at the Charlestown Courthouse at 3 City Square to hear testimony on Olive's petition to open a second restaurant in City Square.

All are welcome to attend.

★ 378 Main St. — At a Nov. 19 hearing the city of Boston Board of Appeals approved a request by Edward and Paula Wiles of 378 Main St. to erect a rear deck on their home.

Representatives of the Boston Redevelopment Authority and the Mayor's Office of Neighborhood Services, along with City Councillors Albert O'Neil and Robert Travaglini, spoke in favor of the appellants' request at the hearing.

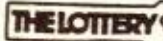

Birmingham And Voke File Bill To Increase Lottery Aid

Legislation recently filed by Sen. Tom Birmingham and Rep. Richard Voke would increase lottery aid to Boston by more than \$20 million a year. The bill would guarantee that each city in Massachusetts receives lottery aid in direct proportion to the amount wagered on the lottery in that city.

Now all profits from the lottery go directly to the

state and are redistributed by two formulas. These formulas result in cities such as Boston receiving less than their fair share of lottery proceeds. The legislation filed by Birmingham and Voke would change the distribution system and require that all cities get back 30 percent of the amount bet on the lottery in that city. This change would more

★ **Bunker Hill Monument**— The National Park Service is in the process of replacing the lightning rod at the summit of the Bunker Hill Monument.

According to a spokesperson for the NPS, the previous lightning rod had snapped off and fell to the ground. The new rod will be positioned adjacent to the remaining portion of the historic rod, which has been on the Monument for many years.

Passersby have been awestruck by the sight of the men positioned at the top of the Monument replacing the rod. Numerous calls have been received at the **Patriot** seeking information on the purpose of the work being done.

★ **Cook Street Playground** — The Boston Parks and Recreation Department held an informational meeting with residents of Cook, Sheafe and Hill streets on the reconstruction of the the playground at that location.

According to James Walsh, regional administrator for the Parks Department, residents expressed their preference for a tot lot for children under 5 and a "passive recreation area" for children 6 to 11. Walsh stated that the park is in two sections and could accommodate these ideas.

A second meeting will be held in early January to further discuss plans for the playground, Walsh added.

(continued from page one) parochial school education," she said.

According to the report, if a school can show that it is fiscally self-sufficient, has an adequate enrollment and demonstrates it provides a quality of academic and religious programs, that school would not close.

At the present time there are 140 students enrolled at St. Francis de Sales School

in first through eighth grade classes. St. Catherine School has 180 students in grades kindergarten through eight.

The consolidation plan proposed for Charlestown mentions an "Inter-Parish" school. This was explained as a facility that would be the equal responsibility of all three parishes, including St. Mary Parish whose school closed in the 1970s. The report does not mention that the "school facility" will be located in one building, leaving the door open for discussion by the parishes that both schools could be used.

Rev. James Canniff, pastor of St. Mary Parish, advised: "Don't believe everything you read and hear until that information comes from your parish." No definite information is expected until after a meeting is held with the pastors, school administrators, faculty, parents and parishioners of all three parishes. This meeting will not take place until more detailed information is distributed from the Catholic School Office to the schools on the proposed consolidation plan.

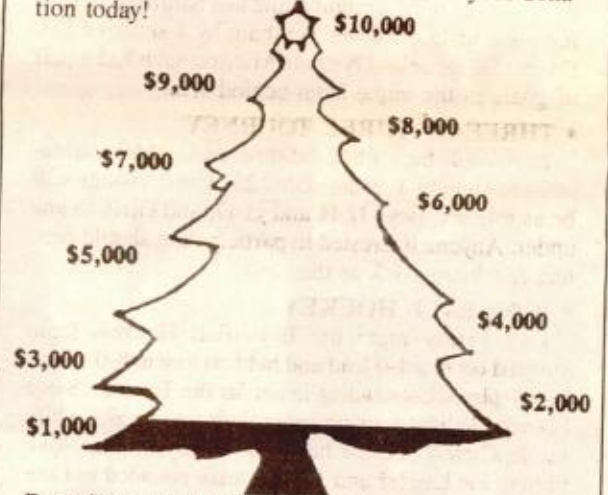

than double the amount of aid that Boston receives.

Voke commented: "The current system for distributing lottery profits is just not fair. The people of Boston consistently spend more money on the lottery than people in other cities, but the difference is not reflected in the lottery aid we receive."

Explaining the bill, Birmingham said: "The people of Charlestown are consistently denied their fair share of lottery aid. Right now rich suburbs get 40 and 50 percent of the amount their people spend on lottery tickets while the city of Boston gets less than 20 percent. This system should be changed, as a matter of simple economic justice."

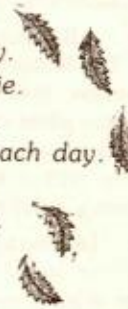

tion process with the community as part of the CANA project. The committee will request a meeting with Pierce to discuss the issue.

Basic Services Committee

The Basic Services Committee worked with residents of the Washington and Union streets and Old Rutherford Avenue area and members of the Charlestown Youth Hockey Association (CYHA) to come to an agreement on parking problems on that portion of Old Rutherford Avenue adjacent to the MDC Skating Rink.

Neighbors and the

CYHA were in agreement that the dead-end portion of the avenue be used for 26 angle parking spaces posted for a two-hour parking limit during the day. The Boston Redevelopment Authority (BRA), owners of the parcel, is in agreement with the community to turn the parcel over to the Boston Public Works Department. This action would allow the BPWD to maintain the parcel and also give the Boston Police Department authority to enforce parking regulations. The CNC voted unanimously to request the BRA to transfer ownership of the parcel to the BPWD.

Development Committee

The Development Committee will hold a meeting with abutters of the Municipal Building at Bunker Hill, Lexington and Ferrin streets before the scheduled demolition of the structure to address issues relative to the process such as extermination, parking and safety matters. This meeting will be announced in the **Patriot**.

The committee will also conduct a public hearing on the development of Building 104 in the Charlestown Navy Yard, as requested by area residents. Committee Chairman Cunha requested that the BRA prepare an update on the development proposal and establish a date that the developer, Bricklayers and Laborers Charlestown Non-Profit Development Corp., could

come before the committee to discuss the plans for 43 units of elderly housing and 30 parking spaces in Building 104. This meeting will also be announced in the **Patriot**.

New England Aquarium

The CNC discussed the news that the New England Aquarium had decided to investigate options to expand at their current Central Wharf location rather than move into the Charlestown Navy Yard. McLaughlin stated that the proposal for a new facility for the aquarium on Pier 11, Dry Dock 5 in the Navy Yard is not completely out of the question. He said that the city and BRA are looking into available options that might provide the financial resources needed to build a new facility that the aquari-

um officials feel it is losing in the sale of their present location in today's real estate market.

McLaughlin added that the city and BRA will look at all options over the next six months and come back to the community with an update on the proposal at that time.

Basic Services-Public Safety Committees

The Basic Services and Public Safety Committees will co-chair a meeting with residents of Old Rutherford Avenue and Washington Street to discuss safety concerns relative to the removal of barriers that were installed across Old Rutherford Avenue as part of the CANA project. No date has yet to be set for this meeting which will be announc-

ed in the **Patriot**.

After the meeting, Roche requested that residents be advised that the city of Boston Assessing Department has established new property assessments resulting from the Fiscal year 1992 revaluation. Representatives from the Assessing Department will be at the Charlestown Branch Library, 179 Main St., today, Nov. 21 until 8 p.m., and tomorrow, Nov. 22 from 12:30 to 5 p.m. to discuss the new revaluation of Charlestown property. For more information on the revaluation and increased tax rate, property owners can call 635-3409, Roche stated.

The next scheduled monthly meeting of the CNC will be on Tuesday, Dec. 3.

Action Must Be Taken To Protect The Safety Of Charlestown Residents

Dear Majority Leader Voke:

I am writing concerning a situation that I witnessed on Saturday, Nov. 16 on the Prison Point Bridge (Gilmore Bridge). My wife Alice and I had errands to run that required us to cross over toward Cambridge. As we approached the bridge from Austin Street, a large 18-wheel tank truck was across the intersection attempting to do a U-turn. The westbound side of the bridge was closed for repair, the lights were blinking yellow and the eastbound side of the bridge was arranged into one lane in each direction. The tank truck could not make the turn it was attempting. In the process of attempting the turn it went up onto the sidewalk and also ran over a few of the large orange barrels, one of which

was crushed like an eggshell. The general condition of the intersection was total chaos. Traffic was entering the intersection from Rutherford Avenue from both the northbound side and the southbound side with no knowledge that one side of the bridge was closed until they were into the intersection. Many of the trucks were too big to make any turns out of the intersection once they realized the westbound side of the bridge was closed.

No police were on the scene directing traffic — it was a very dangerous situation. I commented to Alice that someone was going to get killed here today. As we proceeded over the bridge, we noticed an MDC police car parked opposite the subway station on the bridge with two MDC policemen inside. I was shocked that the policemen could sit in their car with all of the chaos a few feet behind them. When we returned later in the afternoon, we passed the same police car with two policemen still sitting in the car.

On Sunday, we read in the *Globe* that a Charlestown woman was run over at that intersection by a truck. This apparently happened between our trips over the bridge. My questions are: *Why were the intersection lights not operating without the police directing traffic?* and *Why were the police that were on detail sitting in the car when they should have been directing traffic and preventing accidents?* The MDC police were not doing their job, and should be held responsible for the "accident." The actions of the MDC police should be investigated as to whether they should be held responsible.

The MDC has acted irresponsibly toward the Charlestown community. They have been closing the Gilmore Bridge without notice on weekends for repairs. This cuts access to Charlestown for emergency vehicles, and it also greatly inconveniences Charlestown residents. They have also failed miserably in directing the traffic while repairs were being conducted on the bridge.

The intersection of Austin Street, Rutherford Avenue and the Gilmore Bridge is a major pedestrian route to the subway station. Commuters fly through this intersection with little regard for pedestrians. We have had too many deaths in this town from pedestrian accidents, action must be taken before additional Charlestown residents are injured or killed.
