Intro

What is the Covid-19 pandemic? It's a pseudo-reality imposed on the global population, created by an organized group of conspirators. It's a medical-themed, global version of the Sandy Hook Hoax. There, that's it. If you understand the Sandy Hook Hoax you understand the Covid-19 Hoax. Because it's the same players, using the same methods of deception. They rebranded the common annual flu as Covid-19, they use a procedure in a manipulative manner (high-cycle-number PCR-Procedure / Covid-Test) which doesn't test for a new virus but dead genetic material, and the rest is pure psychological warfare executed by the global NWO system which is controlled in the leadership positions by non-humans.

It is a hoax, the primary reason why it works is that people do not know that there is a coordinated network of predators among them that has evil intentions and uses sophisticated methods of deception to pursue those intentions. And the main reason why they do not realize this is because they largely lack the ability to realize the existence of evil and its nature. The secondary reason is that people think and live in a lower paradigm created by the predators, which makes it very difficult for them to realize the higher paradigm from whose level they are manipulated.

An Imperceptible Enemy

In war, there is normally an enemy to be identified. He wears the uniform of an army, waves the flag of a nation, uses certain colors, etc. The enemy we are facing today does not wear a uniform, he looks like everyone else. The battlefield is not a localized area, but the entire planet, or the institutions of civilization, which have been infiltrated by the enemy to the highest level.

Lack Of The Knowledge Of Evil

Most people are not familiar with the nature of evil, knowing it only in the form of fictional characters in movies. Some know about serial killers from media hearsay or book reading, but they believe that these are absolutely exceptional cases with rare mental disorders and that the chance of ever meeting someone like this in their lives is extremely low. They do not expect to find such people in large numbers in high societal, functional positions like their prime minister or chief of health department, etc. In addition, many have a fundamentally false idea of evil, believing it to be mostly obviously identifiable, based on openly malicious, aggressive behavior and grimaces and yelling. The type of charming, deceptive psychopath is known to few who are interested in the topic, but is not well understood.

Most are not familiar with evil organized in networks, which acts out of malice. But this very form of evil is at work on Earth, and it has accumulated such power that it affects the lives of billions of individuals. The face mask is an expression of this.

The Veil Of Oblivion Of The Black Magicians

The majority of people are unaware or only subconsciously aware of the satanic bloodlines and their powerful dynasties and the negative alien/interdimensional groups in the hierarchy above them. But even researchers, who are aware of their existence and influence, seldom apply this knowledge in their considerations and models to the necessary extent. The result is world views and explanatory models that do not sufficiently take into account the existence and workings of those groups, in favor of more mundane, official explanations. It is as if man is not fully capable of realizing the existence and workings of the organized dark forces, as if it constantly escapes him. It is artificial cognitive dissonance, on worldly level the conflict between official corrupt version of the system (governments/institutions/experts) and a more objective alternative version and on occult level the struggle between the morphogenetic energy fields of negativity (ignorance, deception, lies) and positivity (enlightenment, truth, knowledge).

The dark dynasties/organizations in the world have extensive power and their numbers range from tens of thousands to millions of individuals, depending on the source. Enough to, given a determined intention to infiltrate, have an extensive influence on global governments, media organizations and institutions. As the saying goes, "They are everywhere." Well, not everywhere, that is an exaggerated self-aggrandizement to inflate their relevance and to present themselves as more numerous and powerful than they are, but in the governments and institutions, in the power centers, they are indeed very numerous. And they do pull enough strings to manipulate nations into wars and to stage a global pandemic hoax.

The 'Incomprehensible Complexity' Deception

The larger a system, the simpler it must be, because otherwise it would collapse under the weight of its complexity. The more complicated, the more energy, the more resources, the more personnel needed to operate it. A global system must be very straightforward in order to function economically. The disadvantage of this simplicity is that it makes the system very easy to detect. Therefore, countermeasures must be taken to make this simplicity harder to recognize. You have to get the population to focus on the trees so they don't see the forest. This is achieved e.g. by a focus in education on training the left brain hemisphere (thinking in details) and neglecting and atrophying the right (which recognizes larger contexts) and increasing specialization of science and by suppressing interdisciplinary communication between the fields. Someone who recognizes the simple global system is called a simpleton because he thinks too simply and believes to recognize patterns in the chaos, believes there are simple answers in completely incomprehensible complexity. This is how the system protects itself from discovery.

Paradigm-Program Mind Prisons In Science

Science is considered a synonym, an umbrella term for objective assessment of observable or measurable phenomena. In practice, however, it is a set of narrow concepts that consistently ignore objective observations in favor of prevailing paradigms. Evidence for theories is deliberately denied and obscured because what cannot be cannot be. This is done in all sciences. From (quantum) physics over biology to psychology. An example from psychology. There is a rule not to ever be challenged that patients who report hearing voices must be immediately medicated with anti-psychotic drugs. No attempt should ever be made to systematically examine the voice phenomenon for meaningful patterns, on the grounds that this would legitimize and potentially reinforce the patient's "hallucinations". In the technological age where, for example, Google-Glass, inaudible to the outside listener, sends sounds directly by frequency to the hearing of the wearer of the glasses, and various other "voice-to-skull" frequency technologies exist, this is unscientific and pure ignorance. The phenomenon of entities has also been known for millennia from all cultures, but it is never investigated objectively in the public scientific community due to (NWO system established) dogmas.

These highly constrained paradigm prisons do not arise by chance, they are the product of psychological and spiritual engineering controlled and maintained by strategically placed gatekeepers. On a spiritual/astral level, the paradigm prisons are stabilized by organized interdimensional entities (the voices some people perceive). By mental influence and harassment of disruptive individuals. On the worldly level, governments, institutes, financiers and "experts" take over this task.

Sciencism-Cult Gobbledygook

Science is predestined to disguise the true nature of deceptive agendas by means of so-called higher education and reputation of high competence or alleged accomplishment or even intellectual brilliance and the concept of incomprehensible complexity. On the one hand, "science" is dominated by the NWO-system and has a propaganda-based reputation of intellectual grandeur and sanctity, a quasi-religious status; on the other hand, it is difficult for lay people and even largely specialized experts to see through a false scientific narrative if it's supported by several alleged experts.

The Covid-sciencism high-priests, from an objective point of view, talk nothing but scientific-sounding bullshit to disguise their true intentions. They are not accidentally wrong on one point or another, they are not slightly inaccurate, they are not ideologically misguided about a few details, they talk complete bullshit that makes no rational sense whatsoever. What isn't questioned with courage by the scientific community because of these individuals' high reputational status in that scientific community.

The sciencism high priests are colluding corrupt deceivers, all the others more or less emulate them because they are the high priests and questioning their judgment is perceived to be in scientific vain or professional and societal suicide as it could cost one the reputation and career.

Misconceptions About The Maturity And Professionalism Of Scientists

Most people have very stereotypical false ideas about the maturity level of individuals with a supposedly high education level. Humanity is highly diverse in the area of personalities. Even with the same prerequisites in intelligence and education, the differences between individuals are sometimes enormous. Scientists are said to have qualities such as rationality, mental depth, mental agility. Some do, but largely that's a stereotype, as most of them are dependent thinkers, imitators, well-behaved careerists, systems people, who would never challenge prevailing thought structures, habits, scientific pillars, let alone question them at all. Either because they fear for their reputation and career if they would stick their head out, or because of blind trust in established systems, or because they simply don't have what it takes intellectually as they earned their degree largely via memorizing.

In the history of science, every revolutionary break-through in understanding was viciously rejected and fought until eventually accepted as obvious. Humans in general don't like change, dependent humans like change even less, and ideologically invested humans like change the least. And "Science" is full of those. Nowadays, many scientists in addition lack overview because they are highly specialized (subject idiots) whose interdisciplinary understanding is often nonexistent.

Many are in it for the high payment, the societal reputation, the prestige of awards, mainly egoic reasons. Most academics are hopelessly naïve about the nature and workings of financial interest groups in their field, resulting in blind trust in the pharma industry and research institutes. And just like everyone else, most can't grasp the nature of evil. Scientists are just as human as everyone else and susceptible to emotional view, thinking errors, naivety and completely unquestioning authority obedience, living in survival mode full of fears. White coats, academic degrees and an aloof appearance should not obscure this fact.

A minority is not duped by the Covid-hoax, or rather courageous enough to speak up. There are networks forming of scientists, doctors, lawyers, mathematicians, that came to the conclusion (to varying degrees of realization) that the whole thing is a hoax. Not a political overreaction but outright fabricated illusion, based on definition, calibration, concealment, tactical exaggeration, flawed theoretical models, false reporting, falsified images, video manipulation, etc.

The Matrix Mind Maze

Trying to understand the matrix through a left-brain centered academic approach is difficult because of all the narrow-minded prison paradigms, the never-ending added flood of corrupt details, the constantly newly constructed intellectual dead ends, the fundamentally wrong ways of thinking, the focus on details rather than the big picture, etc. By studying individual areas of a car in detail, for example, it takes a very long time to understand the car as a whole. It is similar with the matrix. Think in big contexts, look at the system from above, from the outside, always change to the next higher level, analyze from the meta level, approach it holistically, think with your right-brain hemisphere.

Conspiratorial Meta-Analysis

Who has insight into higher processes within a system, understands in principle all processes on lower level, also without having complete understanding, detailed knowledge in the lower processes.

- 1. Preparation of conditions needed later, for the hoax, taking place long before. In the case of the "pandemic" to conceal the non-existence of a new virus, or to make it difficult to distinguish it from already existing viruses or other genetic material. This is done, for example, by changing the reporting systems for influenza data so that influenza cases can easily be renamed to Covid-19 without any statistical difference being easily detectable.
- 2. Pre-programming. Preparing the subconscious of the population for the later to reduce resistance and to manifest it physically as dark siders have no creative spark and depend on creator beings to manifest realities. Movies and series about disease outbreak and the need for government suppression measures such as police state and military on the streets. For example, the Netflix series "Utopia".
- 3. Hive activity. Many members/organizations of the satanic hive are known and their activities can be observed and clear conclusions can be drawn from them. Where a real event takes place, the hive can be content to distort the facts; where a propagated event does not take place, the hive must create facts where there are none. For example, through manipulative interviews with experts of the situation from which information is cut that casts doubt on the narrative, while the remaining information is presented manipulatively to support the narrative. If this is done systematically, it is done to create the appearance of an event, not just to exaggerate the threat level of a real event.
- 4. Occult hints. These are given out by the hive to obtain metaphysical reassurance that they have no karmic consequences to face for their crimes. When these appear, it is always proven that the Hive is behind the particular incident to which these occult hints relate. From the nature of the clues it can also be deduced which of the elements of the incident are real or fictitious.

Is Corona/Sars-CoV-2/Covid-19 A Real/New Virus?

The official distinction of terms:

Corona Viruses: Supposedly viruses that cause colds or flu infections (rarely conjunctivitis, otitis media) in humans.

Sars-CoV-1: Severe acute respiratory syndrome – CoronaVirus - 1

Sars-CoV-2: Severe acute respiratory syndrome - CoronaVirus - 2

Covid-19: Allegedly the disease caused by SARS-CoV-2. Officially 'CO' stands for Corona, 'VI' for Virus, and 'D' for Disease, 19 stands for 2019, the year it allegedly appeared. (unofficially it stands for Corona Vaccination ID)

Official Sars-CoV-2-Lethality: According to a 61 studies including meta study by Stanford professor John Ioannidis, Covid-19 (caused by Sars-CoV-2) has a mortality rate of 0.25 %, or 2.5 deaths per 1000 infected.

Even if Sars-CoV-2 would exist and indeed cause the disease Covid-19, the mortality rate would be similar to any seasonal flu and wouldn't justify any state implemented measures.

But based on the results of the higher paradigm conspiratorial meta-analysis, we already know that the pandemic is an "elite"-produced hoax because all 4 above mentioned preconditions are fulfilled. Hoaxes usually have elements that have a real basis, but are full of lies, with highly corrupted interpretations, distorted perspectives, elements of pure falsehood.

So, the questions are, is Sars-CoV-2 a new virus with low mortality rate, or does it even exist? To draw a comparison to another hoax, is Sars-CoV-2/Covid-19 the children of Sandy Hook, which exist (but did not die), or is Sars-CoV-2/Covid-19 the dead children (which do not exist, since no children died there)?

Applying this principle to the virus hoax: Is Sars-CoV-2 a real virus whose dangerousness is exaggerated, or is it a hoax that exists only in deliberately flawed theory and falsification?

If Covid-19 is an actual existing novel virus, it must have either arisen naturally (official version / Chinese wet markets) or been artificially engineered.

Natural Occurance

Virus transmissions from animal to human may occur naturally, but for the timing of such a transmission to happen coincidentally in the exact time window of the NWO agenda and with exactly the kind of characteristics needed for the agenda is ridiculous. Wet markets bat-soup? A contrived explanation from a Truman Show script. NWO-Truman Show episodes are staged by means of detailed script, precise timing and planned course, they do not happen due to random circumstances.

Bio-Weapon Theory

The idea that Covid-19 is a bioweapon released by the elite is absurd because it is not consistent with the nature or methods of the elite.

- 1. A virus is the personification of threatening unpredictability. Viruses mutate and it is impossible to reliably predict when, how and to what extent this will happen. The mentality of the elite is severe neurotic OCD and absolute obsession with control. A radical contrast. It is against the nature of the elite to use a virus as a weapon.
- 2. In addition to an intrinsic aversion, a virus release is not strategically pragmatic because the incalculable danger could jeopardize the power structure of the elite, which currently still consists of many people and their relatives (before they are replaced by hybrids who may have higher immunity) and therefore jeopardizes the agenda.
- 3. Metaphysical laws force the elite to take every step with extreme caution and to treat each case individually. The use of bioweapons would have an incalculable impact on the entire collective of the population and it is impossible to predict how it will affect individuals due to the nature of a virus. The complexity of such a process overwhelms the elite's ability to micro-control. Weapons of mass destruction which have any influence on a collective are only allowed when a collective has reached maximum resonance with the dark planes (Sodom & Gomorrah), this is currently not the case.
- 4. The elite seek to avoid ABC weapons because of the potential harm to themselves or the environment and the severity or unpredictability of the effects. Their primary preference in warfare against humanity are a combination of psychological warfare (Covid-19 illusion), political warfare (police state, military on streets, curfews, vaccination passport, food-control) and EMF weapon systems (Wifi, 5G, RFID chip). Through these, infrastructure and wildlife are left undamaged while humans die.

Conclusion

The pandemic is largely an illusion, the only real element of which are the common flu viruses, the diseases caused by them and their symptoms. This is disguised by transferring all the characteristics of the flu to Covid-19 through system manipulation. The "novel Sars-CoV-2 Virus" and the disease and symptoms it causes are pure theoretical fabrications, lies. Also real is the fear of the people which is exploited by psychological methods. A realization which is not surprising because, after all, this is the age of the great deception, not the age of the great bioweapons release.

The reason the "experts" can even determine a mortality rate of a non-existent virus is that they are falsely examining renamed other data instead. It's a mixture of real but systematically distorted flu data and made-up numbers which are statistically adjusted – a product of confusion within a matrix designed paradigm implemented by the satanic/alien hive. The images that supposedly exist of the "virus" are computer-modeled or other genetic elements that are manipulatively mislabeled. The genuine scientists are victims of information and perception warfare against them that they do not anticipate.

The Statistical Impossibility Of The Existence Of A Real Pandemic

You hear over and over again from genuine people that they don't know anyone who has had "Covid" and they don't know anyone who does. A global pattern. Which makes it simply impossible for there to be a pandemic. Whenever that is mentioned, immediately comments appear that one knows at least 20 who had it and who had the most brutal symptoms, some even died from it. These are always only reactive comments which only appear when someone questions the pandemic, i.e. they seem to be an A.I. mechanism which must first be triggered in order to be activated.

Apparent Contradiction Between Population Reduction And Metaphysical Laws

The objection when mentioning metaphysical laws is how they will reduce the population if they are not allowed to kill people directly. By deception! It is not the problem propagated by them which causes the population reduction, it is the solution propagated by them! They deceive the people into believing that a new particularly infectious and deadly virus exists in order to persuade them to be "vaccinated" against it. The vaccination leads to an allergy against already existing viruses which makes the illnesses caused by these viruses significantly more severe in their course. Therefore it needs then further "vaccinations". With every further vaccination people become more susceptible to disease, weaker, sicker. The disease propagated by them does not exist, or its dangerousness is massively exaggerated. The vaccination is the disease!

A Brief Moment Of Great Opportunity For All Conspiracy Educators

The NWO is now out in the open for everyone to see. Chaotic conditions prevail. This is an ideal opportunity to supply the people with information. Now they are particularly receptive. They must be provided with information now, before they get used to the new state (the new normality).

Special attention should therefore first be paid to those directly affected by the agenda, among whom one finds the most attentive listeners and strongest allies.

The Energy Information War

The system is increasingly disrupting communication between people. Online through the monopolization of platforms for the exchange of opinions and the increasing censorship of these. In real life, by means of the "pandemic" justified restrictions on the radius of movement, the duration of movement, social distancing and even speech in public transport. Information is more than only by written word or sound conveyed information, it is transferred also by electro-magnetic interaction and energetic aura fields (quantum exchange) between humans, therefore the NWO wants to enforce a distance law, so that humans do not come closer, embrace, give hands, and exchange thereby information packages in energy form.

One should consider therefore humans always as energy transmitters and receivers which even if verbally and in writing passively, nevertheless alone by their presence can pass on information. Therefore, information campaigns should focus on those people who have a lot of direct contact with other people.

- 1. Local Internet activism. Most people limit themselves to maintaining a channel or website where they upload their information. However, in times of increasing censorship, this is no longer sufficient.
- 2. Supraregional Internet activism. Everyone should start writing directly to other people. Create email lists. Communicate directly with other opinion makers.
- 3. Local real-world activism. Online video viewership is generated by viewers from all over the world. So, 10,000 views may sound like a lot, but these come from people scattered sporadically all over the world of which most sit alone at home and don't get politically active. In addition, who knows how many of the views and thumbs up and even comments are actually from real people and how many are purely digitally produced to create the illusion of high viewing numbers and support in order to pacify activists and deceive them into the false believe of having an impact on public opinion.
- In real life, we need to establish communities, create lie-free/entity-influence free zones, and build Gallic resistance villages by establishing local network structures. If the mask law falls in just one supermarket due to a highly alert and mask law-disregarding local population, the next supermarket in the next neighborhood is soon to follow.
- 4. Supraregional real world activism. In addition to local networks, one should also engage in the wider world to connect communities with each other.

In summary, the internet is still a medium for activism, but should increasingly become of secondary importance in favor of real-life activism. Although it is inferior in number (how many can be reached), it is much more potent because direct communication (also in the form of anonymously distributed leaflets) is way more personal and engaging than an online video or a commentary. In addition, it is important to create NWO-lie-free zones to secure the local infrastructure and establish a real-life resistance movement in the immediate area. This will be important later if war breaks out and/or an invasion takes place. The internet is a digital, abstract mental space in cables or radio waves. No bread is baked there, no traffic controls take place there, no water is purified there, no people are born there, only an imitation of life takes place there.

Does such activism make a difference? Yes, of course. If it did not, those who can answer this question with the most profound scientific knowledge available - the "elite" - would not try to stop such activism. They know it works, so they try to convince people that it does not, to prevent them from getting active. So, get active!

Methods

Email: Collect Emails. On Youtube you find them in the 'About' section of a channel for example. Just write an email with "Hey, here is some information, check it out if you like", PDF added.

Throw sheets/flyers: With a cheap black and white laser printer + cheap ink toner without brand + toner saving eco fonts + toner saving eco mode + duplex double page print + cheap paper, you can print thousands of throw sheets for very little money. Place them at highly frequented spots or put them in mail boxes.

Stickers: You can order them with customized motive or create them yourself with cheap prints and simply spray glue. Graffiti: In highly frequented areas, where trains, cars pass by. Don't spray on privately owned houses of civilians though, that creates hostility against the message.

Color pencils/chalk: On signs, pedestrian walks, etc.
