Awards Ceremony To Be Held On Law Day At The Charlestown District Court

In conjunction with the Charlestown District Court's Law Day celebration on Thursday, May 7, the Charlestown Historic Court House Charitable Trust, an organization of Charlestown's Community leaders, will host an awards ceremony at the courthouse and will announce a community-wide effort to restore three historic paintings hanging at the courthouse. The Charlestown Court is the site of the first Court in North America, Aug. 23, 1630,

The ceremony and announcement will be held at the Charlestown District Court, Two City Square at 4 p.m., following the court's annual mock trial competition which starts at 2 p.m. and involves two teams of students in grades 6 through 12. Awards will be given to the winners of the mock trial

The 19th century oil paintings of George Washington, Daniel Webster and Andrew Jackson, currently on display in the Charlestown District Court, are historically significant to the Charlestown community, and each represents important works of art. The painting of George Washington, given by the citizens of Charlestown in 1858, is by artist James Frothingham, a Charlestown native. Andrew Jackson is painted by John Vanderlyn in 1855. The Daniel Webster, depicting the dedication of the Bunker Hill Monument, was painted by John Pope in 1853 and is considered to be his

most important and most famous work.

To encourage community involvement and participation in the restoration project, the Charlestown Historic Trust will sponsor an essay contest for Charlestown students in categories for grades 6 through 12 with a fall '98 fund-raising effort. Students may select any one of the art works and explain how the American leader contributed to the freedoms that citizens enjoy today. Winners will be selected in the fall at an event to be determined.

The Charlestown District Court holds a Law Day observance each year at the beginning of May to remind citizens of the importance of their legal heritage.

In the end, Modica's team was the better team that day and they won the championship.



The 1998 HOPELINE (635-HOPE), the summer job line for Boston youngsters ages 14 through 17 is now open.





Come Join Us For The Teen Shakespeare Project's First Performance

At 7 p.m. on Friday, May 1, the Charlestown Boys & Girls Club Teen Shakespeare Project will present its first show, *Romeo and Juliet*. All involved in the project are very proud of the work the kids of this community have put into the show. I am also encouraged by the support provided by many adults and parents in the area, without whose help the undertaking would have been difficult, indeed.

The Teen Shakespeare Project sprang from the imaginations of Pat Simpson and Tina Champagne, who had already successfully developed Shakespeare projects at the Warren-Prescott School. The duo contacted Steven Maler, artistic director of the Commonwealth Shakespeare Company which produces free Shakespeare plays each summer on Boston Common, and recruited him to get the project off the ground. Throughout, we have had nothing but positive contributions from Jerry Steimel, Jenny Atkinson, and everyone at the Boys & Girls Club. In addition, Charlestown native Doug MacDonald has worked tirelessly to make this project a reality, offering his time and energy as the coordinator.

A few words about the project itself: as director, my job has been to work with the kids to help them understand the language, texture and meaning of the play and Shake-speare's words so that they may take that understanding and craft it into a physical performance. The director is also responsible for visualizing the world of the play and deciding on a "look" for the performance as a whole. One accomplishes this task by carefully studying the text of the play itself, and by getting to know the performers who will make up the play, assessing their individual strengths and weaknesses. With this in mind, I felt that the outdoor venue of John Harvard Mall would provide the perfect setting for our production. It is atmospheric, roomy and very much has the feel of a central "common" Charlestown area; it is a perfect space for telling the story of kids affected tragically by

the onslaught of adult responsibilities by kids who are nearly the same age in real life.

From the beginning of my involvement with this project, I have felt it to be something very special. I view the project as a journey of the imagination, in which the process of rehearsing, learning about acting, learning about Shakespeare, learning about their own hidden talents and abilities, opens up important secrets to the kids every step of the way. I wanted the actual performance to be less a "nice show," but more a satisfying culmination of months of hard work.

When you come to the performance, you will see that this experience will be dynamic, provocative and enriching for the actors and the audience, allowing freedom for both from the constraints of a traditional proscenium-stage production. Outdoor theater is a crucial art; it harkens back to the ancient religious rituals and seasonal community festivals in which the origins of theater are rooted. Shakespeare himself found delight in the various secular and religious festivals in his local village of Stratford, and he used many of these events and the folk who frequented them as models for characters in his plays.

The play opens on May Day and I hope you will view it as a celebration of life, of children, of the exuberance of young and fresh imaginations. I hope it gives you joy. It

will also be performed at 7 p.m. on Saturday, May 2.

On a personal note, I have had the pleasure of meeting many of you in the Charlestown community, through my friends here and at Motown Night, and I would like to say that I have felt very warmly received by everyone I have encountered. I applaud you for your fine sense of hospitality, and I applaud the actors for their hard work throughout the project. See you at the show!



FLYNN TO BE KEYNOTE SPEAKER

REPORTING REQUIRED ON HOME SALES

Congress recently eased real estate reporting requirements for certain home sales.

Under prior law, a "real estate reporting person" (defined as any deal closer, mortgage lender, or seller's or buyer's agent) was required to file Form 1099-S with the IRS to report all home sales, in addition to supplying the seller with a sales statement. After May 6, 1997, home sales that meet the following requirements are exempt from the general reporting requirements:

 The home is a principal residence, which means that: (1) the home was owned and used as the seller's principal residence for at least two of the five years immediately preceding the sale, (2) the seller has not sold or exchanged another principal residence within the two-year period immediately before the sale (sales before May 7, 1997, don't count), and (3) the home was not used for business or rental purposes by the seller or the seller's spouse after May 6, 1997.

· In addition, the sale must meet one of three dollar limitations: (1) the sale is for no more than \$250,000; (2) the sale is for no more than \$500,000 if the seller is married, and gain on the sale is no more than \$250,000; or (3) the sale is for no more than \$500,000 if the seller is married and will file a joint return with a spouse who also used the home as a principal residence for two out of five years preceding the sale.

Each seller must give the reporting person a written statement certifying that the above tests are met. The reporting person has until January 31 of the year following the sale to obtain this statement and should keep it for four years after the date of the sale. If this certification is obtained and believed to be correct, the reporting person will avoid any potential penalties for not following the general reporting requirements.

A sample certification, approved by the IRS, is available from our office. If you are a real estate agent or other "reporting person" required to obtain this written certification on home sales, call if you'd like a copy.
