## James O'Brien Elected 1985 "Mayor of Charlestown"

On Friday evening, March 1st, at the K. of C. Hall, a capacity crowd was on hand for the announcement of the winner of the Third Annual "Mayor of Charlestown" Contest, sponsored by the Charlestown-To-Charlestown Committee, Inc.

As the Committee members completed tallying the record 6133 "votes", Chairperson Arthur Hurley addressed the audience, introducing the local clergy, elected officials, and dignitaries present. Then, after brief comments by the 1984 Charlestown Rose, Janet Flynn, and 1984 "Mayor of Charlestown", Marty O'Brien, the Charlestown-To-Charlestown Election Committee spokesperson, Peter Looney, stepped to the microphone to announce the results of this year's contest.

The winner, with over 2600 votes, and 1985 "Mayor of Charlestown", is James O'Brien. The traditional "Chain of Office" was bestowed on James by his father and out-going

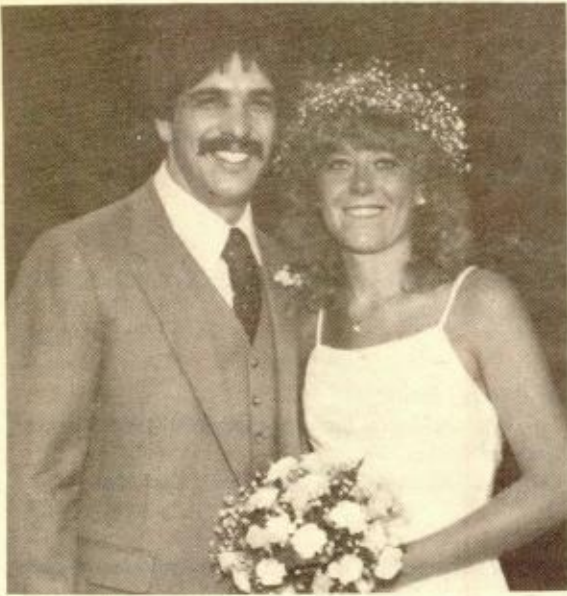

## Legislation Filed To Conduct Public Hearings In The Evening

Boston City Councilor Michael McCormack introduced legislation to the Boston City Council on Wednesday, February 27, 1985 which would require the Boston Licensing Board and the Boston Board of Appeal to conduct public hearings in the evening, rather than during business hours.

"Most people cannot conveniently attend hearings at City Hall during the day," McCormack noted. "It's not fair to expect city residents, no matter how interested they are in any particular zoning appeal or license application, to miss a day's work to participate at a hearing. The home rule petition

I filed is designed to remove obstacles to participation in decisions that can dramatically affect the character of a neighborhood."

In an effort to make attendance at evening city hall hearings as convenient as possible, Councilor McCormack also filed an order calling upon the Mayor to make the City Hall employee parking lot available, free of charge, to residents who attend the hearings.

Presently, the legislation is in the Government Operations Committee of the City Council. McCormack stated he was optimistic that the proposal would be approved

by the Council. Following approval by the City Council, the legislation must be

approved by both branches of the State Legislature and signed by the Governor.

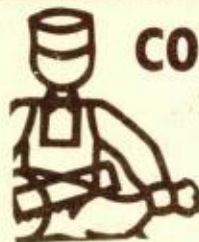

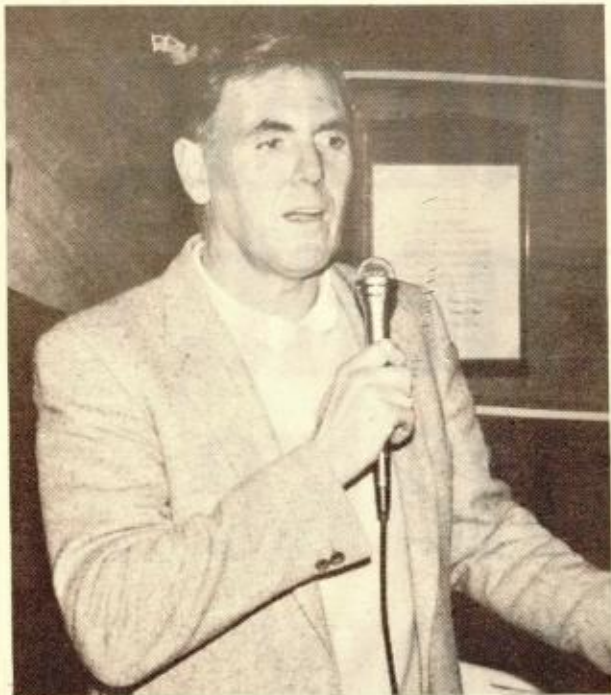

At the conclusion of the dedication ceremonies, a collation was served.



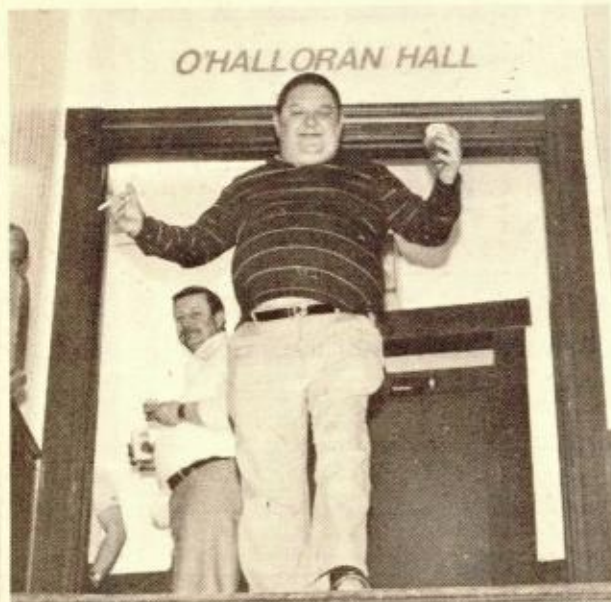

## Portion Of Wall At Hancock Square Work Site Collapses Under High Gusts Of Wind

A combination of wet cement and gusting winds were responsible for a partial collapse of a wall at the Hancock Square Condominiums (the former DaPrato Statuary Building) on Main Street on Wednesday, February 27, 1985.

The bricklayers report that shortly after finishing the back wall of the fourth floor of the building, "a strong gust of wind" caused approximately 200 cinder blocks to fall inward.

According to the developer, Jim Langley, the wall was secured by both metal rods running inside the

cement and wood boards on the outside as braces. Despite the inward falling of the blocks, there was no further damage to the structure reported.

Local criminologist and weather consultant, Robert Lautzenheimer, reported that the winds on the day of the accident were from the nor-

thwest and measured as high as 52 miles an hour.

Langley stated that he was fortunate that there was no further damage other than the wall.

Had the winds been from the opposite direction, there could have been damage to the abutting homes on Main and Essex Streets.

No injuries were reported as a result of the accident.

There are a great many large and small public agencies in the state which play a role in land use and development. The list of these agencies sounds like alphabet soup. They include: EOCD, BRA, NDEA, EDIC, MHFA, MIFA, CEDAC, CDFC, and the CDCs. Some agencies provide technical assistance to neighborhoods and non-profit groups. Other agencies provide funding and a few actively shape the policies and plans that help determine land use in neighborhoods.

EOCD, the Executive Office of Communities and Development, is the state's major land use and development agency. The Secretary who heads the agency, Amy Anthony, is appointed by the Governor. The phone number is 727-7765. It is one of the smallest of the state agencies with only 220 employees. A large portion of its budget of \$118 million is passed through directly to cities and towns, housing developments, neighborhood community action agencies and community development corporations.

The agency has three main divisions. Diane Ortiz is the Assistant Secretary in charge of support for neighborhoods and community action agencies. This division can provide technical assistance and limited financial assistance to neighborhood based community development corporations. They also receive federal CSBG (Community Services Block Grant) money and disperse it to neighborhood organizations.

Joe Flatley is the Assistant Secretary of the housing division. This division used public funds to encourage the development of certain kinds of housing. The "Chapter 667" program builds housing for the elderly. The "Chapter 705" program builds rental housing for families. The "Chapter 689" program builds, or adapts existing housing, for mentally or physically disabled people. The SHARP program (State Housing Assistance for Rental Production) provides a subsidy to

encourage developers to build 25% of their units for low and moderate income renters.

Municipal development is the focus of the third division run by Jerry St. Hilaire. This division offers incentive aid grants

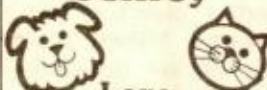

## State Treasurer Crane Seeks To Return \$13 Million In Unclaimed Funds

State Treasurer Robert Q. Crane has released the names of 36,000 persons who are due more than \$13 million from abandoned accounts.

Under the state's Unclaimed Money Law, bank accounts, insurance proceeds, uncashed gift certificates, payroll checks, customer overpayments and the like, that have gone untouched for at least five years are deemed to be abandoned. All such accounts are to be reported to the Treasurer, who then attempts to notify the rightful owners or their heirs. Last year Treasurer Crane returned more than half (\$9 million) of the \$18 million in reported abandoned accounts.

Treasurer Crane said compliance with the law is improving. Nevertheless, the Treasurer said he is not totally satisfied. "It is apparent that less than a sincere effort is being made by some institutions to find the owners. How can anyone fail to locate American Express, Hertz Rental, The New York Times, or Boston English High School?", the Treasurer asked.

Treasurer Crane noted one important aspect of the Unclaimed Money Law which requires that until claimed, all funds are kept in the state's General Fund where they are invested for the benefit of all residents and taxpayers here in Massachusetts.

## Facts About Drugs - F.A.D.

This February, the Division of Drug Rehabilitation issued a report on a survey of secondary schools taken in the Fall of 1984. The results were from 5,078 randomly selected ninth through 12th graders in 67 schools across the state. Responses were also received from 262 seventh and eighth graders.

What were the major findings? Drug and alcohol use is widespread in the ninth through 12th grades and extends to the seventh and eighth graders, also. The frequency of use seems to increase by grade and the most frequently used drugs are alcohol and marijuana. 55% have used alcohol ten or more times. 29% have used marijuana ten or more times and 5% have used cocaine ten or more times. 10% reported using alcohol and 10% reported using pot ten or more times in the month prior to the survey.

With smoking, one out of four (27%) students smoked in the week prior to the study. Among the seventh and eighth graders, 20% used cigarettes in the month prior to the survey.

It seems that males use more heavily than females: 53% of the males and 50% of the females reported use of marijuana; and 20% of the males vs. 16% of the females reported use of cocaine.

There is a higher proportion of whites than non-whites who report frequent use and those who frequently use report lower grades and more "police contacts".

The survey showed that 63% of seventh and eighth grade students have used alcohol, 18% have used inhalants, 7% have used tranquilizers, and 6% cocaine.

What good do all these new figures do? All of us are sure that they do not include our child, or our nieces and nephews. But I would like to propose to you that none of us can be sure, and the future adults that are living in our homes should have parents who are aware and concerned about all children. If it truly is not our kids, it is 60% of their friends. We might encourage our schools to teach drug education and we must attempt to be the role models they need.

## New Exhibit To Open At Charlestown Navy Yard

A new exhibit entitled "Marines in the Frigate Navy, 1794-1834" by Lieutenant Colonel Charles H. Waterhouse will open on March 7th in the Preble Room, Building Five in the Charlestown Navy Yard.

The US Marine Corps Museum in Washington, D.C., and the USS Constitution Museum, with the cooperation of the Boston National Historical Park, the Massachusetts Bay Council of the Navy League of the US, and the World Affairs Council of Boston invite the public to view the 14 major paintings that are painted scenes of Marine activities in the American Revolution, as

part of the Marine Corps' Bicentennial observance.

Painted by Lieutenant Colonel Charles Waterhouse, who served as a combat artist during his career in the armed forces, took 18 months to research and paint this exhibition.

The exhibit will be open daily from 9 a.m. to 5 p.m. through May 31st. Admission is free.

The officers discovered that the vehicle had been reported stolen earlier on this same date.
