### Executive Decree 235/2021

# State Ministry of External Affairs Department of the Diplomatic Cooperation Initiative

Of the 13<sup>th</sup> of May of 2021, by which the diplomatic mission between the United Socialist States of Dherelance and the Workers' Republic of Eothasia is approved.

 $B_{\rm E}$  IT ENACTED by the Councillors of the Workers' Republic, by and with the advice of the State Council of the Republic assembled, and by authority of the democratic institutions of the Republic, as follows:

On this date, the 13<sup>th</sup> of May of the year 2021, the State Ministry of External Affairs is officially authorised, by the powers vested in the Council of Ministers, to pursue, maintain and foment a formal relationship between the Workers' Republic of Eothasia and the United Socialist States of Dherelance.

#### Article 1. Competence.

The Workers' Republic of Eothasia deposits the competence of organising the permanent diplomatic mission to United Socialist States of Dherelance to the State Ministry of External Affairs. This office may delegate its competence into subservient departments as it deems necessary.

## **Article 2.** Delegation of Competence.

The State Ministry of External Affairs delegates the competence of selection of ambassador and maintenance of foreign missions to the Department of the Diplomatic Cooperation Initiative, as per Ordinary Law 47/2012 of the 21st of November.

## Article 3. Diplomatic Mission

- 1. The Diplomatic Cooperation Initiative appoints Honourable Ambassador Efrain Lacasa as representative of the Workers' Republic of Eothasia to United Socialist States of Dherelance. Given the operational unavailability of the diplomatic programme of the United Socialist States of Dherelance, the diplomatic mission of the Workers' Republic shall remain currently in the capital city of Elessia, operating to continue to improve relations between our two countries until an official programme is established and the necessary records processed.
- 2. The State Ministry of External Affairs of the Workers' Republic also recognises the Honourable Francesco Occhini as representative of the United Socialist States of Dherelance to Eothasia and grants full diplomatic immunity in accordance with Organic Law 7/2011, of the 9<sup>th</sup> of November, regarding

International Diplomatic Immunity, and as manifested on the official website of the Diplomatic Cooperation Initiative.

- 3. The Diplomatic Cooperation Initiative appoints diplomatic staff to the permanent mission, which shall consist of: [2] Legal Attaché, [3] Economic & Trade Attaché, [2] Cultural Attaché, [1] Defence Attaché, [1] Charge d'Affaire.
- 4. The Diplomatic Cooperation Initiative appoints administrative staff to the permanent mission, which shall consist of: [5] Personal Secretaries of Ambassador & Diplomatic Staff, [5] Councillor's Staff, [1] Official Embassy Press Spokesperson, [2] Diplomatic Cooperation Initiative Liaison Officers, [4] Medical Staff, [4] Chef & Staff, [10] Other.
- 5. The Diplomatic Cooperation Initiative, in conjunction with the National Security Service, attaches a security detail to the permanent mission, which shall consist of: [10] Ambassadorial Guard. Additional defence equipment will be attached to this security detail and will consist of: [10] 4N2 Cyclone carbine; [10] EPS-1 9x19mm pistol; [10] L1 tasers.

## **Article 4.** International Agreements.

Any and all future agreements agreed upon by diplomatic representatives of United Socialist States of Dherelance and the Workers' Republic of Eothasia must be presented before the Council of Ministers for official approval by an Executive Decree, as determined by Eothasi Law.

#### **Article 5.** Modifications.

The Diplomatic Cooperation Initiative, State Ministry of External Affairs, and Council of Ministers hereby reserve the right to modify and/or terminate this Executive Decree by any means permitted by the Law, if and when it should be deemed necessary or favourable for the Workers' Republic.
