



But Township Administrator Paul J. Shives said Toms River doesn't regulate eruvs, and said legal research conducted by the township indicates "there is no legal basis for municipalities to do so."

An eruv is a visible boundary, often made of wire strung between utility poles, that allows Orthodox Jews to carry objects like house and car keys, to push strollers, or to carry children, on Saturdays (the Jewish Sabbath) and other Jewish holidays.

And in Jackson, some Orthodox Jewish residents have questioned why the township recently began issuing violation notices to several homeowners for objects "encumbering" the public street or right-of-way lawn between the sidewalk and street.

In most cases, the notices were issued to homeowners with simple hockey nets or basketball hoops.

But some members of the township's Orthodox Jewish community are questioning whether the timing of the notices is linked to their request to build an eruv.

Shives said that Jersey Central Power & Light Co. must give written authorization for installation of an eruv. The township does check to make sure permission has been received from JCP&L in areas where eruvs have been installed.

Eruvs have appeared in sections of North Dover where Toms River moved last year to ban door-to-door real estate soliciting for five years, following complaints from residents about aggressive real estate agents.

The township is still in mediation with Rabbi Moshe Gourarie, who filed a lawsuit against Toms River in March 2016, <u>charging that "anti-Semitic hostility" and local opposition to the township's ultra-Orthodox Jewish population are the reasons why the his Chabad Jewish Center has been told it needs a variance to operate as a house of worship on Church Road.</u>

Dear "Bensonhurat" Mike,

I write as a "piasano" from Bensonhurst and therefore I am addressing you by your first name and will sign accordingly.

At the outset I see that your "Italian temper" is showing although I agree with what you state. We Jacksonians are faced with a real problem that must be addressed now before it is too late and this community becomes another Lakewood. As I wrote previously, even given what you have been faced with, and here I must add that I wouldn't want to be in your shoes as Mayor, we must move forward as a community. To allow things to go the way they are is unacceptable. Threats of court actions only destroy a sense of community. Pro-active work on the part of EVERYONE is the key.

I know your sincerity. I know you haven't a single bone in your body that is anti-Semitic. How could you having been brought up in a neighborhood in which we Italians and Jews were as one? As Sebastian Maniscalco righlty says, "Jews and Italians, same corporation, different divisions."

As you may recall when I and Fr. Bambrick met with you, we had planned a program at his Parish to address the friction in the community with regard to the influx of young Orthodox Jews into Jackson. I spoke on the subject of "All you wanted to know about Orthodox Judaism, but never had the chance to ask." The 300 folks in attendance were able to express their frustrations. It was a tremendous success.

Again, respectfully, particularly because of your background in Bensonhurst, you as Mayor, can take the step to facilitate this needed action. May I suggest that, either as a formal element of government, or as an informal effort by you as Mayor of Jackson, you create a human relations commission or committee appointing a diversity of folks to it, representing all segments of the Jackson citizenry. Let them work among themselves on the issue and develop programming and activities to bring a better understanding of the customs and traditions of the various ethnic and religious groups in our Township to every citizen. Urge them on as Mayor. Never mind the fools on both sides of the situation. We must make our population in Jackson a population of mutual respect and harmony. This can only come about when people have the opportunity to truly express their feelings about another and as well have the opportunity to ask the questions that are burning in their hearts.

I firmly believe that if this can begin, the threats of legal action, the animosities developing, will quickly be an element of the past. We can do this in Jackson. Again, as I stated in my previous email, I am at your disposal to aid you in any way you believe appropriate to bring this project to fruition. You are by nature a strong leader. You can accomplish this task.

I keep you and your family in my prayers and hope that Providence will guide you in this important and desperately needed task.



Township Committee of the Township of Jackson.
>>> Placement of a pole in the municipal ROW requires municipal consent. The poles
constitute an obstruction and violate 372-8 and violations as set in 372-10 may be
issued:
>>> Any person who shall violate any of the terms or provisions of this article
shall be subject to a penalty of not less than $100 and not to exceed $2000 or
imprisonment for a term not to exceed 90 days, or both, in the discretion of the
Judge before whom such conviction may be had.
>>> This prohibition applies to all obstructions in the right of way and should be
uniformly applied throughout the Township, to include other obstructions such as
basketball nets that are placed in the right of way without permission.
