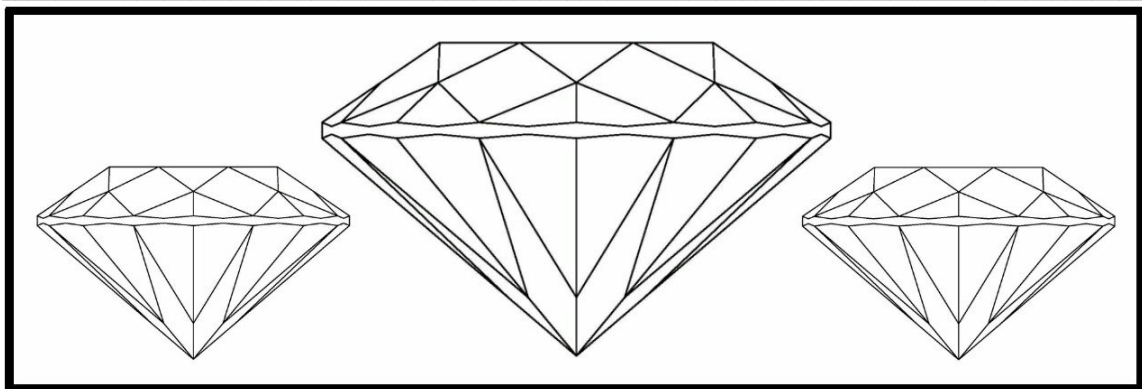

The right of every state around the world,

on questions of compensation for the right to conduct business and jointly with the Imperium of Diamonds Federation.

Each government of the country can therefore quantify its own provisional vision of the maximum possible trade dimension between our states, both bilaterally and multilaterally, thereby also deciding on the right to claim compensation for all the time of lost cooperation between our countries. Your business can therefore be designed entirely freely by your will and must meet basic conditions.

The first condition is the maximum profit, which means creating a common trade at the maximum level of the value cycle, the best importance of development and quality, the goal of the best quality, responsible justice and a legitimate market without damage to the law. The goal of maximalism does not mean to harm any other party, and it does not mean that the government's aim is to secure and abuse its own dominance. The government's goal is to build partnership, friendship, business justice, and respect for common or independent development interests of our states.

The second condition is to achieve a common market budget which, for ID's government, does not mean a weakening of one's own coin or unnecessary necessity, led to its own duty to still print new coins and raise banknote budgets. The objective of the government's ID's government is to ensure a steady circulation of return-back finance from a strategy of joint bilateral and multilateral economic cycles, thus enabling mutual economic stability.

The third condition is the need to use multilateral analytical logistics that complies with the principles of managing joint business planning and performance that minimize damage to partner countries' national markets and thereby achieve and evolve in order to enable them to build on strategies of new business development and maturity. If the proposal of the Common Market and its budget could damage the functioning of the Federation's own domestic markets or if relations and markets with other states are damaged and their stability, the market will be rejected by the Federation responsibly or a logistic adjustment of the principles of the contract functions to prevent developmental damage and strategies.

To confirm the true dimension of the right of your states to claim our common budget, the layout also reflects the analysis and confirmation by the government's ID's on issues of its own goal of development support at International level being limited, according to the goals expressing it;

1. International development trend,
2. The separate development trend of the states and their traditions,
3. Humanitarian objectives and the elimination of poverty, the risk of scarcity of resources,
4. Elimination of unemployment, illiteracy, crime growth factors, etc.,
5. Supporting the Modernization of Nations
6. First line, Achieving world normalization of the most advanced states of the world, equally to each state, and so in 2003-2005,
7. The second line of 2005, up to 2008-2010, measured above the standard average of the International development cooperation function means allowing this second wave of development to be achieved by the first step of the first wave, but the value is not detailed because of the lack of confirmed results from the performance of the First Line targets.
8. Third line, fourth, fifth line, it is not possible to find responsible data today. The outcome must be confirmed by research and the strategy of a joint meeting and cooperation.

Federation ID also reaffirms the reality of rights and entitlements, based on the responsibility of their own intelligence of industrial growth and development, and is published only by the basic first statistics of the development strategy of the civilization level of the federation, the capabilities of the finance budget, the ability of peaceful and organized development up to one year from the start (with time reserves), with the result of the power of a real economy of 300,000,000,000,000 €, which can be confirmed in 1999 (Three Hundred Trillion Euros).

The current intelligence of the federation, responsible for the sum of the economic development strategies and the budget development strategy, is 10,000,000,000,000,000,000,000,000 €€ in DMD, for a population of ten million people since 1999 but without calculating all the necessary values for all the plans of the economic strategy, the amount responsibly as the only first quantification of economic stability and finances, without the sum of all responsible values and developmental calculations.

ID's Government is important partner for Your state and we can commonly very quickly stand for our independent cooperation of International level.

If your government is interested in achieving the development of the common markets according to this document, I and I must ask for your support in view of the purpose of your support to stabilize ID's offices according to ID's development strategy of official function and stabilization plan, and activation of an immediate common market according to official requirements, statutes and goals.

Creating a function of the common conditions of our mutual market also means, at the same time, that our parties have a fundamental obligation to organize our joint meeting and to determine the function of trade rules at the level of our states, on market issues between our governments, and in the second sector the market between the state services and the services our business group in the form of a function of free trade of national corporations and commercial companies, business development in the territory, it is possible to agree on the function of the rules of common commercial relations in the multilateral economy and in the form of membership in International organizations.
