NEW YORK- (PRNewswire) - MGM Resorts International (the "Company" or "MGM Resorts") (NYSE: MGM) and MGM Growth Properties LLC (NYSE: MGP) today announced that MGM Resorts has entered into an agreement to acquire the real property and operations associated with the Empire City Casino's ("Empire City") race track and casino for consideration of \$850 million. Further, MGM Resorts and MGP have entered into a definitive agreement whereby MGP will acquire the developed real property associated with Empire City from MGM Resorts and lease it back to a subsidiary of MGM Resorts, after which a subsidiary of MGM Resorts will operate the property.

Crackdown on border currency exchange shops may have hampered mass gaming in May

MACAU- (Nelson Moura, Macau News Agency) - Mainland Chinese police actions against currency exchange shops at the Gongbei border might have led to a deceleration of mass gaming market growth in May, claims a note sent by advisory firm Union Gaming this Friday. To date, we believe most of the shops remain closed. To the extent these currency exchanges were being used to convert RMB into HKD to be used at the tables in Macau, we believe this would primarily just impact the lower tiers of mass and, importantly, would view the setback as temporary as workarounds typically pop up within a few weeks,' said Grant Govertsen, Managing Director, Head of Asia Equity Research, Macau at Union Gaming. The pairing highlights the scramble among gambling, bookmaking and technology companies to position themselves to gain a large share of the nascent sports betting market now that the U.S. Supreme Court has cleared the way for it.

Scientific Games Will Support Delaware Lottery In First U.S. **Full- Scale Sports Betting Expansion After PASPA Ruling** June 1, 2018

LAS VEGAS- (PRNewswire) - Scientific Games Corporation (NASDAQ: SGMS) ("Scientific Games" or the "Company") today announced that the Company will implement the Delaware Lottery's expansion to fullscale sports betting following the U.S. Supreme Court's overturn of the Professional and Amateur Sports Protection Act (PASPA) of 1992 on May 14, 2018. The state previously offered legal sports betting on professional football and has now expanded its offering to other sports. Macau Legend Cambodia resort plan queried by official June 1, 2018

MACAU- (GGRAsia) - A Cambodian government official was quoted on Friday as saying gambling business was "not allowed" in Siem Reap, near the country's UNESCO World Heritage site Angkor Wat. The comments by Ros Phirun at the Ministry of Economy and Finance (pictured) came after David Chow Kam Fai, co-chairman and chief executive of Hong Kong-listed casino services firm Macau Legend Development Ltd on Wednesday said it was negotiating to buy land in Siem Reap for an "integrated resort". The term is typically a euphemism in the industry for a venue containing a mix of casino space and non-gaming facilities, although Mr Chow did not specifically use the word "casino" when referring to the scheme. Delaware is first state to allow sports betting after Supreme Court ruling

May 31, 2018

DELAWARE- (Joe Lemire, CNN Money) - Governor John Carney announced that the state would launch a "full-scale sports gaming operation" on Tuesday at its three casinos. In May, the Supreme Court overturned a federal law that banned sports gambling everywhere except Nevada. That decision lets states decide whether to allow sports betting. Delaware will be the first state to take that step since the Supreme Court's ruling. SportsPick, Delaware's sports gaming product, will go live at 1:30 p.m. ET in the state's three casinos: Dover Downs Hotel & Casino, Delaware Park and Harrington Raceway & Casino. Bettors will be able to wager on single games for pro baseball, football, hockey, basketball, soccer, golf and auto racing. <u>Click here to read the full article in CNN Money</u>

Guno, Business Inquirer) - In a country which is 80 percent Catholic, it would seem surprising that the gaming industry has taken off: the Philippines has become one of the key markets for casinos in Asia after Macau and Singapore. A stigma towards gambling still exists, whether as an addiction or on the illicit activities attached to it, such as money laundering. President Rodrigo Duterte, who has been aggressive on his crackdown on crime, has expressed a desire to "limit gambling," as he said in a Negros Occidental ceremony last Sunday, May 20.
