

Privacy Policy - Nigeria Air

For our website <u>nigeriaair.world</u> and Nigeria Air apps, accessible from <u>www.nigeriaair.world</u> and through respective Apple and Google Play app stores, one of our main priorities is the privacy of our visitors and guests. This Privacy Policy document contains types of information that are collected and recorded by Nigeria Air and how we use it.

If you have additional questions or require more information about our Privacy Policy, do not hesitate to contact us.

This Privacy Policy applies only to our online activities and is valid for visitors to our website and apps with regard to the information that they shared. This policy is not applicable to any information collected offline or via channels other than this website and app.

Consent

I hereby confirm that I have read the aforementioned policy and with a clear understanding of its implications with regard to my privacy rights consent to the processing of my personal data by Nigeria Air in accordance with the provisions of the Nigerian Data Protection Regulations that consent must be a freely given, specific, informed, and unambiguous indication of a Data Subject's agreement to the processing of his/her Personal Data.

Information we collect

The personal information that you are asked to provide, and the reasons why you are asked to provide it, will be made clear to you at the point we ask you to provide your personal information.

If you contact us directly, we may receive additional information about you such as your name, email address, phone number, the contents of the message and/or attachments you may send us, and any other information you may choose to provide.

When you register for an Account, we may ask for your contact information, including items such as name, company name, address, email address, and telephone number.

Please note that you have the right to revoke your consent to the processing of your personal data at any time by sending an email to commercial2@nigeriaair.world to our data protection officer. Please be aware, however, that the withdrawal of consent will not impact the legality of

the processing done prior to its withdrawal or the processing of your personal information done in reliance on grounds other than consent that were legal for the processing.

How we use your information

We use the information we collect in various ways, including:

- Improve, personalize, and expand our website
- Understand and analyze how you use our website
- Develop new products, services, features, and functionality
- Communicate with you, either directly or through one of our partners, including for customer service, to provide you with updates and other information relating to the website, and for marketing and promotional purposes
- Send you emails
- Find and prevent fraud

Log Files

nigeriaair.world follows a standard procedure of using log files. These files log visitors when they visit websites. All hosting companies do this and are a part of hosting services' analytics. The information collected by log files includes internet protocol (IP) addresses, browser type, Internet Service Provider (ISP), date and time stamp, referring/exit pages, and possibly the number of clicks. These are not linked to any information that is personally identifiable. The purpose of the information is for analyzing trends, administering the site, tracking users' movement on the website, and gathering demographic information.

Cookies and Web Beacons

Like any other website, nigeriaair.world uses 'cookies'. These cookies are used to store information including visitors' preferences, and the pages on the website that the visitor accessed or visited. The information is used to optimize the users' experience by customizing our web page content based on visitors' browser type and/or other information.

Users will be informed in advance and given the choice to object if their information is potentially used in a way that is against this privacy policy.

Data Privacy Rights (Do Not Sell My Personal Information)

You may be entitled to the following rights, subject to any applicable laws, rules, and/or regulations: Before your personal data is used for purposes other than those for which it was

originally obtained, you have the right to be informed and to provide your consent. to ask us to update any personal information you find to be inaccurate or altered. to request that we erase your personal information, such as when we no longer need it for processing.
