'Mr. Little League' - John Curtin - Passes Away At 80

John J. Curtin, 80, president emeritus of Charlestown Little League Baseball, died Monday evening, Jan. 19, at Mass. General Hospital. A lifelong resident of Charlestown, John devoted most of his adult life to the betterment of youth through his tireless dedication to Little League Baseball.
John helped establish Little League in Charlestown some 35 years ago and remained in the capacity of league president for over 20 years and, for the past five years he has held the title of president emeritus of the organization.

In recognition of his dedication to youth activity, John was recognized by the city of Boston in 1984 as the first recipient of the city's Neighborhood Hero Award and several years ago, the Little League field at Ryan Park in Sullivan Square was named in his honor.
John was also a popular taxi cab owner in Charlestown for many years before his retirement in 1988. He was also a member of the Old Charlestown Schoolboys Association and the Hackney Association of

## Boston.

John continued his interest and support of the youth of Charlestown and, in particular Charlestown Little League, until the time of his death. Ed Greatorex, the president of Charlestown Little League, called John "Mr. Little League."

Greatorex said that John was "dedicated to the kids of Charlestown and gave 100 percent to Little League." Greatorex went on to say, "John was my boss and I always answered to him. We discussed the program on a regular basis and he was always there to offer advice on problems that arose in running the league. John loved to attend games whenever he was able and would sit on the benches in Ryan Park and enjoy the kids."

Greatorex went on to say that "the Little League program was built up the way John wanted it to be and it will continue to grow as he would have wished."
John was the husband of the late Alice (McGonagle) and the devoted father of a daughter, Evelyn Shields of Melrose and five sons, John of North Easton, William of Bridge-

## NEW LAW COMPLICATES

 CAPITAL GAINS TAXESThe capital gains tax cut contained in the Taxpayer Relief Act of 1997 was welcome news to most taxpayers. It lowered the maximum capital gains tax rate from $28 \%$ to $20 \%$. The $15 \%$ capital gains rate that applied to people in the lowest tax bracket was lowered to $10 \%$. There was no change in the maximum rate for long-term profits on collectibles; it remained at $28 \%$. An additional rate of $25 \%$ was created for depreciation recapture on certain real estate sales. To further complicate things, the new law provides for different length holding periods at which the various rates apply. For 1997 sales of capital assets, the holding period and rate that applies will differ depending on the date of the sale in relation to two effective dates in the law - May 7 and July 29.

How to net capital gains and losses with such a variety of holding periods, sale date cutoffs, and tax rates was not dealt with in the original legislation. A technical corrections bill gives the guidance on how capital losses are to be netted against capital gains. Long-term capital gains are to be grouped by tax rates, and losses for each long-term tax rate group are to first offset gains within that group. If a long-term tax rate group has a net loss, that loss will be used to offset net gain for the highest longterm tax rate group. Any remaining loss will offset the gain in the next highest long-term tax rate group, and so on. A carry over of net long-term capital loss from a prior year will be used first to offset net gain for the long-term highest tax rate group, and so on. Net losses with holding periods of one year or less are to first offset net gains for the highest long-term tax rate group, then the next higher, and so on.

## A Look Back . . . At Old Silver Lake

Through a series of coincidences, I recently became reacquainted with an old Wilmington friend. Nearly 40 years have passed since I last saw or spoke to Gerry O'Reilly, a man we, who frequented the Town Beach, knew as "Scratch." But his stature and ever-present smile made him easily recognizable.

In our conversation, I learned he had been commissioned by the Wilmington Historical Commission to gather information for a pictorial essay on old Silver Lake. A review of the finished product was a refreshing trip back in time for me, for Silver Lake was where I had spent all of my early summers.
Although most of what was presented in his work predated my own experiences, much of the pictorial was easily recognizable. Photos of Grove Avenue, Moxie Beach, the Betterment, Steven's Market, the old icehouse at the lake, and many other Wilmington landmarks helped to spark long-forgotten memories.

one that is shown above. which has created a great deal of curiosity for Gerry
The photo depicts a group of 12 young men posing outside a summer cotlage identified as the "EWE \& EYE" by a sign over the screened porch door.
The cause for Gerry's curiosity lies in the sweater wom by the boy pictured second from the left in the back row. In a blown up version of the 1918 snapshot, the letters LEST are
clearly visible down the sweater's front. What comes before the L and after the T cannot be seen, but it is Gerry's feeling that the letters are part of the word "CHARLESTOWN," and that the boys were summer visitors from this community.

Gerry has not been able to identify the boys in the photo, but he is certain that if he can locate but one name, the others will all fall into place.
Any reader of the

Patriot who may be able to assist Gerry in his attempt to identify the individuals in the photo, can contact me through this newspaper. I, in turn, will pass the information on to him.
