

## **International Investment Arbitration Moot Court**

# September 13 - 16, 2019 / Bangkok, Thailand What is ALSA International Moot Court Competition (AIMCC) 2019?

The ALSA International Moot Court Competition (AIMCC) is a simulated arbitration hearing of an Investor-state dispute settlement (ISDS). Students from all over the world will send in their Memorials for the complainant and respondent of a fictional case written by professionals. After the Memorial Round, selected teams will present their memorials for the complainant and the respondent in front of a Panel of Arbitrators in the Oral Round.

Through the competition, participants will be given the opportunity to develop analytical skills and skills in legal research, writing, and advocacy and expand their knowledge on and become exposed to issues of international law in the simulated environment of an arbitral tribunal. The competition promotes networking amongst law students, encourages the exchange of ideas and perspectives on contemporary legal issues, and, in turn, proliferates the development of the law. The experiences acquired from the AIMCC carry through in later life, helping to shape successful careers in different areas of legal practice.

Theme: International Investment Law

Venue: Windsor Hotel, Bangkok, Thailand

Awards of The Competition: Winning Team of the Final Round – The winning team of the final round of AIMCC will receive a 500 USD Prize Award

Best Individual Oralist – The Best Individual Oralist of AIMCC 2019 will receive an unpaid Internship opportunity at ICC case management team, with the internship period being determined by ICC and the awardee

Best Respondent and Claimant Memorandums – Teams with best Claimant and Respondent Memorandums will receive one ticket each for one member of the respective teams to attend the Program of the Institute for the Development of Arbitration (PIDA1) by ICC Institute of World Business Law.







#### Registration

Registration is open from 15th of March until 22nd of June 2019 (23.59 GMT+7). A team must fill out the registration form and send it to alsaimcc2019@gmail.com. The confirmation email will be sent to the team's contact person. There are no charges for registration during the Memorial Round. Teams that qualify for the Oral Rounds will be announced on 21st of August 2019. Another registration form will be sent to those qualified along with the Oral Round Participation Fees. Teams will have to fill another registration form in order to confirm their participation within 1 week to alsaimcc2019@gmail.com, a confirmation letter will be sent to the teams.

### **Frequently Asked Questions**

#### Who is eligible to participate?

Students who are currently enrolled in universities and are pursuing undergraduate degrees in law or law-related degrees. A person who is not a graduate of a degree or research degree program, has not previously graduated from any type of law degree programs, who is not or has not been involved in extensive 'practices of law', or currently involved in the organization of the Moot and who is not registered as a team member as specified in Clause 5.2 of AIMCC 2019 official rules .

Note: Exceptions may apply upon the request and the written permission of the Organizers as of the AIMCC registration time. All determination of eligibility is in the discretion of the Organizers.

#### How many members per team?

A minimum of 2 team members and a maximum of 5 team members are required for each team.

#### Can a team have a coach?

Yes! A team may be advised by a coach to adequately prepare the Team to participate fairly in the Competition. However, coaches may only provide substantial advice and consult matters regarding the Moot with the Team, as specified in Clause 5.8 of AIMCC 2019 official rules and may not actively take part in the oral pleadings.

#### Do all team members have to be enrolled in the same university?

No! Team members may be enrolled in different universities. However, such universities must be located in the same country.

#### What is the structure of the competition?

The competition will be divided into two rounds: the Memorial Round and the Oral Round in Bangkok. Teams will be assessed on the basis of their memorials to determine if they qualify for the oral rounds.

#### Does everyone who registers have to pay the 280 USD?

No! Only teams that qualify for the Oral Round in Bangkok have to pay the 280 USD participation fee per person, which will include all accommodations, local transportation, and all meals including lunches and 2 formal dinners.

#### What's in it for me if I participate?

Apart from a 500 USD Prize for the winning team, AIMCC also provides other exciting awards such as an internship opportunity at ICC's case management teams and tickets to attend the Program of the Institute for the Development of Arbitration (PIDA1) by ICC Institute of World Business.

Through the competition, you will be given the opportunity to develop analytical skills and skills in legal research, writing, and advocacy. Participation in the AIMCC will expand your knowledge on and expose you to current issues of international investment law in the simulated environment of an international arbitral tribunal. Also, you will get to network and exchange ideas and perspectives on legal issues with law students from different countries. The experiences you may acquire from the AIMCC will help to shape successful careers in different areas of legal practice.

In addition, this year's competition offers a Panel Discussion prior to the Competition! The discussion will be led by renowned and professional International Investment lawyers, allowing you to participate in the discussion and receive expert opinions on hot legal issues!
