# Colleges mull pushing for share of legal sports betting proceeds

UNITED STATES- (Eric Olson, Associated Press) - Concerned that expanded sports gambling will bring additional costs for ensuring their games are on the up-and-up, college athletic departments are looking for a way to get a piece of the action. A U.S. Supreme Court decision in May allowed states across the country to join Nevada in having legalized sports betting. Since then, sports books have opened in Delaware, Mississippi and New Jersey. A West Virginia casino is set to take bets within two weeks, with other states not far behind.

# Casino REITs called attractive

August 22, 2018

LAS VEGAS- (Clark Schultz, Seeking Alpha) - Union Gaming stays positive on the casino REIT sector as it sees even more consolidation ahead on the regional level and calls out potential for more real estate deals in Vegas. "On the Las Vegas Strip alone, there is over \$3.5bn of EBITDAR (\$1.8bn of rent) currently not owned by REITs," notes analyst John DeCree. "This represents \$20bn-\$25bn of potential real estate value assuming a 7%-8% cap rate. This would represent a 5+ year growth pipeline based on the Casino REITs M&A pace YTD. In addition, the Las Vegas Locals market (>\$1bn EBITDAR) is virtually untapped by REITs as well," he adds.

# Casinos ask state court to shut down Pennsylvania's new iLottery

PENNSYLVANIA- (Mark Scolforo, Associated Press) - Pennsylvania casinos asked a court Wednesday to shut down the state's new iLottery program, arguing the internet-based games simulate slot machines and casino-style gambling in violation of state law. The complaint against the Revenue Department, which includes the Pennsylvania Lottery, said the iLottery games mimic slot machines found in casinos and online. "All of the iLottery games feature the same user interface as a slot machine,
