Condition of Play

The following contents are essential and important for players participating in the 29th Sindh Cup Snooker Tournament 2020.

1. Any player intentionally giving wrong information on this entry form, for any reason, will be disqualified from playing the tournament and the entry fee will be forfeited.
2. All players have to strictly follow the dress code requirements specified as under: -
 - A. One color plain long trouser (No stripes)
 - B. One color plain full sleeve shirt (No stripes)
 - C. Bow tie & waist coat.
 - D. Leather soled shoes (No sneakers)
3. Any player using, distributing or under the influence of drugs, in the venue at anytime during the championship can be penalized and suspended from playing further in the tournament and subsequently, can be banned from participating in other championships for a period of 3 years.
4. Top 8 players from this championship will qualify for the 46th National Snooker Tournament 2021.
5. The association has all the rights to enter any player, at any time if situation demands.
6. Any damage caused to the association of the venue's property shall be paid for at a cost sufficient to replace it, by the player breaking or damaging the same.
7. Player not satisfied with the decision of any referee may appeal to the tournament director whose decision will be final.
8. No practicing on the championship table will be permitted, unless it is specified by the tournament committee.
9. No logos of any company shall be allowed on player's clothing.
10. If a player is late for his match for 1 minute, one frame will be awarded to the opponent and after 15 minutes a walk over will be awarded to the opponent.
11. All players are directed to report their arrival in the venue for their match, to the tournament director / chief referee.
12. An overall tournament director / chief referee shall be appointed by the SBSA whose decision regarding any dispute will be final.
