6.1.1. For non-emergency personnel

- Protective equipment : Wear recommended personal protective equipment. Dust formation: dust mask. Wear suitable protective clothing, gloves and eye or face protection.
- Emergency procedures : Ventilate spillage area. Avoid contact with skin and eyes. Do not breathe dust/fume/gas/mist/vapours/spray. Do not touch or walk on the spilled product. Evacuate unnecessary personnel. Mark out the contaminated area with signs and prevent access to unauthorized personnel.

Appropriate engineering controls:

Ensure good ventilation of the work station. Avoid contact with skin, eyes and clothing. Carry out operations in the open/under local exhaust/ventilation or with respiratory protection. Consider the use of a work permit system e.g. for maintenance activities. Emergency eye wash fountains and safety showers should be available in the immediate vicinity of any potential exposure. 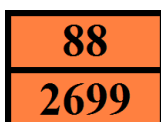
