We the undersigned, 87 residents of the City of Poughkeepsie School District, herby demand the City of Poughkeepsie School Board remove Dr. Nicole Williams as Superintendent due to her incompetence, mismanagement, and failure to properly perform her legal duties as Superintendent.

The City of Poughkeepsie School District, like all school districts, has a supremely important mission: to educate our children, so that they might achieve their full potential.

Dr. Williams's incompetence and mismanagement has repeatedly and seriously put this mission at risk. Over the last year, it has been the rare week when the Poughkeepsie Journal has not uncovered new details of failures by Superintendent Williams. For instance, serious questions have been raised about graduation rates being accurate. Additionally, it appears the District has not properly provided support for handicapped and disabled children or provided academic intervention services (AIS) to qualifying students. Finally, recent reports seem to indicate the District, on direct orders from Dr. Williams, has repeatedly made gifts of public funds. These issues are not mere shortcomings, but egregious violations of the law.

It is clearly apparent that Dr. Williams is not fit for the task of being Superintendent. Unfortunately, former board members, after losing by a historic margin, used their last remaining days to give Dr. Williams a new five-year contract with unprecedented protections.

Regardless, action must be taken. Our schools must not be forced to suffer another year under Dr. Williams's incompetent management. We ask the Board take whatever action necessary to remove her.
