Birmingham To Hold Regular Office Hours In Charlestown

Tom Birmingham, the newly elected senator representing Charlestown and the rest of the Suffolk-Essex-Middlesex district, has announced his decision to hold regular office hours in every city or town in the district. There will be office hours in Charlestown at the

Bunker Hill Museum, 43 Monument Square (use Monument Avenue entrance) on Monday, Feb. 11 from 7 to 9 p.m.

Birmingham will then rotate the meetings on a weekly basis through the North and West Ends of Boston, Revere, Everett, Saugus,

Chelsea and Charlestown. The public is cordially invited to attend and address questions, comments or suggestions to the senator.

Upon announcing his plan for holding office hours, Birmingham stated: "I'm proud to begin these weekly neighborhood meetings because I will be able to hear directly the real concerns of the people I represent. I plan to work as a senator much as I have campaigned. I will be accessible, responsive and hard-working."

EDIC Outlines Programs — Massport Criticized At CNC Meeting

Representatives from Boston's Economic Development and Industrial Corporation and the Boston Police Department were on hand at the Feb. 5 meeting of the Charlestown Neighborhood Council to provide an update on programs and plans in each of these city departments.

Council Chairman Dennis McLaughlin opened the meeting by asking for a moment of silent prayer for the men and women serving in the Persian Gulf. Council members present at this meeting were: Vice Chairman Peter Looney, Secretary Jim Mansfield, Marilyn Darling, Marty O'Brien Sr., Kay Whelan, Ellen D'Ambrosio, Tom Cunha, Bob Wallace, Ed Callahan,

Mel Stillman, Dan Kovacevic, Matty O'Neil and Jim Conway.

Harry Grill, counsel to EDIC Director Don Gillis, outlined EDIC's aims and handed the members a mission statement which included the expansion of job opportunities through economic development and training, financing for continued economic growth, and the retention and expansion of business with the resulting job opportunities.

Grill told the council that EDIC has just completed nine meetings throughout the city that were designed to inform business persons, residents and agencies on the services offered and to obtain input into what the

attendees would like to see funded under Community Development Block Grants. He invited council members to contact the EDIC with any questions and comments on its programs.

The EDIC has a mandate to maintain and create jobs in Charlestown, said Grill, now that they and the Mayor's Office of Jobs and Community Service have merged, adding that with the relationship established with the Mayor's Office of Neighborhood Services, they are better able to respond to community concerns.

It was related that EDIC representatives have begun visiting Charlestown businesses to provide informa-

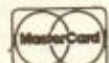
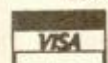

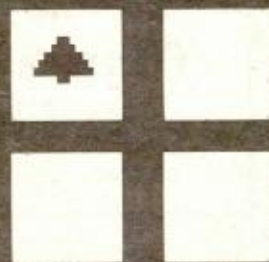

Residents Named To Bridge Design Review Committee

The Massachusetts Department of Public Works has named several residents as members of the Bridge Design Review Committee which will study the Charles River Crossing aspect of the Central Artery/Third Harbor Tunnel roadway construction project.

The committee, which held its first meeting on Feb. 1, includes residents Richard Johnston, co-chairman of the North Area Task Force; William Lamb, architect; and Dan (Tom) King from Citizens for a Livable Charlestown. Other

residents include Judy Evers, Charlestown liaison from the Mayor's Office of Neighborhood Services, and Judy McDonough, executive director of the Massachusetts Historical Commission.

There are presently 38 committee members with Stanley Miller, chairman, and John Wofford, facilitator. Miller is a general partner in Congress Realty and chairman of the board of Guaranty-First Bank and Trust. Wofford is a senior consultant at ENDISPUTE, a conflict management and

dispute resolutions firm with its local office in Cambridge.

Following the introduction of the members, newly appointed state Transportation Secretary Richard L. Taylor spoke to the gathering. He told them that his office regards the deliberation of the committee as an important mechanism for potential suggestions and improvements to the CA/T project. He pointed out that the committee was established in the objectives for dealing with the Charles River Crossing set forth by then Secretary of Environmental Affairs John DeVillars on Jan. 2 when he issued the certificate approving the project.

Taylor said that the committee is charged with the responsibility of identifying improvements in the proposed Scheme Z crossing so as to make it "as aesthetically pleasing and environmentally harmless as

possible." He added that in the work of the committee as well as the MDPW's continued review of other options, "it is imperative that this project and the substantial public benefits which it represents not be jeopardized through endless review and delay."

Taylor promised the committee further assistance and resources and stated that his department has agreed to add technical and specialty consultants if requested by the committee chairman. He asked for a preliminary report from the committee by April 30 and a final report shortly thereafter.

Committee members were able to share their concerns on the Charles River Crossing aspect of the plan, including Scheme Z, and the Traverse Street ramp. Participants heard the problems with this aspect of the CA/T plan as envisioned by representatives from

the North End, Beacon Hill and Cambridge as well as from environmental and architectural groups. Miller asked for a summary of issues from each of the committee members within five

days of the meeting.

On Friday, Feb. 8, Charlestown resident Tom King will conduct a walking tour of the Charles River Crossing site starting at 150 Causeway St.

USS Constitution Museum Hosts 12th Annual Ship Model Show

A ship modeler's dream comes alive as the USS Constitution Museum hosts its 12th annual Juried Ship Model Show Feb. 11 through March 16, featuring the work of the USS Constitution Model Shipwright Guild of New England.

A wide selection of ship models built by amateur and professional modelers will be on display including commercial freighters, naval vessels, fishing boats and ships in bottles. Museum visitors will be able to

tour the exhibits and take part in a judging contest to cast their vote for the most popular model.

"We are celebrating the creative spirit of these modelers and of two marine artists who have focused on 'Old Ironsides,'" said Ellen J. Kraft, director of the museum. "Paintings recreating scenes from Constitution's past by the museum's artist-in-residence Cheslie D'Andrea will be on display along with etchings of the ship by George C. Wales, a

Boston architect and artist."

The USS Constitution Museum is a non-profit educational institution dedicated to preserving and interpreting the history of "Old Ironsides" and the history of the early republic. The museum, located at the Charlestown Navy Yard, is

open daily from 9 a.m. to 5 p.m. Museum admission is \$2.50 for adults, \$2 for senior citizens and \$1.50 for children. On Saturdays, children 16 years of age and younger are admitted to the museum free of charge when accompanied by an adult.

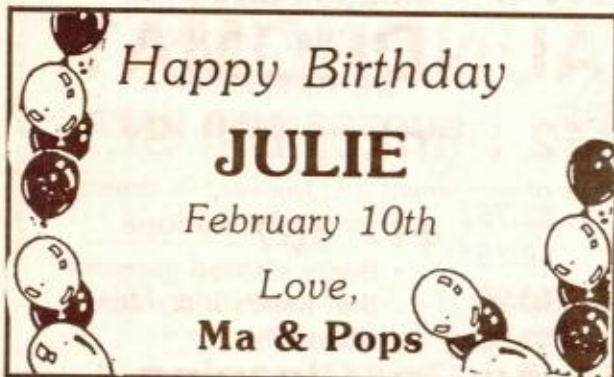

tion on the agency's services. Grill said that the EDIC has been monitoring the Hood plant in Charlestown and asked that the agency be given time to return to the council to focus on that facility. He added that company officials have assured EDIC that Hood does not have the plant on the market at the current time. Grill added that the community must also monitor the plant and pass on any information or changes to EDIC.

Grill handed out a summary of EDIC services in this community for Fiscal Year 1991 which included: five adult skills programs, \$188,439; one youth program, \$30,000; one counseling program, \$2,185; and two education programs, \$109,960. Local agencies receiving funding are Boston Community Schools, Bunker Hill Community College, Charlestown Community Schools and the J.F. Kennedy Family Service Center.

EDIC staff member Tom

Fields related other areas of services provided by the agency. These included assistance in relocation, primarily to one of the EDIC's three industrial parks; help with licensing and permits; a newly published directory with information on 12 types of business assistance, ranging from zoning to financing; and the institution of a business services hotline where answers to business-related questions can be obtained by calling 1-800-255-EDIC weekdays between 8:30 a.m. and 5 p.m.

Gay Shanahan spoke on the financing services available through EDIC for large projects with taxable and tax-free bonds offered by the Boston Industrial Development Financing Authority (BIDFA) and financing tools offered to small business through the Boston Local Development Corporation (BLDC) with loans up to \$250,000.

Jack Clark related the jobs and community services aspects of the EDIC. He said that he is involved

with the human services, education and jobs for the agency and expressed a desire to work with community-based organizations to put money out to community groups. Clark added that

he wanted to hear priorities in funding from the neighborhood.

McLaughlin told Clark that the council has been involved with several projects which have promised that a

certain number of jobs would go to community residents. He went on say that the council has found that there is no mechanism in place to include job opportunities and one must be

created. Clark said the EDIC has been working with the Boston Redevelopment Authority on jobs and job training-related issues as well as providing some help on community benefits packages. Clark stated that the EDIC would be willing to work with the council on this.

Boston Police Commissioner Francis "Mickey" Roache and a team of police department officials made a presentation on community-based policing. This portion of the meeting will be detailed in next week's Patriot.

Returning to council business, McLaughlin asked for the ratification of the following committee chairmanships: Cunha, development and community appreciation; Stillman, public safety; Looney, public services; Wallace, haul road; Gillen, mitigation; Conway, bylaws and veterans; Nancy Keyes, oversight; and McLaughlin, New England Aquarium committee-of-the-whole.

Bylaw Committee, Jim Conway, chairman

Wallace brought to the floor proposed changes in the council's bylaws. Since members must be given notice of proposed bylaw changes, McLaughlin referred them to the bylaws committee with the suggestion that a meeting be held in the very near future. Conway stated that he would set a meeting for Feb. 21 at 7 p.m. with a site to be announced and a notice mailed to council members.

Public Safety Committee Mel Stillman, chairman

Stillman reported on last month's meeting with Officer Joe McNulty. He said the main issue was vandalism, particularly at the Old Kent School in Hayes Square and residents were asked to join police in keeping an eye on it. He urged attendance at the upcoming meeting on Tuesday, Feb. 12 at 7 p.m. at the Kent Community School, 50 Bunker Hill St.

Public Service Committee Peter Looney, chairman

Looney reported that the Charlestown High School Parents Council had a good meeting last month at Bunker Hill Community College. He noted that there hadn't been a council in a number of years and it's going well now and should be solid by fall.

Development Committee Tom Cunha, chairman

Cunha spoke on the committee's Jan. 29 meeting on Parcel R-107 at the corner of Main Street and Lawnwood Place. He said that when a draft Request For Proposal (RFP) was brought before

the committee in October, area residents outlined a number of concerns including: the addition of a fourth floor to the structure, 16 relatively small residential and commercial units with 50 percent affordable, the desire for parking on or near the property, the suggested exclusion of 3 Lawnwood Place from the parcel so it could be developed separately and the disrepair of the buildings allowed by the owner, the BRA.

Cunha said the new RFP calls for a cut to nine residential and commercial units with no one-bedroom units and 25 percent affordability, the elimination of the proposed fourth floor and the retention of the Lawnwood Place three-decker as part of the parcel. He added that the BRA has determined that no parking will be available on or near the site.

Cunha explained that the RFP is a general plan for development, not a particular design. He said that the RFP would have to be brought forward to allow for the submission of development proposals and he noted that the BRA has said there are developers interested in the parcel.

According to Cunha, the Boston Fire Department has deemed the building unsafe for firefighters in the event of a fire at the site. It was suggested that the Public Safety Committee follow up on this by contacting the Fire Department, Commissioner Tom McNicholas of the city's Inspectional Services Department and the BRA and monitor the safety issues relative to this property.

The council voted to endorse the RFP for this development with several conditions attached. These include: the exclusion of electric heat in the development; the prospective developers would have to talk with abutters; and the BRA would address the safety issue of the building, stating its condition in the RFP.

Appreciation Committee Tom Cunha, chairman

Cunha was enthusiastic about the number of responses received to date nominating recipients for the various community appreciation awards. He reminded members of the deadline at 5 p.m. on Friday, Feb. 8 and said the committee hoped to have selected the recipients by the next council meeting.

The Awards Banquet will be held on Saturday, March 30 at the Knights of Columbus Hall. Tickets are \$15 per person and may be obtained by contacting Moe Gillen at 242-3746 or Bob Wallace at 241-8889.

Mitigation Committee Moe Gillen, chairman

In the absence of the chairman, Looney read a letter from Massport to Christy Foote-Smith, director, Massachusetts Department of Environmental Protection that was hand delivered to the members just prior to the meeting by Dorothy Steele, Massport's community liaison.

The letter, signed by Massport Maritime Director Anne Aylward, addressed the application by the Massachusetts Water Resources Authority for a Chapter 91 license for construction of an MWRA personnel ferry dock at the former Revere Sugar Terminal on Medford Street in Charlestown.

In part, Aylward's letter stated: "As you know, this property is owned by the Massachusetts Port Authority and leased to the MWRA. At this time, MWRA's lease does not permit the use of the site for a person-

★ **More And More Homes** . . . throughout Charlestown have joined supporting the servicemen in Operation Desert Storm by placing yellow ribbons and American Flags outside their houses. Single white candles are glowing in many windows awaiting the return of these men and women . . . The demand for yellow ribbons has become so great, Bill McClellan reports that no sooner does he put them up on his house, than they are taken . . . Secure them tightly, folks, and keep up the good work!

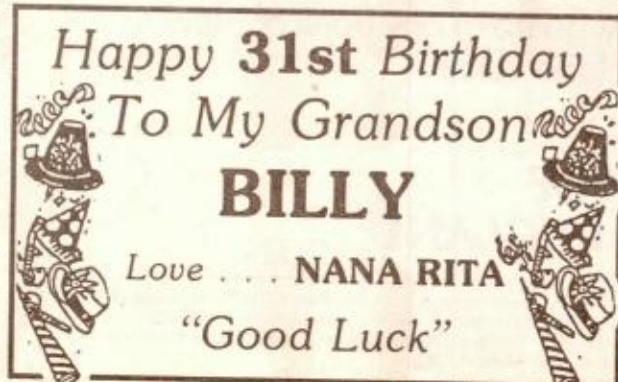
Thank you again for your warm thoughts and generous gestures. I'll write again soon.

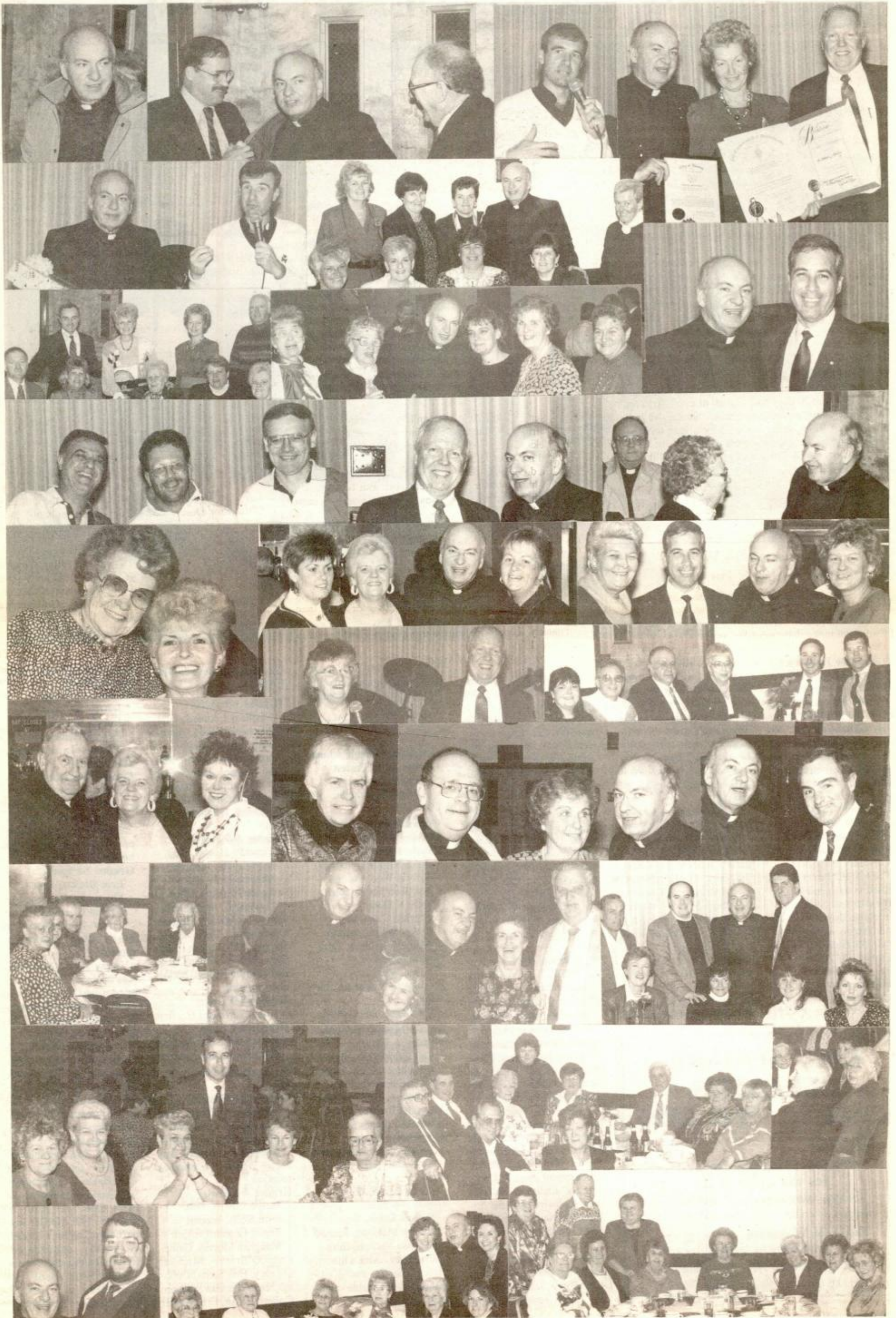

A Look Back At CHS Hockey

Charlestown High School's hockey team these past few years has been reminiscent of years gone by. Before 1955, CHS had virtually no hockey history, which of course has changed in the past few decades. Players from around the town have received college scholarships and some have even played professional hockey but most importantly, organized hockey in Charlestown has helped build strong character in the youth of our town.

During the 1940s and up to the late 1950s, the CHS team colors were buff and blue, and they were known as the "Gray Ghost." In the late 50s, the colors were changed to red, white and blue and the teams then were called the "Hillers" by the press. It was not until the middle 60s that they were called the "Townies."

The first years of Charlestown's domination of Boston hockey were from 1955 to 1964. These teams won five district titles, finished second three times, third once and sixth once. Interestingly, there was only one losing season and that was in 1956. The longest winning streak was 32 games without a loss from 1959 to 1961. There was only one undefeated and untied team, and that was in 1960. Three teams won titles with a tie, those of 1957, 1959 and 1963. The overall record for this decade was 76-15-7.

Charlestown teams were always noted for their defensive play throughout the city of Boston and during these 10 years, the team featured some great goaltenders. Selecting the best defensive team would be very difficult, although the 1958 and 1959 teams were only scored on four times each. During the 1959 and 1960 seasons, Tommy Crilley went undefeated at 20-0-1 and Tom White posted the best win record at 29-4-3.

Offensively, which team could put the disk in the net most often? The 1960 team, lead by Richie O'Neill and Eddie Collins, lit the lamp at an average of more than five goals a game. The 1963 team averaged almost six goals a game with Mike "Butch" McGrath, Bob Cunio and John Tibbetts. This was the highest-scoring line in the state that year. The 1964 team averag-

ed over five goals a game and John Tibbetts and Bob Cunio were one and two in scoring statewide. These three teams scored more goals than all of the other teams combined.

Although Hyde Park won the title three times and Southie once during this decade, the "game" was always against our cross-town rivals, Southie, and the rivalry was a great one with not too many blowouts from either side. Jack "The Barber" Luiselli, when talking about the fierce competitive level that existed between the two towns and making reference to the Charlestown Town Team, said, "We could go to Eastie and would not have any trouble, same thing over in Roxbury, but as soon as we played the guys from Southie, we would fight from the first quarter to the fourth. The hockey games against Southie were tough and the hitting hard. But the fans from Southie went home disappointed, winning only twice while Charlestown won 12 and there were two ties."

State tournament play was a horse of a different

color. At this time the tournament was open to all schools across the state with no divisional play as there is today. Winning one game in the tournament was quite an accomplishment. After all, Charlestown was the smallest school in the district and surely one of the smallest in the state, so advancing was very difficult. There were four teams that advanced — the 1955 team defeated Natick 1-0 with superb play in the net by Jim "Crash" McNeil and lost to Lynn English 3-0. The 1957 team beat up on Worcester North 10-3, upset Norwood 2-1 and lost to Winchester in the quarter finals in triple overtime 1-0. This team was anchored in the net by the tremendous play of Gerry Murray. The 1959 team advanced but lost to Marlborough 3-0. The 1963 team advanced, upsetting Quincy 4-2 and was overpowered by Belmont 3-1.

Okay, now the six dollar question — *Which was the best team from this era?* The 1960 team went undefeated and untied and placed five starters on the dis-

trict all-star team. There is no question the team had a lot of talent and was a great team. The 1959 team went undefeated, won the district title, won the city title, advanced in the tournament, placed five starters on the all-star district squad, only had four goals scored on them and was another great team. The 1963 squad went undefeated, advanced in the tournament, placed six starters on the all-star district team and is another strong contender. But for my money, the 1957 six had the best team and perhaps the best team ever to play at Charlestown High. This team went undefeated, demolished Worcester North scoring an amazing 10 goals in one game in the tournament (which tied a record with Arlington set the previous year), upset the se-

cond-seed Norwood 2-1, reached the quarter finals — the only team to do so from Charlestown in open tournament play — only to bow to Winchester in triple overtime 1-0. With a little luck this team could have won the state crown.

And how about the best six players (my phone will be ringing off the hook)? The three players up front are Franny Doherty who led the iron-man squad of '55 and was a one-man team. Buddy Sullivan from '57 was "the best player I ever coached," remarked Coach John Tyrell, and he would know. He coached the high school for nine of the 10 years. Also, Big John Tibbetts, '64 was a three-year starter and led the state in scoring.

At defense, another player from the iron-man squad

of '55 is Billy O'Donnell, a heads-up player and, paired with Billy Feeney, '64, he could control the pace of the game.

During this era, Charlestown had four goaltenders who played two or more years each and received incredible play from all... from Jerry Murray's spectacular play in the tournament to Tom White's three years of solid play, posting a 29-4-3 record. However, Tommy Crilley, '60 was the only goaltender to go undefeated at 20-0-1. Crilley rounds out the team.

My selection for the Charlestown High School All-Star Team with players from 1955 to 1964 would be: Forwards — F. Doherty, J. Tibbetts and A. Sullivan; Defense — B. O'Donnell and B. Feeney; and Goalie — T. Crilley.

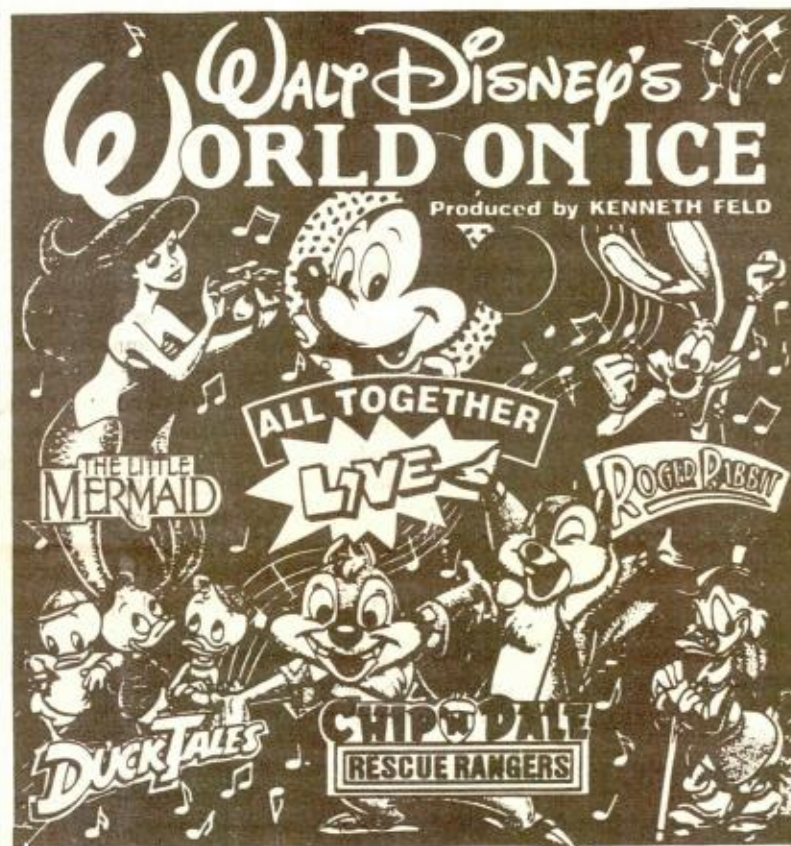

nel ferry. Amended lease terms have been negotiated between MWRA and Massport, however their execution is awaiting resolution of mitigation issues between MWRA and the Charlestown community. It is my understanding that this mitigation relates primarily to traffic management."

Several members took issue with the contents of the letter. Conway referred to the portion that stated amended lease terms have been negotiated, adding that at last month's meeting the Massport representative said that the lease had not been amended "and now we have this (copy of the let-

ter)." He went on to say that a letter should go out immediately to Massport and the MWRA stating that the council has had no input in any lease agreements and is on record as being opposed to a personnel transfer facility that would bring hundreds of cars over the community's streets on a daily basis.

O'Neil stated that once again the council has to ask if Massport is going to deal up front or are they just going to tell us what they are going to do. Kovacevic said the council should meet with the MWRA, and Cunha added that Massport and the Boston Traffic Department should also be included. McLaughlin noted that

the council's only leverage is with the city, and BTB in particular.

The council passed a motion that a letter be sent to Massport, MWRA and BTB informing them of the council's opposition to the personnel transfer facility plan, asking for a clarification on who is dealing with the council and who should respond to its concerns and strongly stating the council's lack of input in the negotiations between Massport and the MWRA on the Medford Street site.

The March meeting of the council will be on Tuesday, March 5 at 7 p.m. at the Knights of Columbus Hall.
