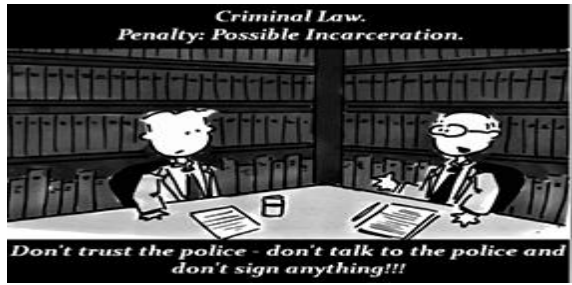
When they can't find anything wrong with you, they create it.

Secrecy helps trample parents' rights

The keystone of child protection should be to ensure that children can be made safe at home, or in care.

Children enter care for many reasons other than neglect or abuse. Some are simply unwanted, delinquent, with special needs or whose parents are temporarily disabled. When young children enter care, early planning is essential so that stable life plans can be ensured.

In contested cases, it is important to have good factual evidence. This means direct eyewitness evidence and not the opinion and hearsay evidence so often presented.

Parents have rights to due process. They have a right to clear statements about what evidence will be offered and a right to competent legal representation.

On the surface, the Child Family and Community Services Act seems to support these principles. Hearings must be within 45 days and temporary orders no more than one year. The child's best interests are paramount and include stability, continuity of care and kinship contact. Timeliness is essential. In practice, the principles are ignored and regularly derailed. The long, complicated act seems designed as a source of revenue for lawyers. When first enacted, it ground the family courts almost to a halt for over a year.

Children's best interests depend on opinion, and ministry bureaucrats think only their opinion counts. Family court becomes as adversarial as criminal court, while child welfare gets lost in legal bickering. Neither the courts, the Ministry of Children and Family Development directors nor defence counsels monitor timelines. Cases get bounced from judge to judge.

Any piece of social legislation can be used as a tool or a weapon. The choice lies with those in authority. Legislators little realized that they offered as many weapons as tools, but the resolutely adversarial Children's Ministry quickly found them.

A recent Times Colonist editorial showed how the ministry behaves as if a child's right to privacy is a paramount right, which can trump all the other rights in the act. They cloak everything in secrecy and withhold information that people have a right to know.

A typical case recently covered by the CBC illustrates these matters. A couple had three children, the younger

ones born 14 weeks and six weeks prematurely. Such children can be very fragile. When the parents took the six-week-old to hospital, a doctor reported that the child's condition was due to abuse. At first, the ministry's director acted reasonably and took charge of the child, who stayed in hospital.

With only inferred evidence on the older children, they took them into care, placing them with relatives.

Then the evidence wilted. Other doctors strongly disagreed with the first diagnosis. Courts had previously declared the type of evidence unreliable. A police investigation found no evidence.

After seven months the parents had spent \$60,000 on lawyers with no progress, and in despair they went to the media. Following Global TV coverage, the director promptly removed the children from relative care with armed police, apparently just to assert his authority.

They have since been moved three times. Last July, the director's lawyer told him the case was weak and he should return the children. In spite of this, the director is pursuing the case aggressively and seeks a continuing care order.

A hearing will not take place until March 2010, and the parents -- already heavily in legal debt -- cannot raise the \$100,000 needed for defence. Blameless or not, they stand no chance of getting back their children.

Obviously the need is for better staff, and not more staff.

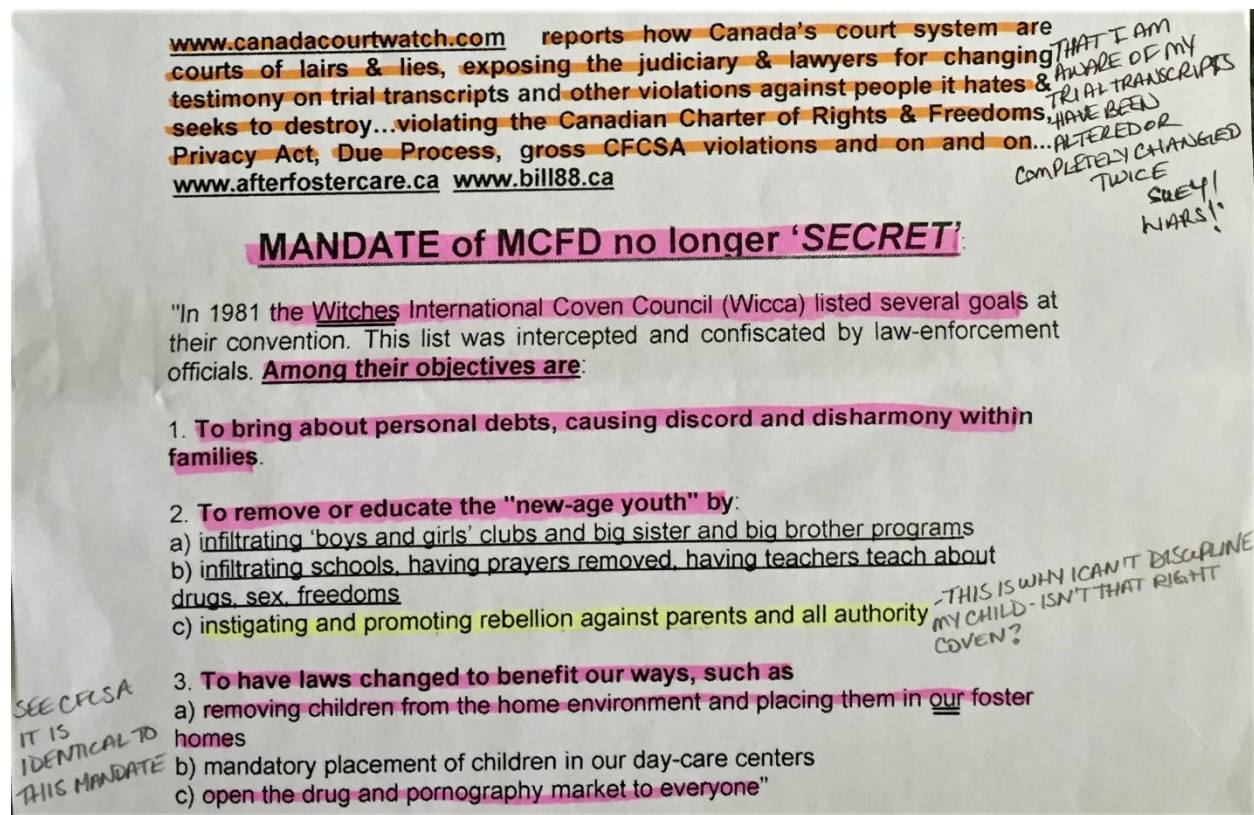
Some suggested remedies:

- **The act is too flawed to fix. Scrap it and bring back the old one.**
- **Save a lot of money by providing duty counsel to represent parents as well as the ministry.**
- **Give the child advocate some real power to monitor practice.**
- **Provide mandatory core training on matters like evidence and mediation.**

Ray Ferris was a social worker and supervisor in child protection for more than 30 years. He retired in 1988 but has kept busy with advocacy and writing, including a textbook on child protection.

Heather Carr died shortly after catching fire while in a rock art sculpture in Riverside Park last week.

Carr, a Thompson Rivers University graduate, was a social worker in Merritt. She had the file for Allan Schoenborn’s three children: Kaitlyne, Cordon and Max.

Schoenborn killed the three children in April 2008 inside the Merritt home they shared with their mother, Darcie Clark.

Carr went on stress leave after the murders and was later placed on long-term disability.

In 2010, Schoenborn was found not criminally responsible for the killings by way of a mental disorder. He remains in psychiatric custody in Port Coquitlam.

Carr was active among Wiccan groups on social media, operating a Facebook group called Being Pagan Out of the Broom Closet.

A post on that page said Carr died as a result of “severe burns suffered in a ritual gone horrifically wrong.”

The placement for A.J. has been updated in the system. He has been shown out of Pat's as of last Thursday and shown into Faith's. As neither you nor Pat are looking at a return to this restricted foster parent, I think we are safe to say that the 5 day move is not an issue at this time. Faith said that she is fine with the school and the transportation. I am worried about protecting my caregiver from more allegations though and would like to do an IDNSP as soon as we can so that Faith knows what will be expected and you have an idea of whether Faith's home will work for this boy. At this time, I see no reason why it can't -----other than the mom making allegations! - NO ACTUALLY PAT TAYLOR MADE ALLEGATION & WAS CUT FROM CHILD'S LIFE!
Due to the messages and letter, I would like to try and have Faith's location remain unknown to the mom as best as we can protect this. If there is a problem, and we have to move him again, there will be difficulty in getting him to the same school as we are running out of caregivers, especially on the Peninsula. Anyway, we'll cross that bridge later (or hopefully NOT). MAY THE FORCE BE WITH YOU!

Case notes for meeting with lawyer and MCF Thursday April 15th

Prepared by Ray Ferris April 14, 2010.

Points of focus.

1. Clear and compelling evidence is demanded in order to remove a child from its parent for any length of time. I hope all can agree on that point.
2. The MCF does not have clear and compelling evidence. Far from it. What is the substantive evidence? There is only one piece of significant evidence and this is the evidence, which caused them to remove AJ into care. The information received from medical staff gave them reason to believe that the child could be at risk. Quite appropriately, the child was removed until the matter could be further assessed.
3. The evidence was that the mother suffered an emotional breakdown as a result of a number of stress factors converging at once. For a short time, she was not able to provide good care for her son. The question arises as to whether this was a matter of short duration, or was there factual evidence, which would lead to the likelihood that the child would remain at risk.
4. It is my assessment that there is virtually no factual evidence to suggest a continuing risk. Most of the reasons given are matters of hearsay and opinion and there is ample evidence of bias and of an adversarial stance. The staff members have made a number of errors in their assessment and have shown lack of knowledge and skills. They failed to make an in-depth assessment of the lifeskills of the parent. They got trapped into the usual mistake of assuming that a risk assessment means digging up as much negative material as possible and failing in an equally zealous inventory of positives. There are numerous examples of this. They did not adequately explore the child care standards of the mother for the first five years of the child's life. There are numerous ways they could have got a more accurate picture, but they seem to have got to enmeshed in issues of parenting styles. In general they show a lack of knowledge of what is good evidence and what is not. In particular they do not understand opinion evidence. Opinion evidence can be expert opinion, but this is not without accountability. It can be tested by other experts. Expert opinion is also well known to favour the hand that pays. Opinion can be based on fact. When it is based on clear and demonstrable facts, those facts should render the opinion to be unnecessary. Opinion based on hearsay, rumour, allegation and assumptions are of no value.
5. One of the issues that preoccupied the social workers was that maybe every few months she paddled the boy with a wooden spoon. One of the measures one should use in alleged abuse cases is to ask whether the abuse bordered on criminal and would warrant a police investigation. This type of case does not come anywhere close to such a standard and is in a much more subjective realm. Indeed it is largely a matter of parenting style in disciplining a child. Viewpoints will vary. Social norms are changing in views of physical punishment of any sort. However there is no absolute consensus about whether or not reasonable hand spanking is allowed. It is certainly not illegal. I know that official ministry policy is to proscribe physical punishment in all foster homes, and this expresses the official value position. However, the ministry must differentiate between what is unwise and what is illegal. The behaviour acknowledged by [redacted] would at worst indicate a need for guidance.
6. Lacking substantive evidence that there would be a continuing risk to the boy, the ministry must consider that there is likely to be emotional damage to him if the state of limbo is allowed to linger. They simply do not have anywhere near enough evidence to justify an application for continuing care. So if the lad is to be in temporary care, they should heed the guidelines in the CF&CSA, particularly sections 4 (c) (d) (f) (g) and section 2 (c) (d) (g). Also pay attention to the potential under 47 (3) and be careful not to abuse timelines and keep the child in care longer than demanded by the Act. There is little point in extending existing orders unless you intend to apply for a continuing care order. It would not be rational under the present circumstances.
7. There are other legal process issues which concern me and I want to raise them. However, the may not all be due to ministry action. Problems lie in the Act itself, in poor legal representation and in the court logjam, which is also largely due to a flawed act.

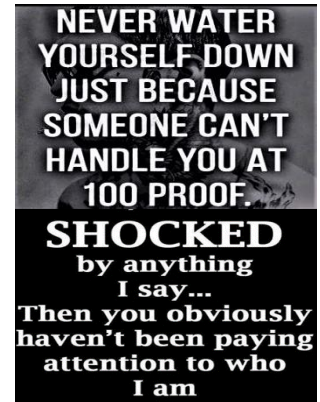

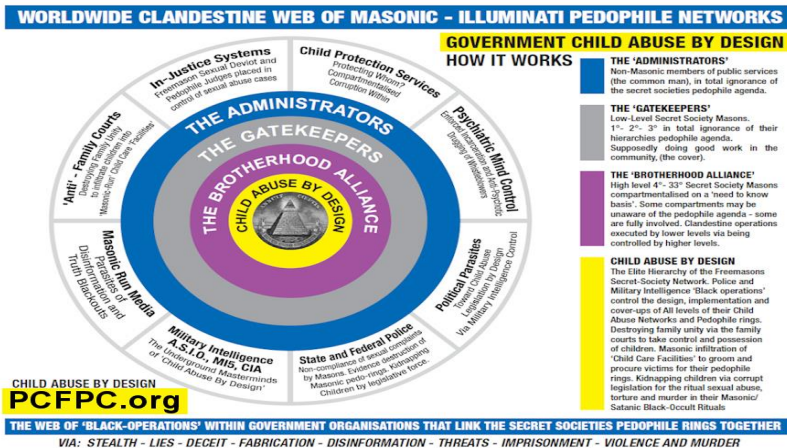

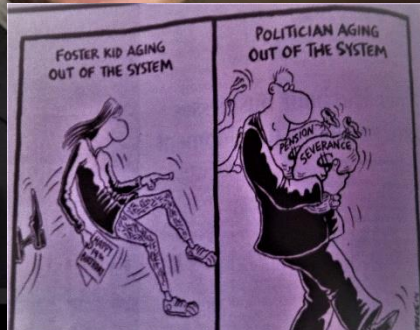

As Rob Hunter of Phoenix was not immediately available, Leah Stewart of Boys and Girls Club had the case from July 7 to September, 2009 before it was transferred to Rob on September 8, 2009. disillusioned that he did not just tell the social worker that she was fine and should return AJ home right away. Laurel Fossett was assigned for visit supervision only between March and June 2010.

When the file was officially transferred from social worker Lynda Garbutt to social worker Johanne Grenier [redacted] refused to attend the pre-scheduled transfer meeting stating to Lynda that: "you are emotionally abusive to me" and she could not attend without representation.

When contacted by Family Finders worker Sarah Hogarth, Lisa sent another email on March 13, 2010 stating she had decided to back away from the Family Finders study because she felt AJ belonged with his mother.

June 24, 2010 - Home study completed on [redacted] mother Yvonne [redacted] and her husband David [redacted] from Cranbrook. They had made an application for custody of AJ under FRA. Cranbrook resource worker Fiona Winton did a thorough assessment that did not support their application for custody. Serious concerns arose based on both of their past abusive relationships, abuse of their own children by previous partners, estrangement from their own adult children (both have 2 daughters from previous relationships), past and possible current mental health concerns for both, substance abuse concerns for David and an extreme and rigid belief system that alienated both of them from extended family, friends and their own children.

THEN WHY DID WISHART CONTINUE THE SYLTS APPLICATION?

WHICH IS WHY WISHART & GRENIER WERE IN FAVOUR OF THEM HAVING MY CHILD

[redacted] is estranged from her mother and blames her for much of her unhappiness. She has adamantly been opposed to her mother obtaining custody of AJ. The [redacted]'s FRA application was joined to the CFCSA matter before the July 2010 protection hearing. At that hearing their application was adjourned by Judge Wishart until the next hearing. They had 2 visits with AJ in July 2010 during the trial and began weekly phone calls with him thereafter. AT MY DISGUST & HORROR

In January 2011 I was told by the foster parent that grandma had not been home for phone calls since the beginning of December and phone calls with grandpa were awkward and appeared to be unexpected. AJ became reluctant to have the weekly phone calls and the last straw came when he called grandpa on his 7th birthday and grandpa didn't even know or seem to care. After that AJ told the foster parent he didn't want anymore phone calls with grandparents. Around the same time I received information from [redacted] lawyer that she had heard her parents were divorcing and her mother had been criminally charged. I sent a sec. 96 request to the [redacted] RCMP. In the meantime I received an email from Fiona Winton, the resource worker who had done the homestudy on the Sylte's, indicating that she had received information to suggest that there had been a domestic violence incident between the [redacted] in November and [redacted] had been taken to the local Transition House by a friend at that time.

In February 2011 I received verbal information from the [redacted] RCMP indicating that they had arrested and charged [redacted] with assault on David on December 12th and that [redacted] had subsequently countercharged him with assault arising from an incident in November. Both charges were dropped by Crown. According to the RCMP, [redacted] was residing at the Kootenay Women's Shelter on December 21st when they accompanied her to the home to collect some possessions. At that time women's shelter staff told police [redacted] had been a victim of violence from David for years. David told police that their relationship was over for good. [redacted] told police that David was severely depressed and hearing voices. When I called [redacted] in early February 2011 where she was housesitting at her brother's farm in [redacted] she adamantly denied everything I had been told by the police. She also stated that her brother and sister-in-law, [redacted], would be applying for custody of AJ. I had a subsequent telephone conversation with Harvey [redacted] in which he clarified he was not interested in permanent custody or adoption for himself but wanted to know if there were other options for AJ with family. During March 2011 [redacted] told director's counsel as well as the judge during the Trial Confirmation Hearing that she intended to pursue her FRA custody application of AJ. On March 19, 2011 she left a voicemail for director's counsel stating she had changed her mind and would no longer be pursuing custody. David [redacted] has not been in communication with the director since last year.

MY MOTHER IS A COMPULSIVE LIAR

██████ has told me that she has seven siblings and, according to ██████ much of her extended family lives in the ██████, ██████, ██████ area. There may be some appropriate family there that would be interested in adopting AJ. ██████ and ██████ have 3 adult children who might be appropriate.

Child's Circumstances, Placement and Visits

AJ was initially placed with family friend and long time daycare provider Patricia (Pat) Taylor as a restricted foster placement at the request of ██████ herself. Pat had been caring for AJ since he was 11 months old so she knew him well and he was comfortable in her care. Pat enrolled AJ in Karate beginning in June and he was thrilled. He had wanted to do Karate since he was three. He was very excited by his progress and kept inviting his mother to come and watch him but she refused on the grounds that Karate was based on a cult (she did not tell AJ this).

NOT A CULT BITCH, THE OCCULT/BABYLON

Visits were initially unsupervised and several times a week while AJ remained with Pat but by April Pat reported that ██████ was skipping her Wednesday visits and also Saturday visits unless Pat initiated them. ██████'s phone calls to AJ had also dropped off and AJ was becoming increasingly confused and angry to the point where he was agitating the other children. In June 2009 Lynda Garbutt made a referral to the High Risk Mental Health Team for AJ and Kaleen from Phoenix was assigned as AJ's worker. Also in June Lynda told Pat that Saturday visits would now be supervised by Pat in her own home. Sunday visits were apparently supervised by ██████. However, it became evident that ██████ had been allowing ██████ and AJ to visit downstairs (████████████████████) without supervision. In August 2009 social worker Johanne Grenier met with Jack to clarify visit supervisor guidelines: visual and auditory supervision at all times.

At the same time she made a police report alleging Pat had sexually molested AJ. AJ was tearfully removed from Pat's home and placed with foster parent Faith Manley on November 19, 2009 where he remains to date. The allegations against Pat were investigated by police and MCFD and were never substantiated. All visits with ██████ were suspended until further notice unless they were supervised by Rob Hunter in the community. Between November 5, 2009 when ██████ refused to cooperate further with Rob Hunter and March 9, 2010 when she had her first supervised visit with Laurel Fossett, ██████ had no visits. This was a period of 4 months. A Christmas 2009 phone call had been arranged for ██████ and AJ by Johanne Grenier and ██████ then lawyer Christine Churcher but ██████ refused to do it because she believed it would be mentally and emotionally abusive. From AJ's perspective he had been moved from a home he loved to a stranger's home against his will and all contact had been cut off with the people he loved (mum, Jack, Pat and even Rob) over Christmas 2009 and for his 6th birthday on January 10, 2010. He responded by trying to cut himself.

After ██████ sent an email to the social worker on June 3, 2010 stating she would no longer accept visits supervised by MCFD, she attended a last visit supervised by Laurel Fossett on June 10, 2010. Laurel reported that, much like the previous workers had observed, visits ranged from very child focussed to very strained. ██████ demonstrated a range of behaviours but spent some time during most visits withdrawn from AJ, as well as some time during

During these phone calls I will inform you of any issues that may have arisen during your supervised visits. I will be speaking with Rob Hunter prior to my phone calls so that I may be able to be more specific for you. *I only heard from J Grenier once on OCT. 30/09. TYPICAL!*

I will be looking into the concern you brought to my attention regarding AJ telling you that his foster parent, Pat Taylor, has told him "he's stupid".

THIS WAS NOT SAID DURING THIS MEETING - PROVES GRENIER KNEW OF ABUSE. DID NOTHING ABOUT IT.
We also spoke that as Pat is currently in the process of some major home renovations it is difficult for her to supervise visits in her home. She has offered to supervise visits on Tuesday evenings and on Saturdays, after AJ's karate lessons. AJ attends karate on Tuesdays between 5:30 and 6:30pm and Pat then usually takes him to dinner somewhere. On Saturdays he has karate from 12:00 noon to 1:00pm and then they usually go for lunch. Please contact Pat and let her know when you will be attending. AJ attends Canada's Best Karate and Pat would be able to give you directions.

If you could let me know what your understanding is of why your visits were changed from unsupervised to supervised that would be helpful. If you are really unclear then please do not hesitate to set up a meeting with myself and I will go over it with you.

A referral has been made to Cascadia Counselling Services for you. I sent the referral today and have yet to hear which counselor has been assigned to you. Once I know who will be assigned I will let you know and that counsellor would then be in touch with you. I do not know how long it will be before you hear from them however if you have not heard from them by November 13, 2009 please contact me and I will follow up.

I am writing to acknowledge and address the concerns you have raised with Doug Colwell, Vancouver Island Complaint Resolution Consultant. As per the letter of December 10th, 2009, to you from Doug Colwell, you spoke of four concerns and proposed remedies. As Doug Colwell advised you, your complaint with regard to your belief that you do not represent a risk to your son, is not eligible for review, so therefore I will not be speaking to it. 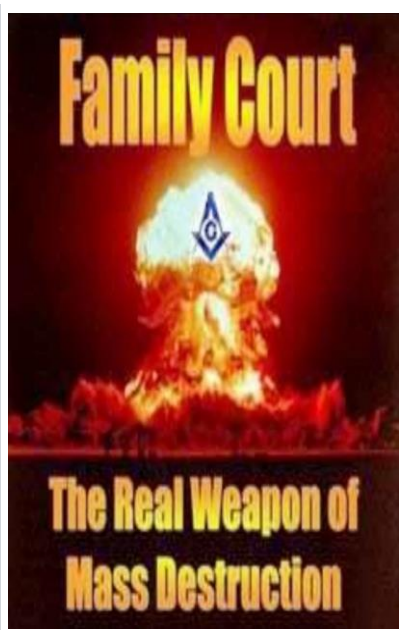

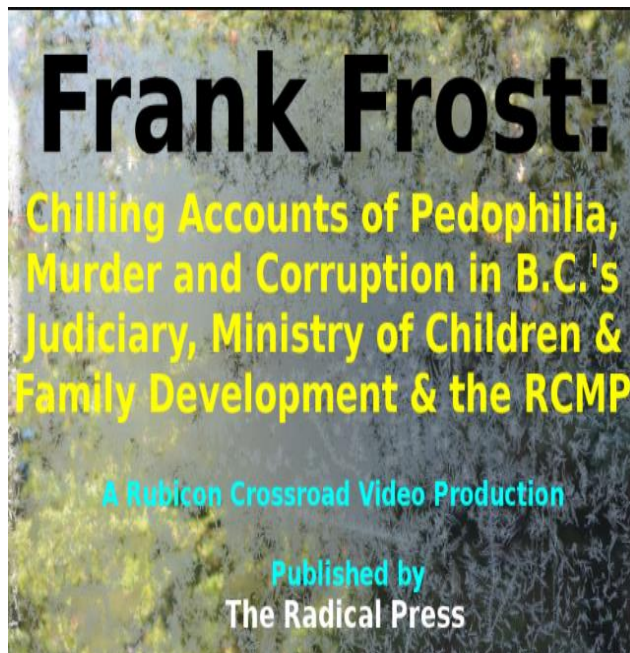

Attorney general's department could not explore the possibility of contracting defence counsels to represent all parents in protection cases. They too would become skilled and they would be in a strong position to negotiate with the ministry counsel outside of the court. Such a scheme might well be more cost effective than at present.

We immediately contacted the Ministry of Children and Family Development, Child Protection Services and were told by the case worker Linda Garbutt, that A.J. had been removed from his home because of safety issues. No specifics were given us.

My wife and I then told the ministry that we would take A.J. into our home and assume immediate responsibility for his care , support and well-being.

We were told by the case worker that Grandparents would be considered as custodial alternatives over strangers or foster care homes.

She extracted a lot of information from us, and then became belligerent, hostile, and ended her conversation with the comment " I'll see you in court." - TYPICAL OF MCFD WITCHES PERSONALITY DISORDERS

After waiting for more communication for several months , we again contacted the ministry and were given a new case worker; Johanne Grenier, who was very condescending, and when we said we wanted to talk to A.J. by phone, she absolutely refused. ALL CONTROL OF ANOTHER IS ABUSE - PERIOD!

She said we could write a letter to A.J., sending it through her, but it would be heavily censored. - ILLEGAL!

When we again said to her that we wanted to assume care for our Grandson, she said " You need to get counselling" - NO ACTUALLY JO JO DOG FACE YOU NEED COUNSELLING, AS YOU ARE MENTALLY VILE!

Never at any time were we advised that we had any rights before the law as blood relatives to assume our proper role as caregivers and custodial parents.

By contacting a multitude of other agencies , we discovered that we do have many rights and remedies under the law.

We were informed we had the right to apply for and register an application to obtain a court order which was duly filed in The [redacted] Court Registry with appropriate documents.

We were advised we could attend Court in [redacted] B.C. on April 1 ,2010.

We appeared before the Judge and were told that we "appeared confused."

We reiterated our position as willing caregivers and legitimate custodial applicants.

Standing by was a lawyer , one Michelle Fuchs , who said she was there to represent the Ministry. The Judge then said that he would adjourn our case until we were "helped" by Michelle.

We left the courtroom and went into an adjoining room, whereupon Michelle said to us "Oh, You need a lawyer." She appeared sympathetic and said there was an upcoming court case in Victoria regarding A.J. in June, and we would need legal representation. - OF COURSE THATS THE MANDATE OF THE NWD - EVERYONE NEEDS A LAWYER AKA LIAR!

We asked her if she would represent us in Victoria court in June. She agreed.

She advised she would require a retainer of \$ 10,000. up front. LICENSED +

We would be responsible for all travel expenses for her to attend. PROFESSIONAL EXTORTION - TYPICAL

She did say that she had her own lodging in Victoria, so that was covered.

She gave us her business card and we said we would be in touch .

Michelle Fuchs was the only resource given to us for direction.

Only after we contacted the Ombudsperson were we finally allowed to speak to our Grandson by phone, and a local caseworker begin a home study for custody.

We have been treated as if we are "on trial" and must prove our innocence.




Thank you for your letter of October 4, 2010. I understand from your letter that you have the following concerns:

1. You had hoped to see your grandson when you were last in Victoria and you believe that this access was declined.
2. As a result you are requesting that a new caseworker be assigned.

In response to your concerns I have spoken at length with Ms. Tonn. It is my understanding that Ms. Tonn declined your recent request for access to AJ due to the fact that AJ, and a number of members of the foster family, had a bad case of the flu. I am certain that you would agree that any child who is ill should be resting at home to ensure a quick recovery. Alana stated that AJ had not broken skin and when she asked AJ why he had been trying cut himself he told her, "I do it sometimes because it feels good". This counsellor immediately placed a call to Johanne Grenier to inform her of the incident and left a message on Johanne's voicemail. In addition, this counsellor phoned Faith, although Alana stated that she had spoken to Matt about the incident on the day it occurred. This counsellor expressed concern to Faith about the incident and Faith stated she had also increased her supervision of AJ in the home and had restricted him from using scissors without supervision. On Monday, January 11th, this counsellor spoke to Johanne on the telephone. Johanne stated that she is also very concerned about AJ but was relieved to hear that he had not succeeded in his attempt to self harm. This counsellor expressed to Johanne a deep concern about AJ's emotional health and the fact that he is experiencing a deep level of pain and hurt that he cannot process. This counsellor informed Johanne that she will begin with some directive counselling with AJ to develop healthier coping mechanisms to address his feelings and also to provide more direct processing of his feelings regarding his Mother. Johanne stated that she will inform her supervisor of the situation as well. At this point, this counsellor will begin more directive counselling with AJ and will connect with Project Alive for consultation.

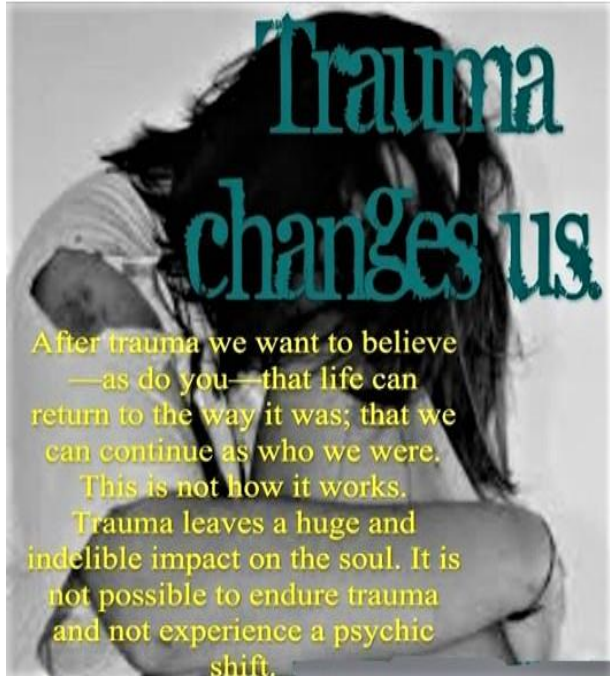
This counsellor also met with AJ on January 11th, 2010 to perform a thorough risk assessment. This counsellor asked AJ about the incident and AJ stated that he had not been trying to cut his fingers, but had been trying to cut the skin around his eye. AJ could not identify why he wanted to cut himself, although he stated that Faith told him sometimes kids hurt themselves because they are missing someone and AJ stated that he is missing his Mother. This counsellor asked AJ if he had ever tried to hurt himself before and he stated that he could not remember but he did not think so. This counsellor also asked AJ if he had ever thought about dying or wanting to die and he stated he never had. This counsellor asked AJ to point out if he felt talking about the incident using feeling faces and he identified a face with a straight line mouth, no expression. This counsellor asked AJ if he was not feeling anything or if he was trying to ignore the feelings he was having and he stated he was trying to ignore his feelings. Although this counsellor assessed AJ at a relatively low risk level, it is clear that AJ is experiencing a level of pain that he is not capable of processing. It is the opinion of this counsellor that the last two months have been very difficult for AJ as he has not had any contact with his mother since mid-November. This stress has likely been compounded by being placed in a new home over the holidays and his recent birthday, which are typically times spent with family.

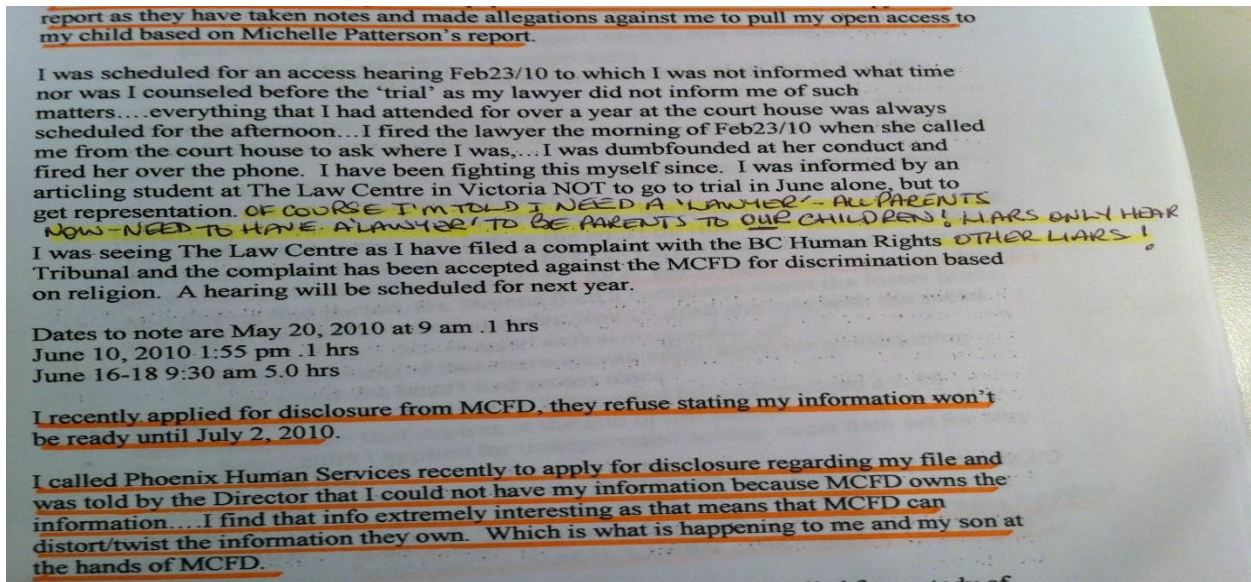
low self esteem and self-hatred, lack of trust, depression, and substance abuse and other forms of addiction are widespread, as children lose the capacity to give and accept love from a parent.

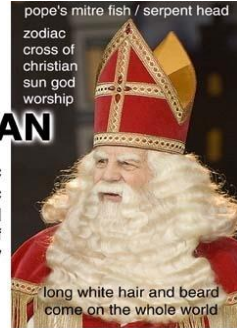

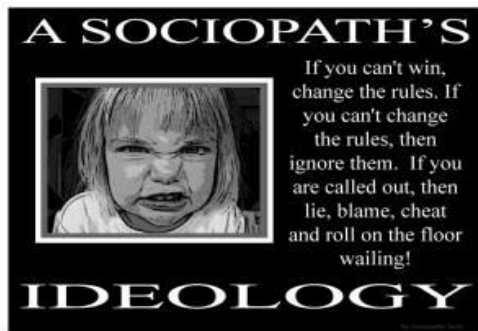



Ex-B.C. staffer charged in 'triple delete'

Accused of making false statements to mislead privacy commissioner

A former B.C. government employee has been charged with making false statements in an attempt to mislead privacy commissioner Elizabeth Denham in connection with the alleged "triple-delete" case.

George Steven Gretes, a former ministerial assistant in the Ministry of Transportation and Infrastructure, faces two counts under B.C.'s Freedom of Information and Protection of Privacy Act.

The charge of wilfully making a false statement to mislead, or attempt to mislead, the commissioner carries a maximum fine of \$5,000.

The RCMP launched an investigation following the release of Denham's Access Denied report, which probed the disposal of government documents. The report alleged that the government triple-deleted emails about the Highway of Tears case rather than release them in response to a Freedom of Information request.

"Triple delete" refers to a procedure that permanently removes email from the B.C. government computer system.

The Criminal Justice Branch said in a statement Friday that the RCMP investigation focused on the conduct of Gretes, who was interviewed under oath by Denham's investigators.

Gretes resigned from his government job after the release of Denham's report in October.

Special prosecutor Mark Jette approved the charges. Gretes is slated to make a first court appearance April 20 in Victoria.

The RCMP asked the province in November to consider appointing a special prosecutor, which is usually done if there is significant potential for real or perceived improper influence on decision-making. Special prosecutors are generally appointed for files involving cabinet ministers, MLAs, judges or senior police and public officials.

Jette will handle the prosecution and any subsequent appeals.

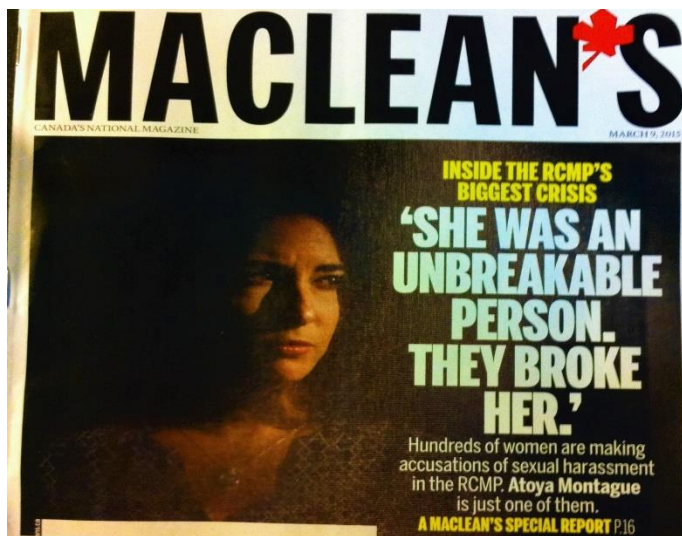

Child advocate claims B.C. government more interested in damage control than safety

The B.C. government is dodging mandated oversight on "critical injury" child-in-care cases and seems more interested in managing negative publicity from tragic cases than improving system safety, B.C.'s representative for children and youth charges.

Representative Mary Ellen Turpel-Lafond said "there is a deep concern that entire categories of critical injuries that ministry staff know about," are not being turned over to her office, as required in the Representative for Children and Youth Act.

Turpel-Lafond raised the issue after reading The Province's report on documents obtained in the case of Kevin Fanning, who pleaded guilty to sex crimes against a mentally challenged boy in a Richmond foster home in 2009. In court it was revealed the boy suffered depression and suicidal thoughts from ongoing abuse.

Background checks were not completed on Fanning, and documents show government workers "signing off" on questionable safety arrangements.

"The ministry have not done an internal investigation," on the Fanning case despite "significant failings in oversight of the system," Turpel-Lafond said. "The ministry suggests 'Oh, every thing has been dealt with,' but ... I'm finding very little action was taken."

Turpel-Lafond demanded in December that The Ministry of Children and Family Development report for review incidents such as the Fanning case, or the case last fall of Amy Prentice, a 14-year-old with Down syndrome who was found dirty and emaciated next to the decomposing body of her mother in a Chilliwack trailer park.

The ministry has not complied, Turpel-Lafond said.

"I asked for a simple change, and why the ministry cannot do that quickly is a concern," Turpel-Lafond said. "It should raise some very big flags to all people."

There is also a provincewide concern that foster care parents can live in separate homes from their children and outsource too much work to relief staff, as was done in a government-approved arrangement in the Fanning case, Turpel-Lafond said.

Responding to The Province's story and Turpel-Lafond's charges for the first time, Minister Mary Polak said the ministry cannot ensure foster parents actually live in foster homes.

"We try to achieve [foster parents living in foster homes]," Polak said. "But each individual foster placement is determined on its merits."

Asked whether she was disappointed with government failings in the Fanning case, Polak said "it's distasteful and absolutely inappropriate ... nevertheless this is a case where an individual engaged in criminal behaviour ... it is impossible to predict what a person will do."

Polak said the ministry's criminal record check system has been improved after the Fanning case, which she suggested is likely isolated.

"I don't think this [Fanning case] is anything that gives us a system challenge," Polak said.

On sharing all critical injury cases with Turpel-Lafond, Polak said "my understanding is we are very close to finalizing [an agreement] on this."

In an interview NDP ministry critic Maurine Karagianis said the ministry didn't react to the Fanning case until a police investigation was launched, and the "first and foremost concern is that this stays out of the media."

The Province's information request turned up several emails between workers in which they assure managers that police investigators have not yet reported the Fanning case allegations to the media.

"[An RCMP investigator] again assured me that I would be updated if a statement was being made to the media," a Dec. 21 2009 email from employee George Sartori to a series of managers says.

And one series of emails suggests an agreement that one person "liaise" with information to outside agencies on the case because "one person managing info is always better."

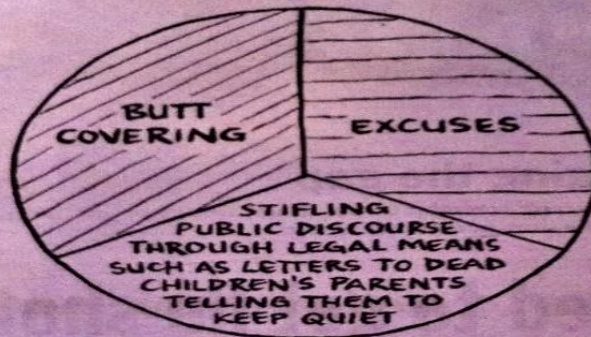

“[27] The Ministry of Children and Family is in breach of an order of the British Columbia Supreme Court. They are arguably in direct contempt of that order.

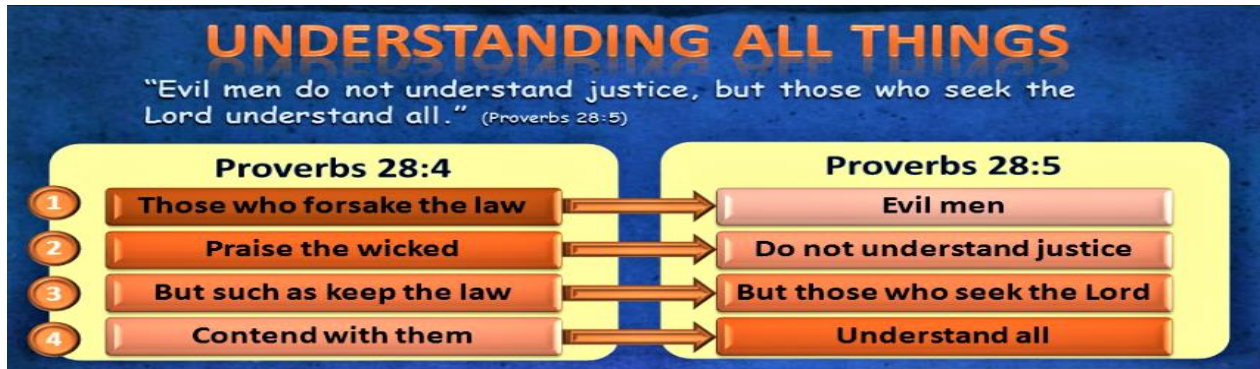
[28] I would like to comment again on something alluded to by former counsel for the Ministry; his suggestion that the Ministry is only bound to abide, to follow, Provincial Court orders. This, frankly, is disrespectful and it is wrong. It suggests that a certain branch of government has no obligation to follow the orders of the court of superior jurisdiction of that province. It ignores the *parens patriae* jurisdiction of the Supreme Court. It ignores principles of the courts, including the relationship between superior and inferior court. It ignores, frankly, the obligation of any person or board or Ministry or government to abide by court orders and to obey court orders; court orders for which they were present, for which they were able to have influence on, orders in regards to which they called evidence and made argument, orders which they have not appealed.

[29] There is something called the rule of law. The rule of law requires, in a free and democratic society, that all persons abide by the law, whether they like it or not. The rule of law gives persons options if they feel aggrieved by the decision of the court, options to appeal, options to reapply. No branch of government with the resources it has, with the number of employees it has, should be ignoring court orders. No citizen should disobey court orders. Society breaks down when anyone, be it a branch of government or an individual, has the arrogance to believe that they are above the law or above the order of the court.

RESULTS: The odds of a reported suicide attempt were ~4 times greater in adoptees compared with nonadoptees (odds ratio: 4.23). After adjustment for factors associated with suicidal behavior, the odds of reporting a suicide attempt were reduced but remained significantly elevated (odds ratio: 3.70).

CONCLUSIONS: The odds for reported suicide attempt are elevated in individuals who are adopted relative to those who are not adopted. The relationship between adoption status and suicide attempt is partially mediated by factors known to be associated with suicidal behavior.

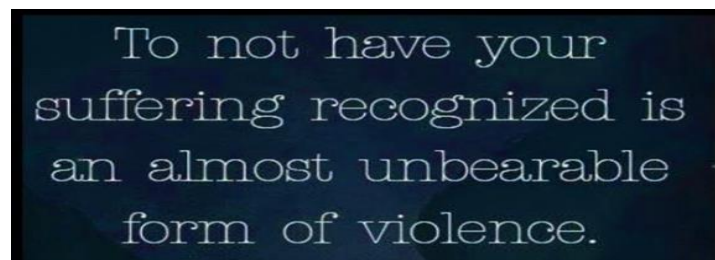

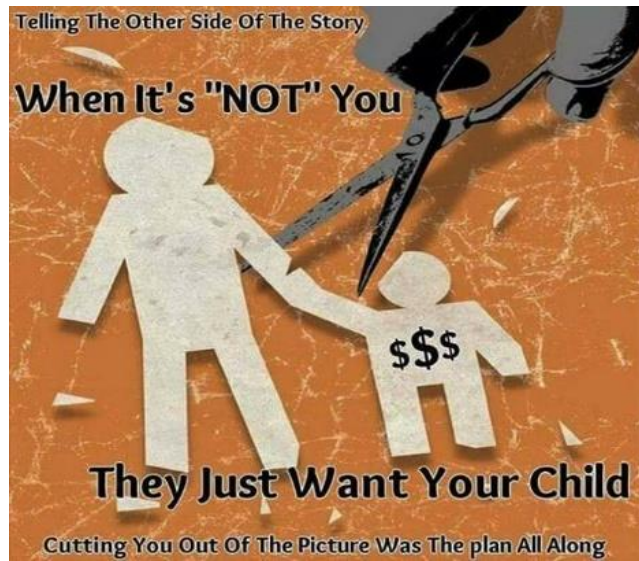

Orphans of our urban drug culture neglected again

The closure of a third group home for teenage wards of the province is likely the last assignment for Bernard Richard, B.C.’s second Representative for Children and Youth.

Two years into the job first held by former judge Mary Ellen Turpel-Lafond, Richard is retiring to his native New Brunswick this summer at age 67. He is not encouraged by what he has seen in B.C.

Richard released details last week of the closure of a group home somewhere in the Lower Mainland, after a staff member shared drugs with troubled teens and even took some on drug delivery runs.

An investigation by the provincial director of Child Welfare in February revealed why 18 teens with no family or foster care had to be relocated once again.

“The investigation was initiated as a result of a disclosure by a youth that a staff person was gang affiliated, took youth on drug drops, had smoked marijuana with the youth, offered the youth cocaine, and took the youth out for drinks in the community,” Richard wrote in a letter to Children and Family Development Minister Katrine Conroy.

“The investigation found only 10 of 33 staff and caregivers were cleared as

risk-free by criminal record and other security-screening criteria. Nine, who had all been caring for children until the investigation, were barred permanently from further caring.”

Richard, a lawyer and former New Brunswick cabinet minister who served as that province’s first child advocate, told me he has little faith in Conroy’s assurances that auditors and inspectors are being brought in to examine the rest of B.C.’s contracted agencies.

Conroy says more staff have been brought in to do criminal record checks that were supposed to have been done, and ministry social workers are instructed to “regularly visit” teen clients to make sure they’re fed, cared for and supervised.

It reminds Richard of an earlier case he reported on, where teen Alex Gervais jumped to his death after being left on his own in a hotel room by a contract agency in Abbotsford. Gervais reported that supposed caregivers were trying to take advantage of him rather than help him.

“These are the youth, remember, who will soon age out of care,” Richard said in an interview. “They’ll end up on the street, homeless, addicted or dead.”

In many cases it was the drug culture that put these kids where they are, as

their parents abused or abandoned them while wasting their own lives away. There are more than 800 B.C. children and youth in contracted residential agency homes, which means the ministry hasn’t been able to find suitable foster homes for them.

Richard said teens with behavioural and mental health issues are the ones who don’t have a home-like setting, and are the most vulnerable to drugs and street life.

They could be helped by the government’s offer of free post-secondary tuition for former youth in care, if they could get that far. And it’s important to note that Richard acknowledges some of the contracted agencies are doing their best.

“They operate as charitable organizations, and most do pretty good work,” Richard said. “But there are some for-profits, and the three that have closed in the last three years are for-profit organizations. So they cut corners. They want to maximize their profits and so they pay low wages.”

There’s little point in blaming Conroy, or her B.C. Liberal predecessor Stephanie Cadieux for this situation. At least Richard leaves B.C. with a specific direction they can take to make things better, not worse.

Adoption: Rights of birth parents

You contacted us for a briefing on the rights of birth parents relating to adoption, and how these might be affected by the *Children and Families Bill* currently before Parliament.

This information is provided to Members of Parliament in support of their parliamentary duties and is not intended to address the specific circumstances of any particular individual. It should not be relied upon as legal or professional advice, or as a substitute for it. A suitably qualified professional should be consulted if specific advice or information is required.

Birth parents: Consent to adoption

The *Adoption and Children Act 2002*,¹ (ACA 2002) established a statutory code and a legal structure regulating the circumstances in which a child can be placed for adoption and the consequences once such a placement is made. Before a placement for adoption is made a parent must be fully engaged in the decision making process, either by giving consent, or by having the opportunity to contest the issue in court proceedings.

When considering an application for a placement or an adoption order the court has the power to dispense with a parent's or guardians' consent on two grounds,² namely that:

- the parent or guardian cannot be found or lacks capacity (within the meaning of the *Mental Capacity Act 2005*) to give consent;
- the welfare of the child requires consent to be dispensed with.

In determining whether consent should be dispensed with on welfare grounds, ACA 2002 makes it plain that the child's welfare will be the paramount consideration in determining the issue of dispensing with parental consent. The welfare checklist set out in section 1(4) of ACA 2002 must be applied in determining the issue. It sets out the factors the court must have regard to:

- (a) the child's ascertainable wishes and feelings regarding the decision (considered in the light of the child's age and understanding);*
- (b) the child's particular needs;*
- (c) the likely effect on the child (throughout his life) of having ceased to be a member of the original family and become an adopted person;*

¹ The provisions of the Act came into effect at different times but it was fully implemented by December 2005

However, many adopted people believe that being separated from their mothers at birth caused a 'primal wound' or trauma from which many of their current day psychological difficulties have stemmed.

The only large-scale national research study on the experiences, impacts and service needs of people affected by past forced adoption policies and practices was undertaken by the Australian Institute of Family Studies (AIFS) and published in 2012 (Kenny et al., 2012). The study highlighted a number of universally reported mental health impacts to all groups affected, including:

- Trauma-related symptoms
- Depression
- Suicidal ideation and behaviour
- Anxiety
- Grief and loss
- Disenfranchised grief
- Identity issues and impacts on self-worth
- Relationship and parenting issues
- Substance use
- Physical or medical illnesses
